

**AMENDED CERTIFICATE OF JUDGMENT**

I, **Sharon Harris**, Clerk of the United States District Court for the Northern District of Alabama, do hereby certify that an Order and Judgment was rendered by the United States District Court for the Northern District of Illinois, Eastern Division, and registered in the United States District Court for the Northern District of Alabama on the 23rd day of September, 2013, in the above-styled cause wherein: Petitioner American Zurich Insurance Company obtained a Judgment against Respondent Fleet Force, Inc. ("Fleet Force") whose address is c/o Greg Trapp and Robert Wood, Registered Agents, 501 North Jackson, Russellville, AL 35653; c/o Greg Trapp, Registered Agent, P.O. Box 210, Russellville, AL 35653-210 and c/o Greg Trapp 705 Cross Ave, SE, Russellville, AL 35653, in the amount of \$1,920,103.24 Dollars, calculated as follows: (a) Zurich is entitled to an award of compensatory damages from Fleet Force, Inc. in the amount of \$1,756,396; (b) Zurich is entitled to an award of pre-judgment interest from Fleet Force in the amount of \$155,187.84, with such interest having accrued at the rate of 9% per annum through August 20, 2013; and (c) Zurich is entitled to an award of \$8,519.40 in arbitrator fees and expenses incurred by Zurich. (d) In addition, Zurich is entitled to an award of post-judgment interest from Fleet Force, with such interest to accrue at the rate of 9% per annum from August 20, 2013 until such time as Fleet Force pays Zurich all amounts due under this Judgment; and that Steven Whitmer and Ashlee Knuckey, Locke Lord, LLP, 111 South Wacker Drive, Chicago, IL 60606 and Richard Greer, The Greer Law Firm, P.C., 2101 4th Avenue, Suite 200, Birmingham, AL 35233 are Counsel of Record for Petitioner in said cause.
