**MODIFICATION OF MORTGAGE**

**THIS MODIFICATION OF MORTGAGE** dated September 30, 2013, is made and executed between Brian Jay Tucker and Jessica Erin Tucker, Husband and Wife (referred to below as "Grantor") and Central State Bank, whose address is P O Box 180, Calera, AL 35040 (referred to below as "Lender").

**MORTGAGE.** Lender and Grantor have entered into a Mortgage dated July 22, 2013 (the "Mortgage") which has been recorded in Shelby County, State of Alabama, as follows:

Recorded on 8/7/2013 under Instrument # 20130807000321000 in the Office of the Judge of Probate of Shelby County, AL.

**REAL PROPERTY DESCRIPTION.** The Mortgage covers the following described real property located in Shelby County, State of Alabama:

1st Mortgage Dated 7/22/2013 and Modification of Mortgage Dated 9/30/2013, Residential Real Estate, Shelby County, Alabama

The Real Property or its address is commonly known as 174 Mountain Forest Trail, Calera, AL 35040.

**MODIFICATION.** Lender and Grantor hereby modify the Mortgage as follows:

Mortgagee allows mortgagor to increase the original Mortgage Agreement, as modified and amended, from Two Hundred Fifty Two Thousand Eight Hundred Fifty Eight and 00/100 Dollars (\$252,858.00) to Three Hundred Two Thousand Eight Hundred Fifty Eight and 00/100 Dollars (\$302,858.00).

**CONTINUING VALIDITY.** Except as expressly modified above, the terms of the original Mortgage shall remain unchanged and in full force and effect and are legally valid, binding, and enforceable in accordance with their respective terms. Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Mortgage as changed above nor obligate Lender to make any future modifications. Nothing in this Modification shall constitute a satisfaction of the promissory note or other credit agreement secured by the Mortgage (the "Note"). It is the intention of Lender to retain as liable all parties to the Mortgage and all parties, makers and endorers to the Note, including accommodation parties, unless a party is expressly released by Lender in writing. Any maker or endorser, including accommodation makers, shall not be released by virtue of this Modification. If any person who signed the original Mortgage does not sign this Modification, then all persons signing below acknowledge that this Modification is given conditionally, based on the representation to Lender that the non-signing person consents to the changes and provisions of this Modification or otherwise will not be released by it. This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.

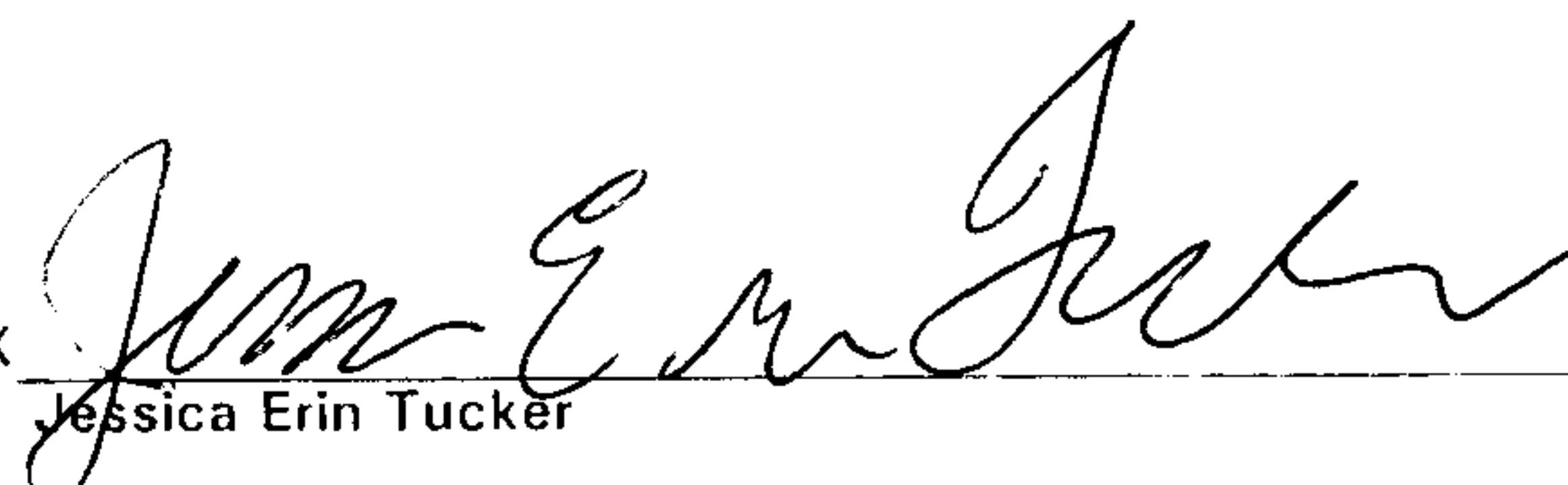

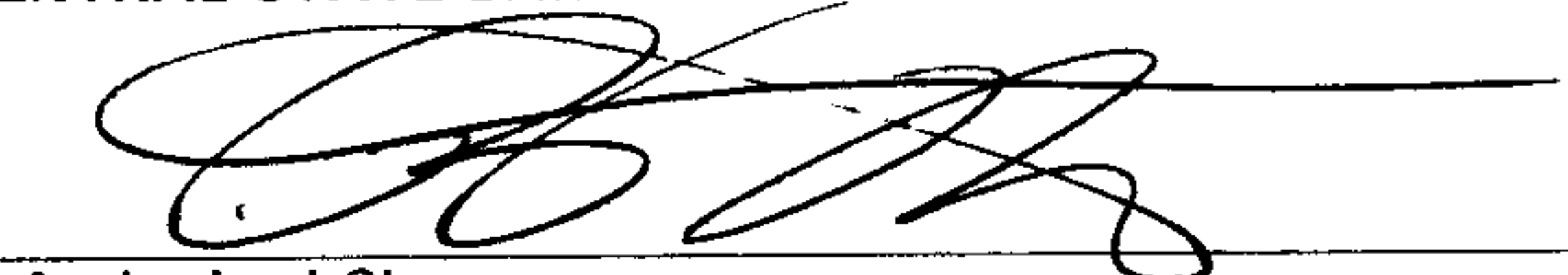
