ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of a corporation under the Code of Alabama adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is: Cahaba Management Group, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: to provide Management, Auditing, Consulting, Tax Preparation, Marketing, and Advertising. The corporation shall be empowered to engage in any other type of business or do any act not prohibited by law which a majority of its Board of Directors may deem appropriate or desirable. The corporation shall further have the power to do all things necessary, proper or incidental to the attainment of the foregoing purposes.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 1,000 shares of common stock of the par value of \$1.00 per share. The amount of capital with which the corporation will begin business will be \$1,000 consisting of 1,000 shares of common stock of the par value of \$1.00 per share, all of which shall be paid in.

SIXTH: The number of directors constituting the initial Board of Directors is four (4) and the name and addresses of the persons who are to serve as Director until the first meeting of shareholders, or until their successors is elected and shall qualify.

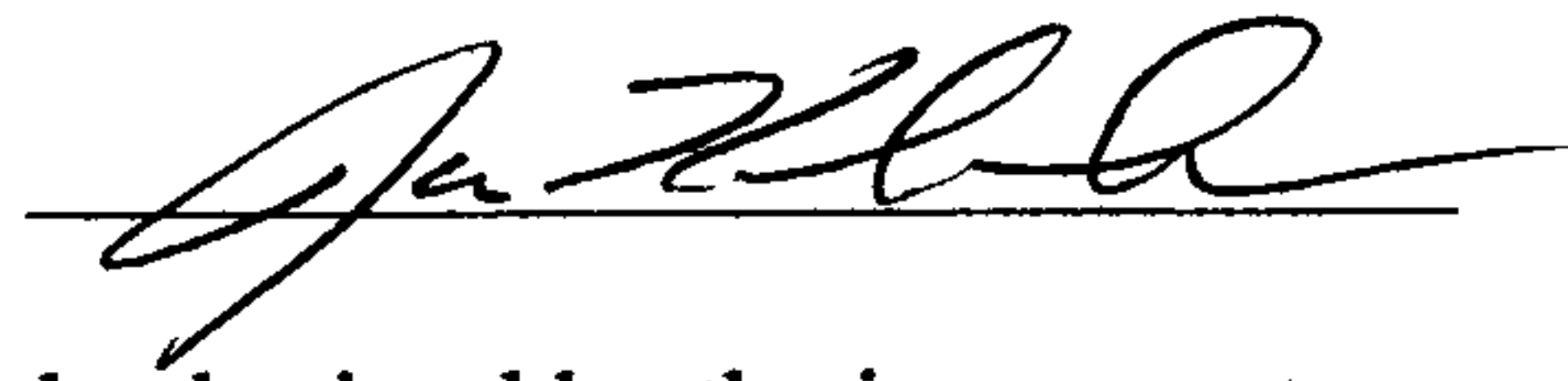

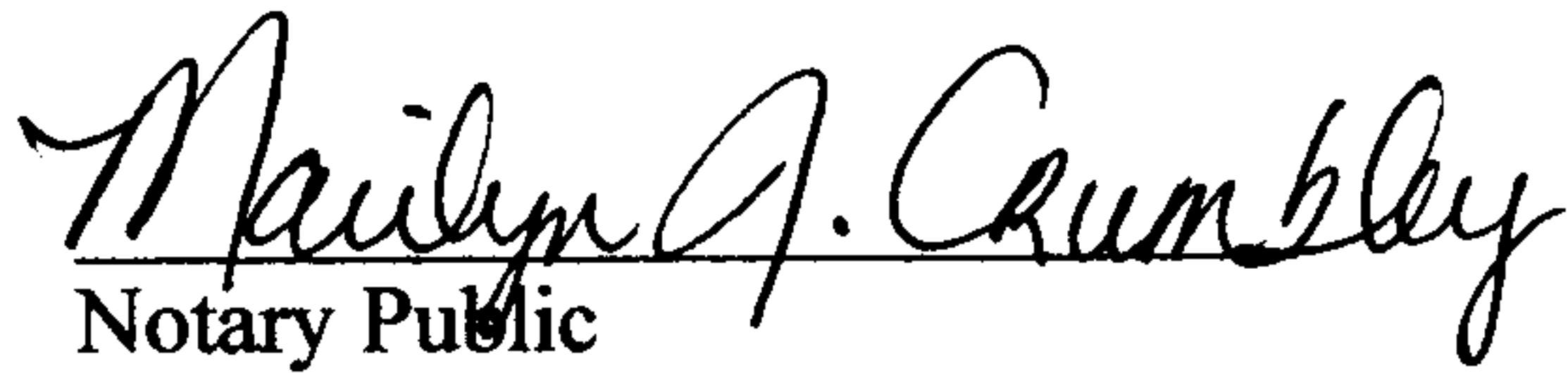

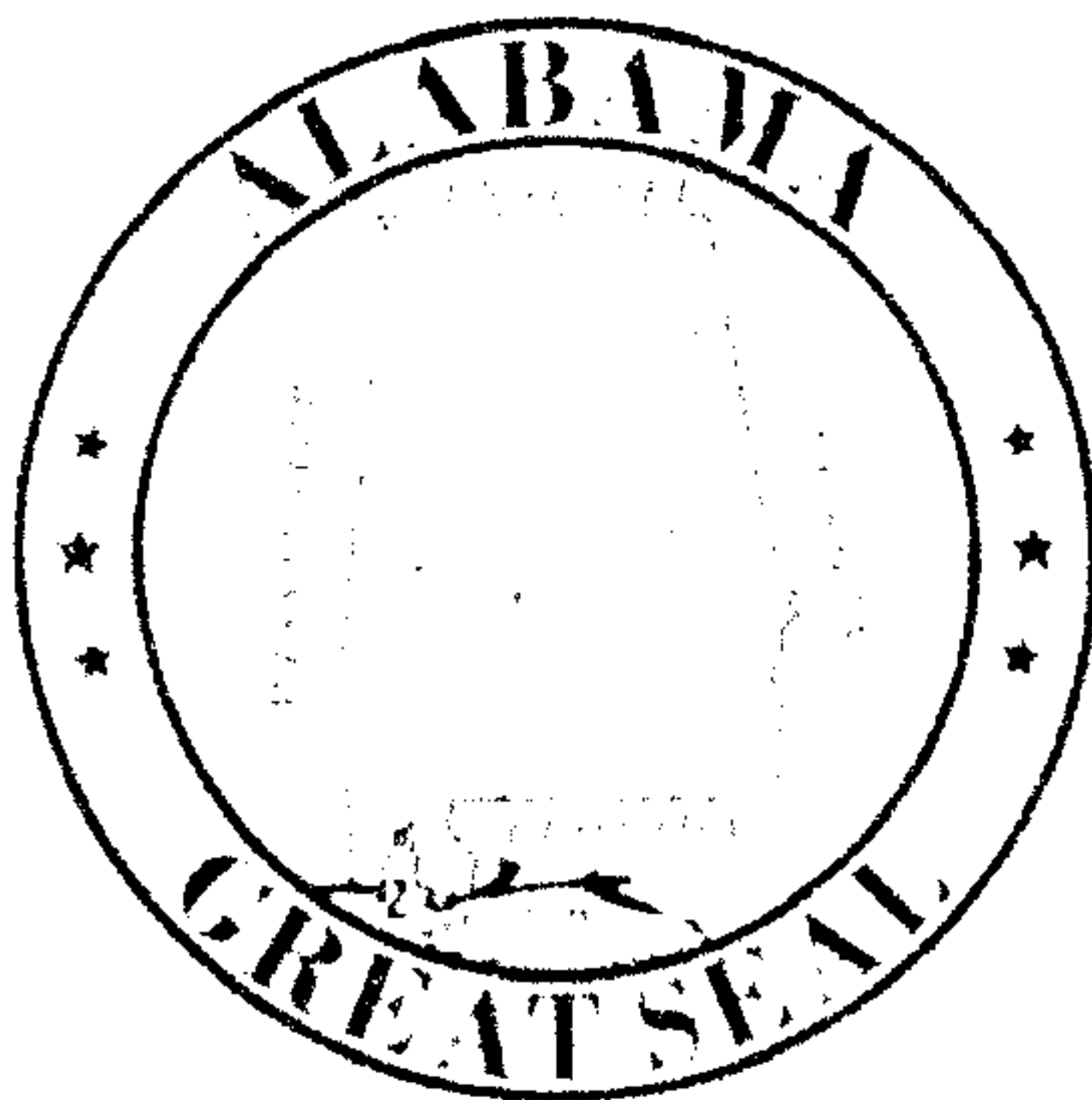
