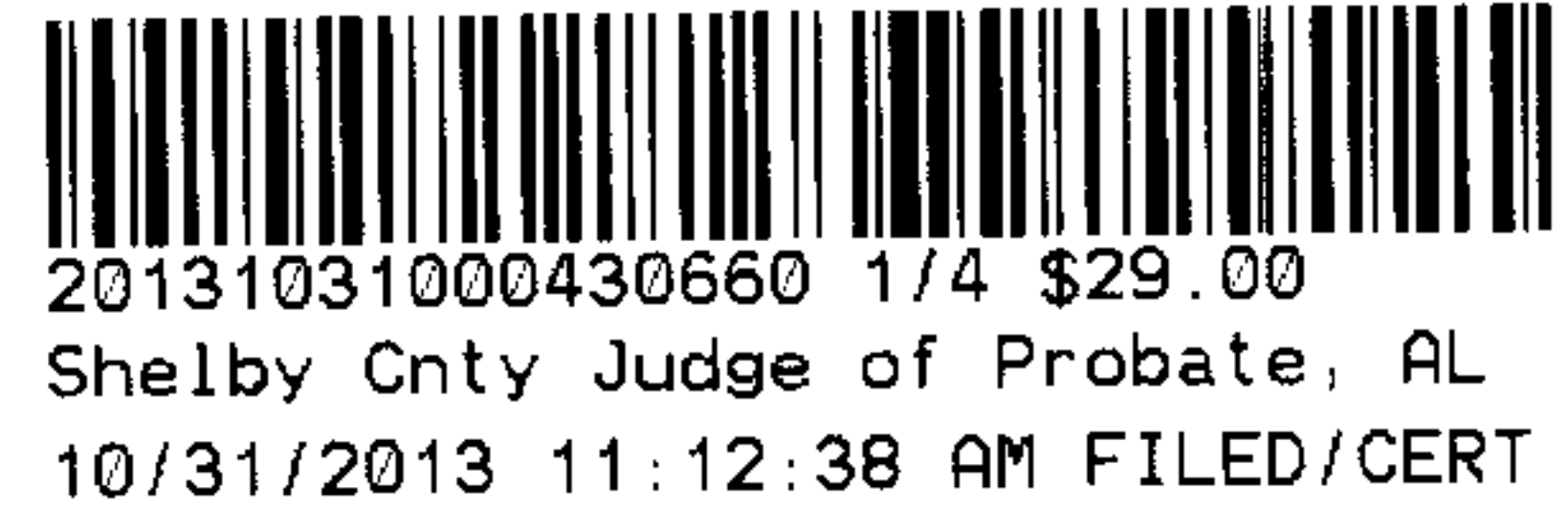

FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 31st day of July, 2007, Kimberly S. Severin aka Kimberly P. Severin & Mark Severin Wife and Husband, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for New South Federal Savings Bank, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20070809000374390, said mortgage having subsequently been transferred and assigned to LPP Mortgage LTD, by instrument recorded in Instrument Number 20100917000306660, in the aforesaid Probate Office ("Transferee"); and

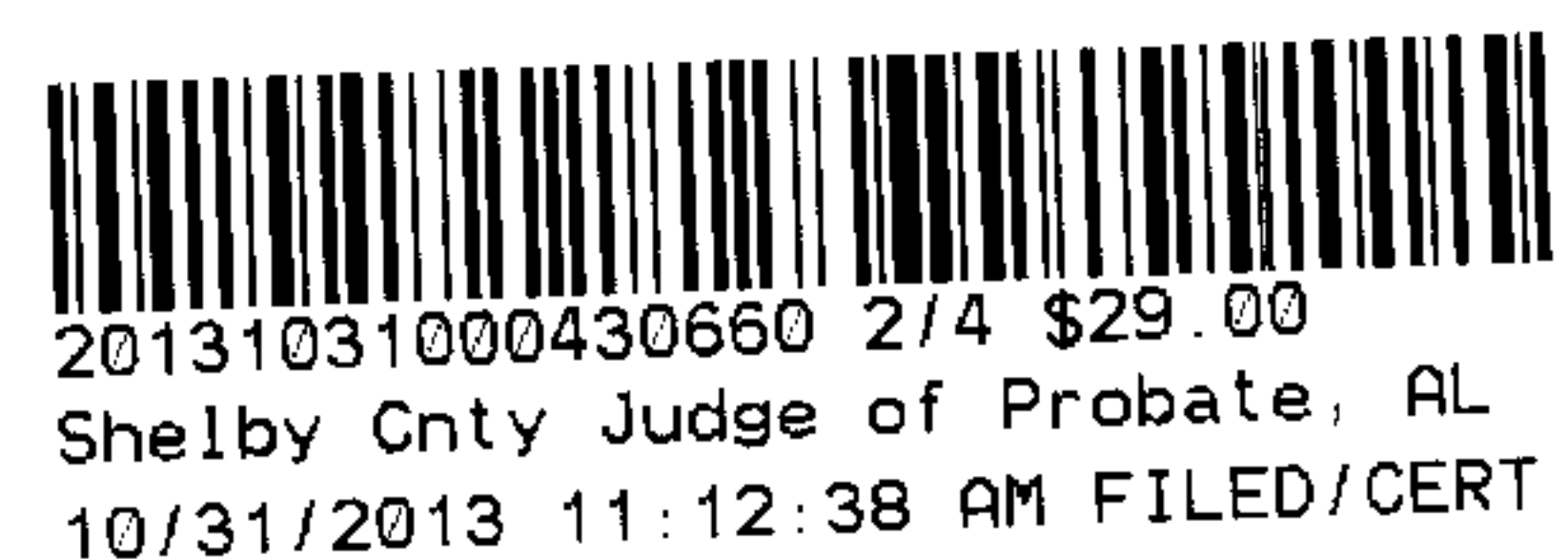

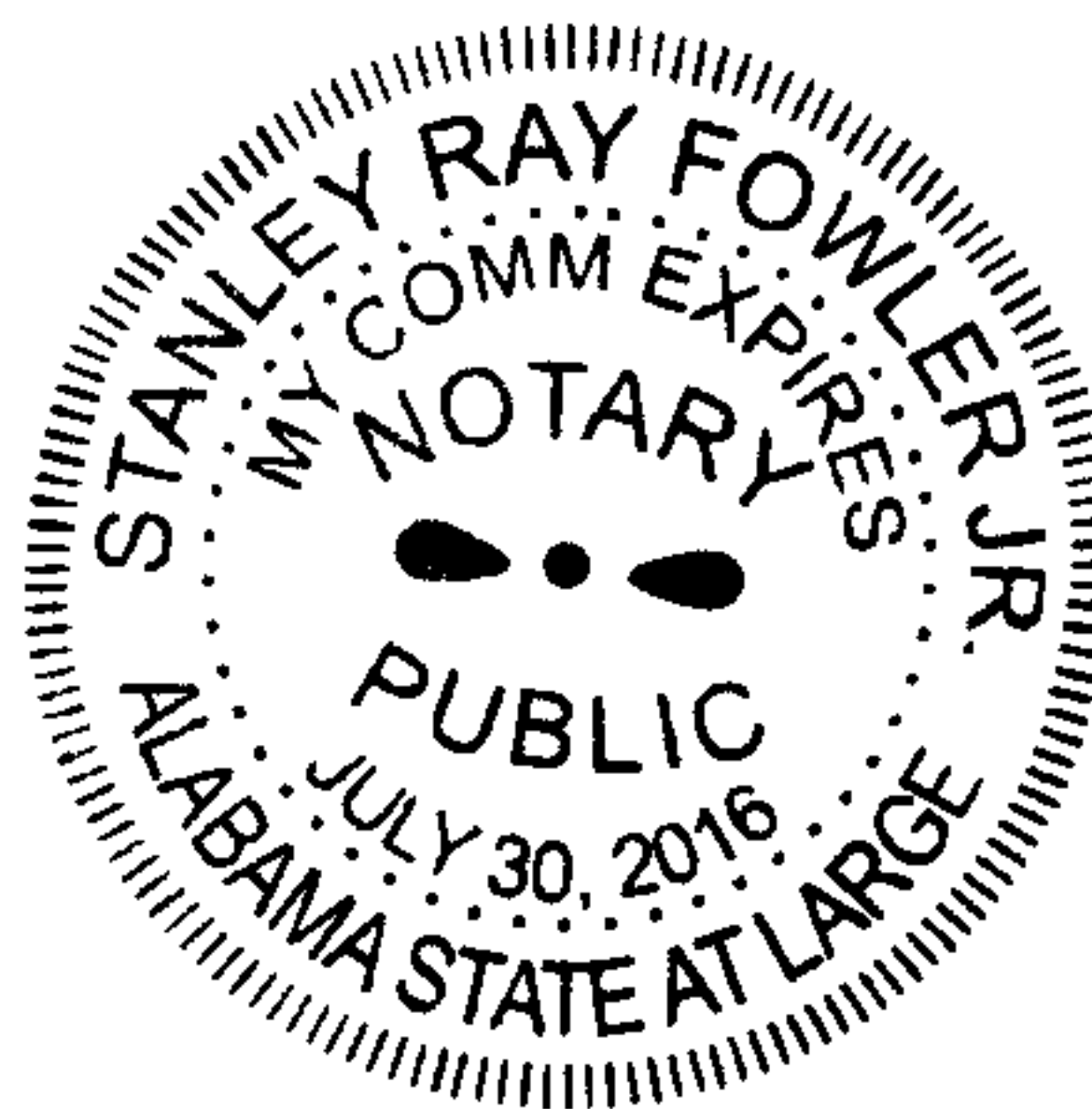
