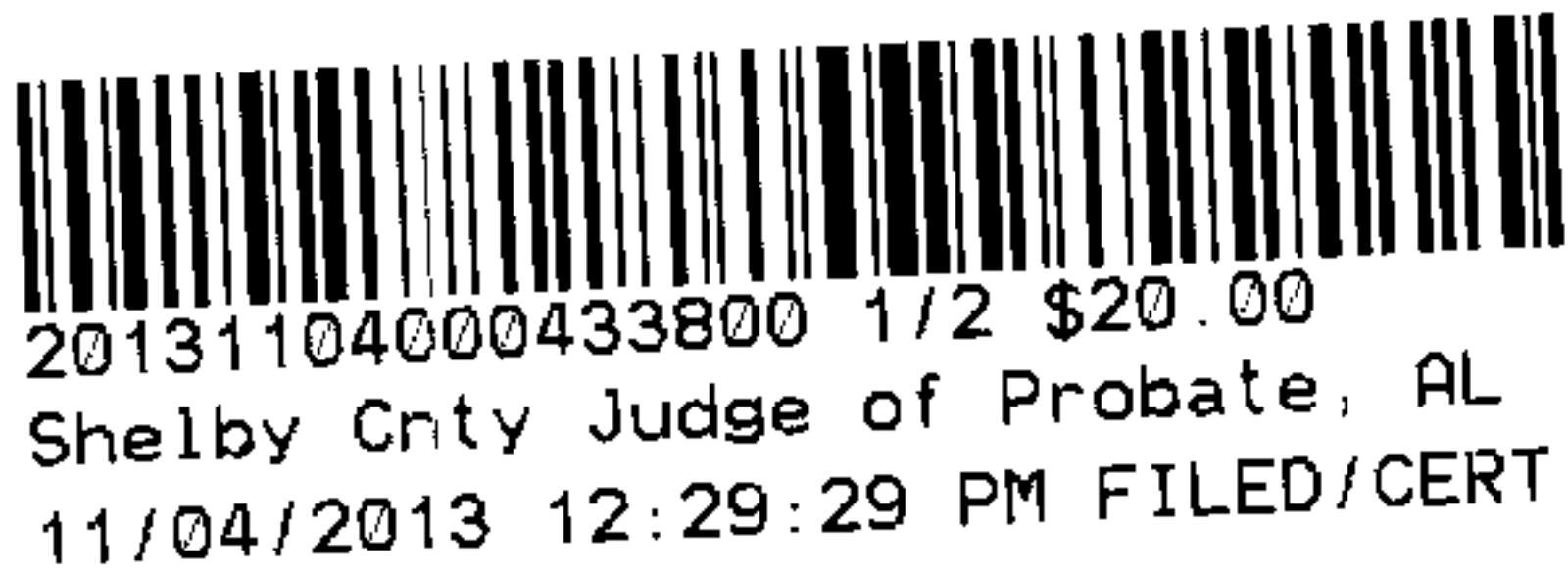

This property is not the homestead of Gregory K. Arnett, a married man, nor of his spouse.

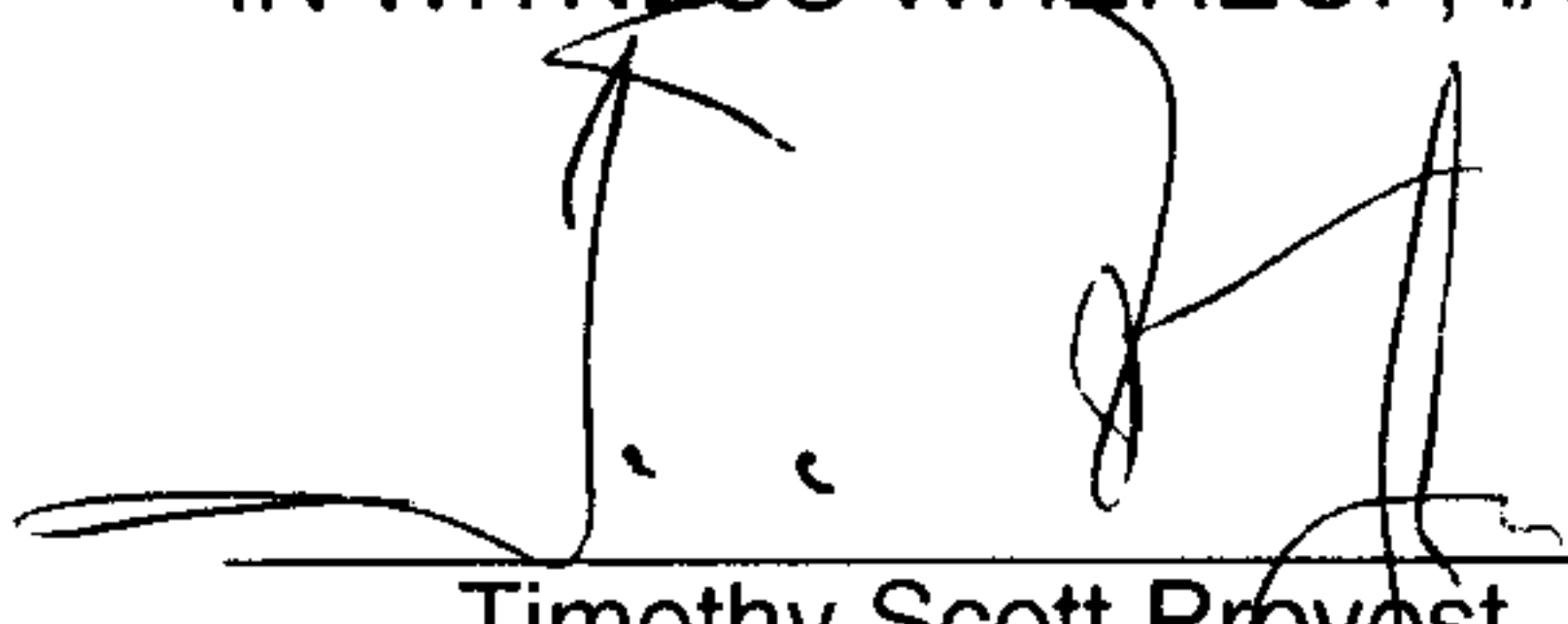
