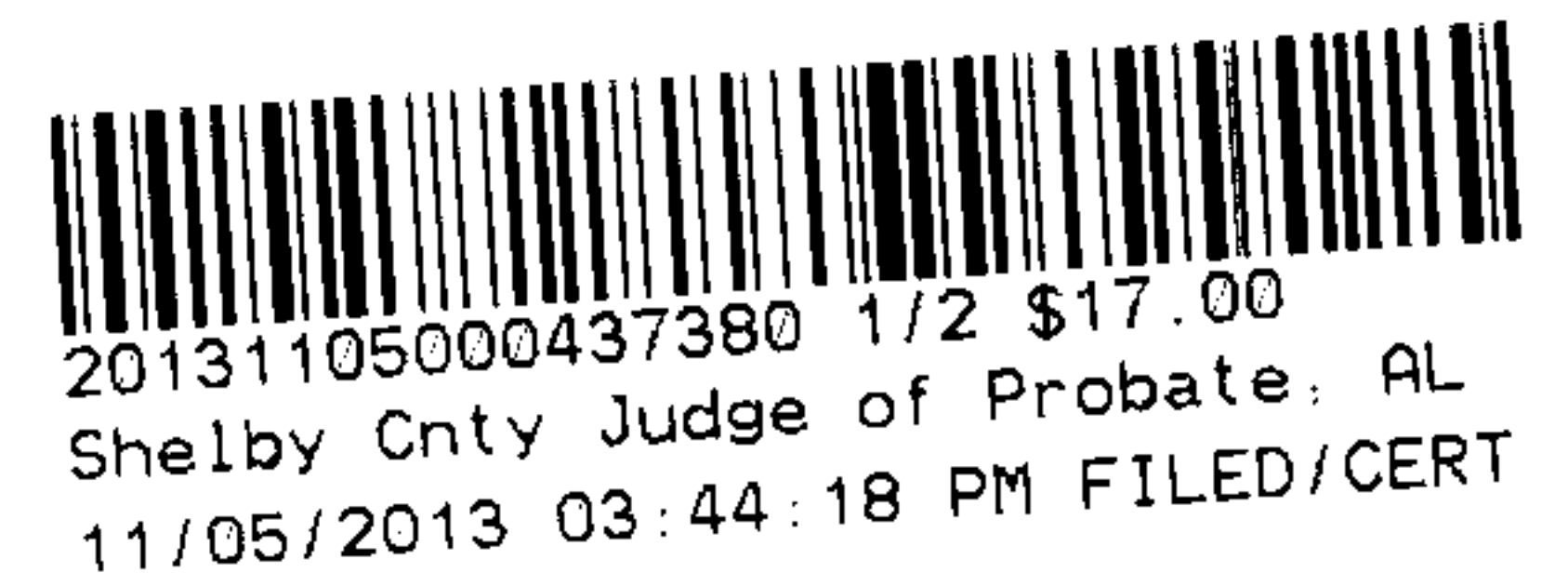

CERTIFICATION OF TRUST






