CERTIFICATE OF FORMATION

I, the undersigned, desiring to form a Limited Liability Company pursuant to the laws of the State of Alabama, certify as follows:

1. The name of the Limited Liability Company (the "Company") is:

2. The term of the Company shall commence on the date of the filing of the Company's Certificate of Formation in the Probate Court and shall continue indefinitely, provided, however, that the Company shall terminate and dissolve upon the first of the following events: (a) when there are no remaining Members, unless the holders of all the financial rights in the Company agree in writing, within 90 days after the cessation of membership of the last member, to continue the legal existence and business of the Company and to appoint one or more new members; or (b) on the written consent by all of the Members in their sole discretion.

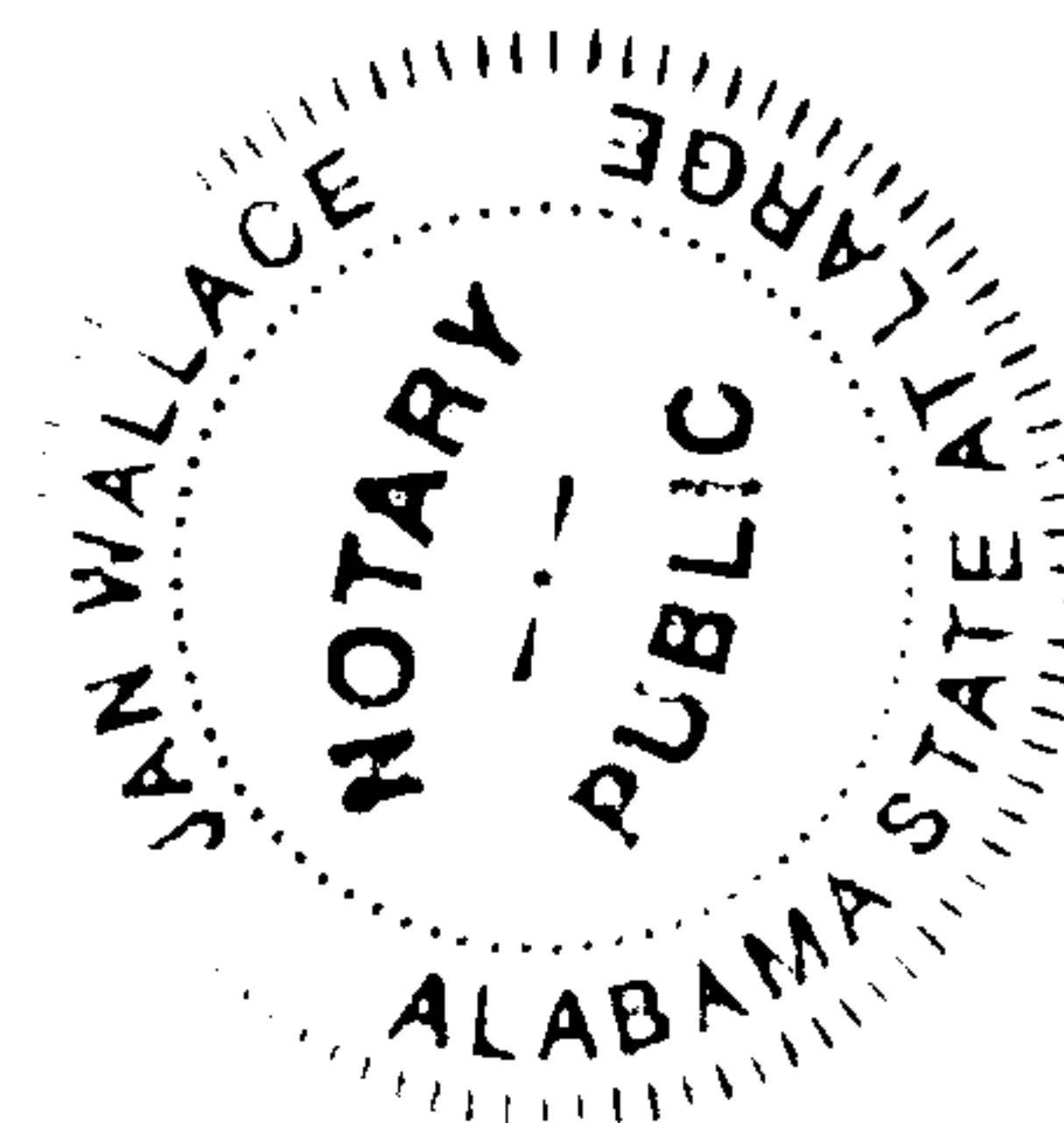
