The Association claims a lien upon property owned by **Francis & Batenga Obuseh**, situated in Shelby County, Alabama described as follows:

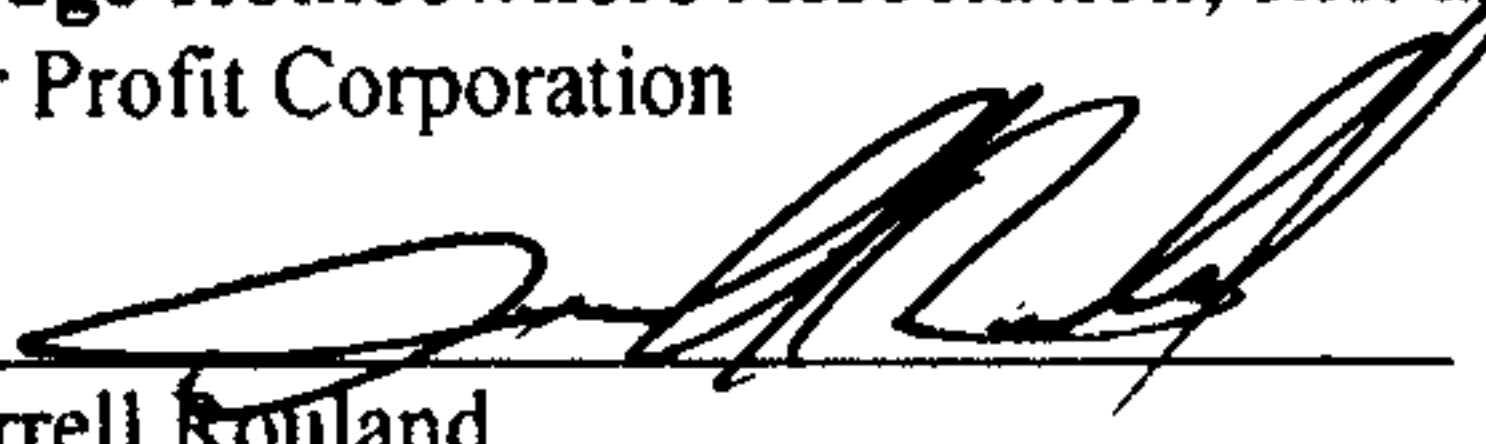
