The Association claims a lien upon property owned by **Cleveland & Carolyn Proffit**, situated in Shelby County, Alabama described as follows:

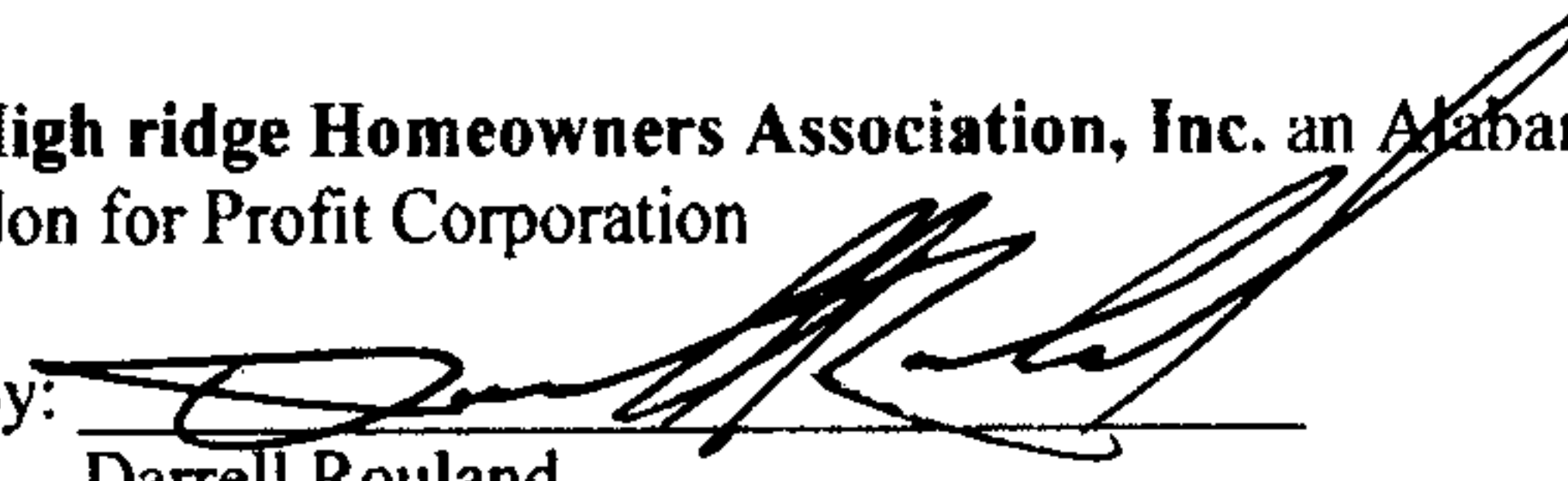

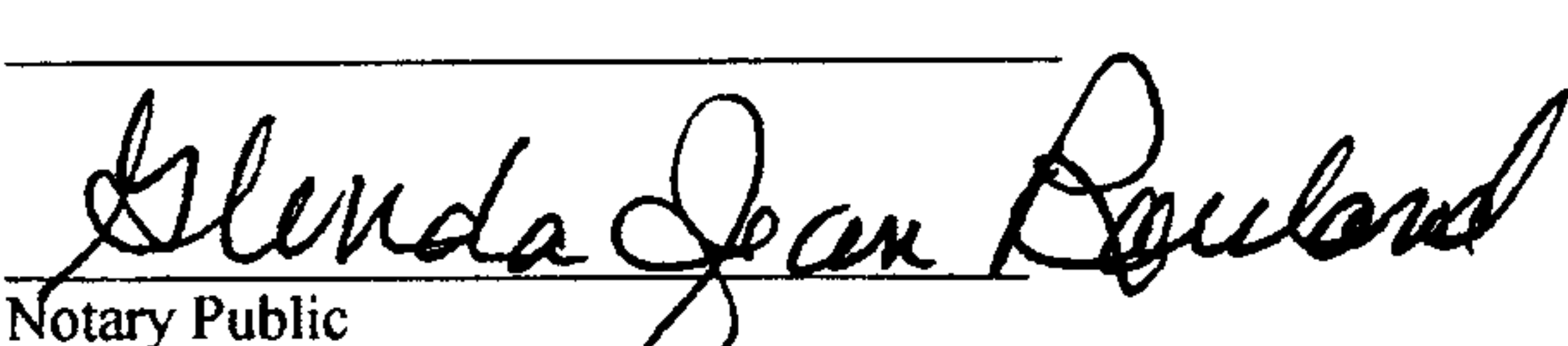
