Pursuant to Section 805 of the Single Family Mortgage Foreclosure Act of 1994 (the Act), 12 U.S.C. § 3754 and the Delegation of Authority published in the Federal Register on November 15, 1995, (60 F.R. 57484), you are hereby designated to act as a foreclosure commissioner to act on behalf of the Secretary of Housing and Urban Development (the Secretary) to conduct nonjudicial foreclosures in the State of Alabama of the mortgages that may be referred to you by various Offices of the Department of Housing and Urban Development (HUD) or its designee. Foreclosures that are referred to you are to be conducted pursuant to the Act, the regulations, and the instructions that will be given to you at the time of referral of a case.

The commission that will be paid to you for a completed foreclosure will be determined by HUD. A percentage of that amount will be paid for cases that are withdrawn by HUD, based on the following schedule:


20% Work completed up to "service" of the Notice of Foreclosure and Sale.

80% Notice of Foreclosure and Sale has been "served," including the start of publication, or posting if required.

As Foreclosure Commissioner, you are the agent of the Secretary but not an employee of the Department of Housing and Urban Development or of the Federal government. You will be responsible for your actions as any other agent.

This designation is effective immediately and can be revoked with or without cause pursuant to the Act. Four originals and one copy of this Designation are enclosed. Please sign, date, and provide your Tax Identification or Social Security Number.

Return the executed copy with the Notary certification to the undersigned at the above address and retain the other originals for recording as necessary.
