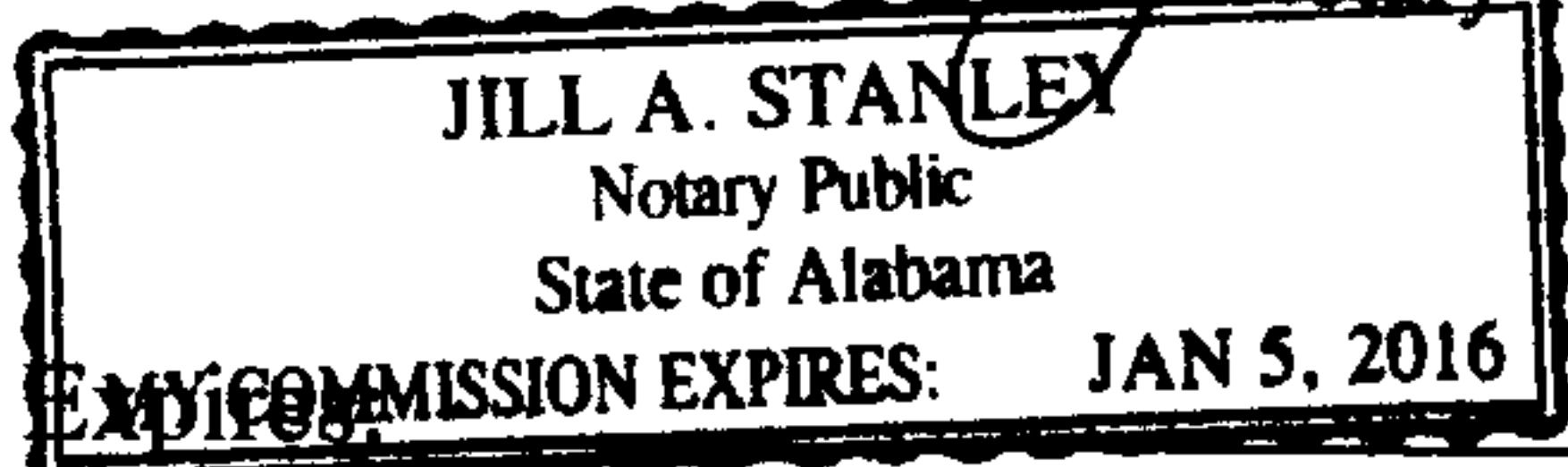
Oath of Office

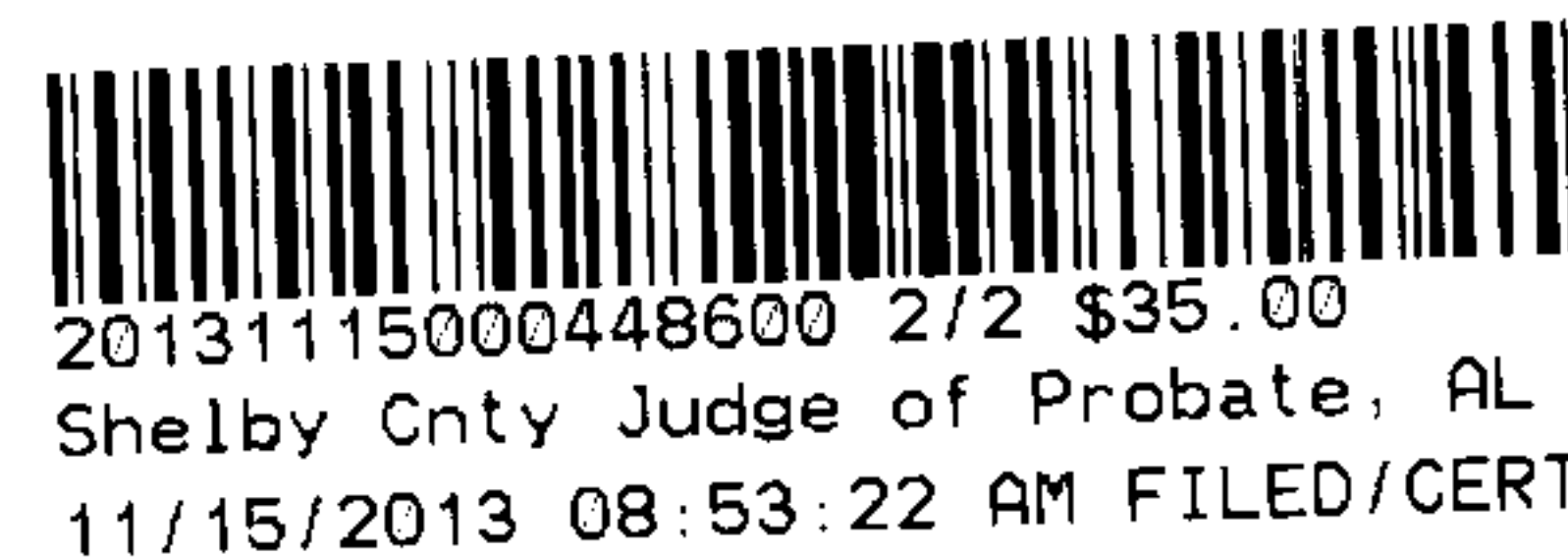

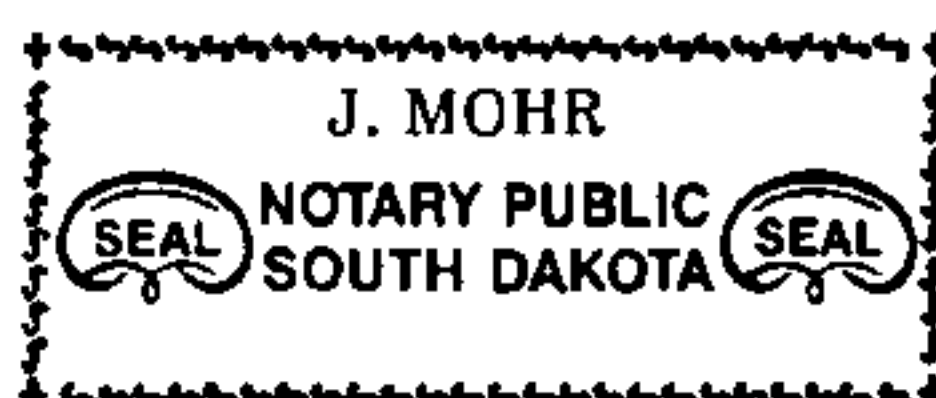
