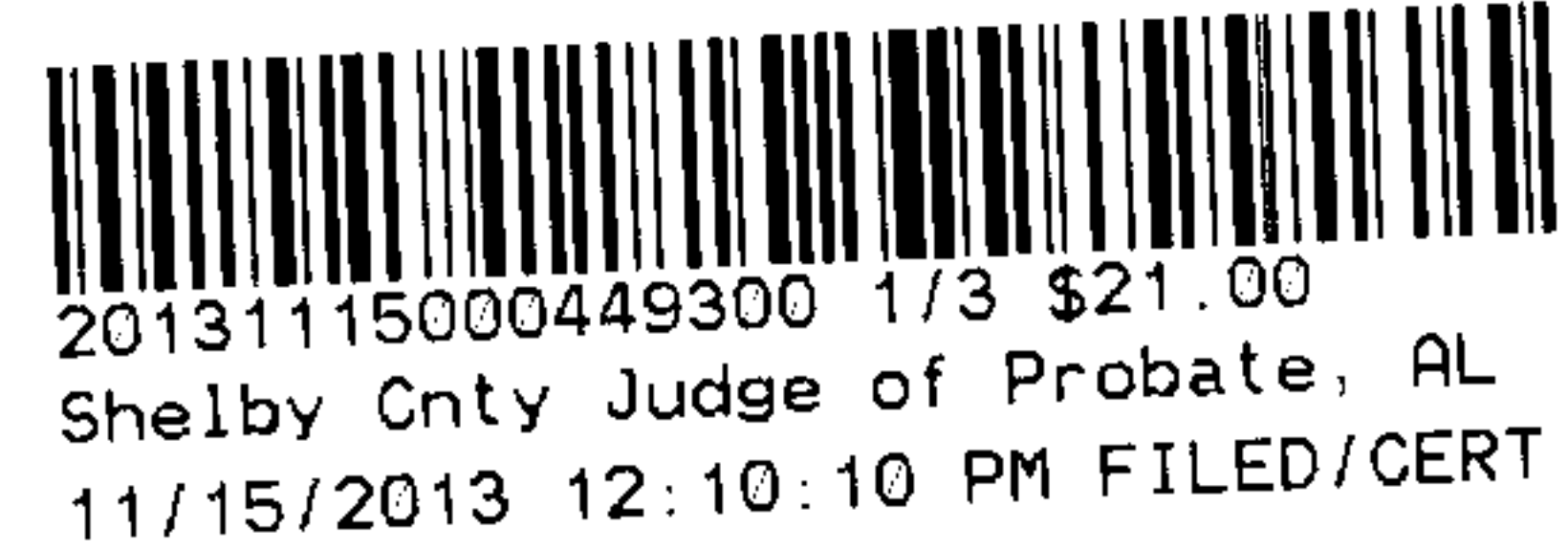

WARRANTY DEED



KNOW ALL MEN BY THESE PRESENTS:

That in consideration of One Hundred Thirty Seven Thousand and 00/100 Dollars (\$137,000.00) in hand paid to the undersigned **Kyle Deneke and Alima Deneke** (hereinafter referred to as "Grantors"), by **Robert J. Boggs Jr. and Amber N. Boggs** (hereinafter referred to as "Grantees"), the receipt and sufficiency of which are hereby acknowledged, Grantors do, by these presents, grant, bargain, sell, and convey unto Grantees, as **joint tenants with right of survivorship**, the following described real estate situated in **Shelby County**, Alabama, to-wit:

Lot 3-38, according to the Plat of Chelsea Park 3rd Sector as recorded in Map Book 34, Page 23 A & B in the Probate Office of Shelby County, Alabama.


TO HAVE AND TO HOLD to Grantees, as joint tenants, with right of survivorship, their heirs, executors, administrators and assigns forever.



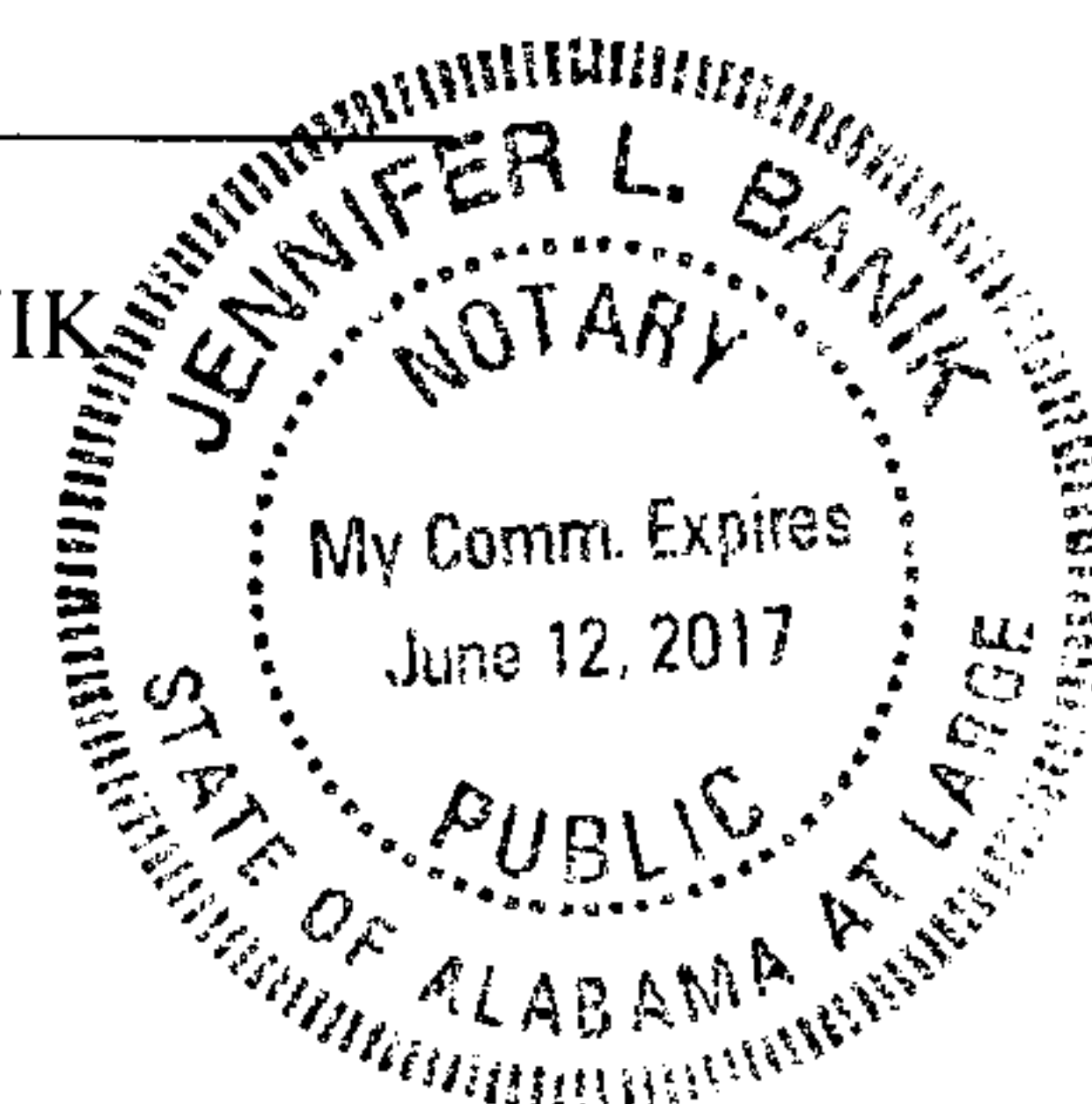
