**ARTICLES OF ORGANIZATION
OF
LE & FH LLC**

The undersigned, acting as the organizers of a limited liability company under the Alabama Limited Liability Company Act, hereby adopt the following Articles of Organization for LE & FH LLC:

ARTICLE ONE

The name of the Company is LE & FH Limited Liability Company (LLC).

ARTICLE TWO

The Company shall continue in existence until it is dissolved in accordance with the provisions of the operating agreement, or, if there is no operating agreement or no provision in the operating agreement governing the duration of the Company, then in accordance with the Alabama Limited Liability Company Act.

ARTICLE THREE

The Company is organized for the purpose of owning, renting, and managing rental real estate.

ARTICLE FOUR

The mailing address of the initial registered office is 300 Cahaba Park Circle Ste. 133 Birmingham, AL 35242 and the name of the initial registered agent of the Company at such address is Richard F. Herring.

ARTICLE FIVE

The names and mailing addresses of the initial members of the company are:

ARTICLE SIX

The initial members of the Company may admit additional members at such times upon such terms and conditions, as may be mutually agreed by the Company and the additional members.

ARTICLE SEVEN

The members of the Limited Liability Company shall have the right to continue the business of the Limited Liability Company upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member of the Limited Liability Company if (i) there are at least two remaining members or at least one remaining member and a new member is admitted; and (ii) the legal existence and business of the Limited Liability Company is continued by a written consent of all the remaining members within ninety (90) days after the occurrence of the events of disassociation.

ARTICLE EIGHT

The Company is to be managed by one or more managers. The names and mailing addresses of the initial managers, who shall serve as managers until the first annual meeting of members of the Company or until their successors are duly elected, are:
