(herein referred to as Grantor, whether one or more), grant, bargain, sell, and convey unto

SELDON R. DANIELS, TRUSTEE, OR HIS SUCCESSORS IN TRUST, UNDER THE DANIELS LIVING TRUST, DATED NOVEMBER 19, 2013 AND ANY AMENDMENTS THERETO

(herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:

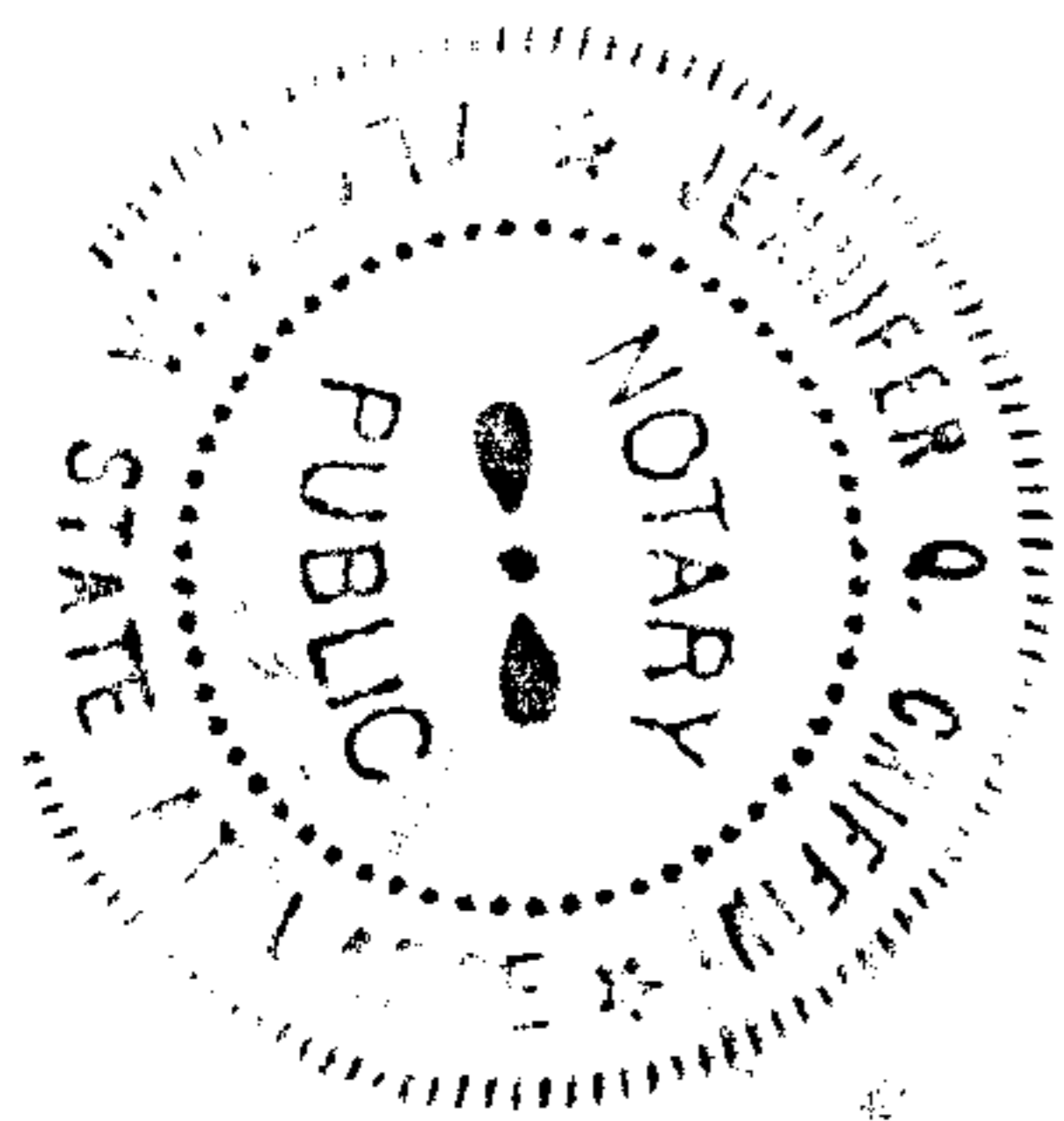
