Know All Men by These Presents: That in consideration of **Three hundred seventy five thousand and no/100 (\$375,000.00)**, to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Barbara D. Weeks, an unmarried woman** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **John Randall Horton and Melissa Horton** (herein referred to as grantee, whether one or more), the following described real estate, situated in **Shelby County, Alabama**, to-wit:

Lots 218 and 219, according to the Survey of Shadow Oak Estates 2nd Sector, as recorded in Map Book 33, Page 149, in the Probate Office of Shelby County, Alabama.

Subject to mineral and mining rights if not owned by Grantor.


