

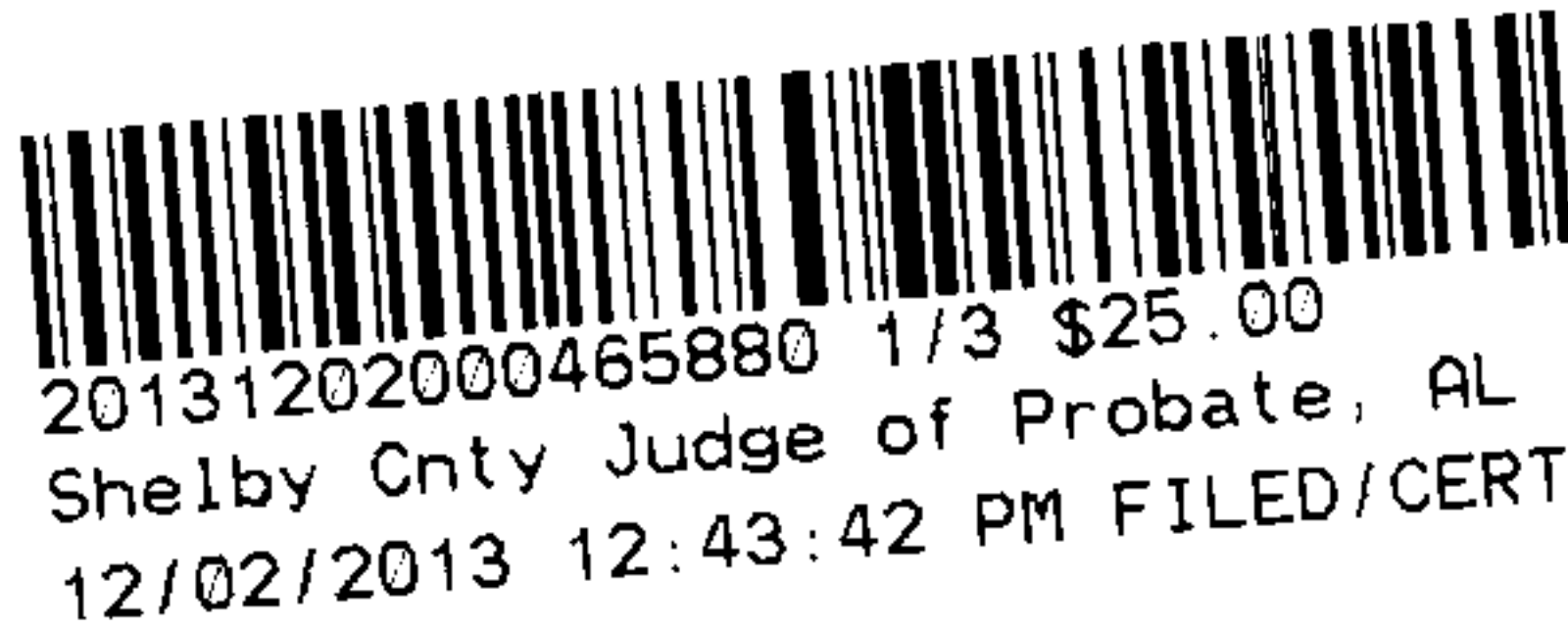

CORPORATION FORM STATUTORY WARRANTY DEED – Jointly for Life with Remainder to Survivor

County, Alabama, to-wit:

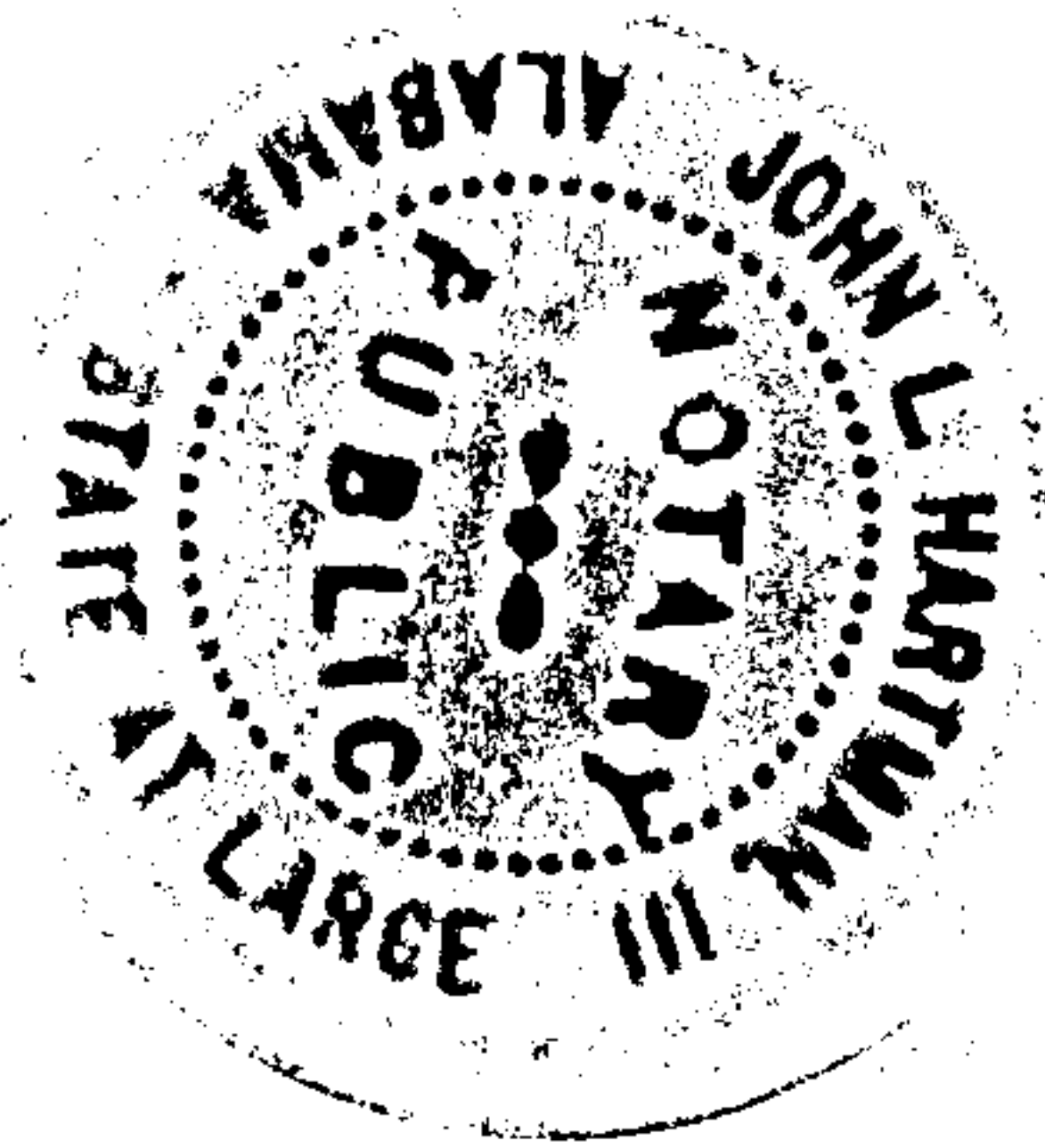

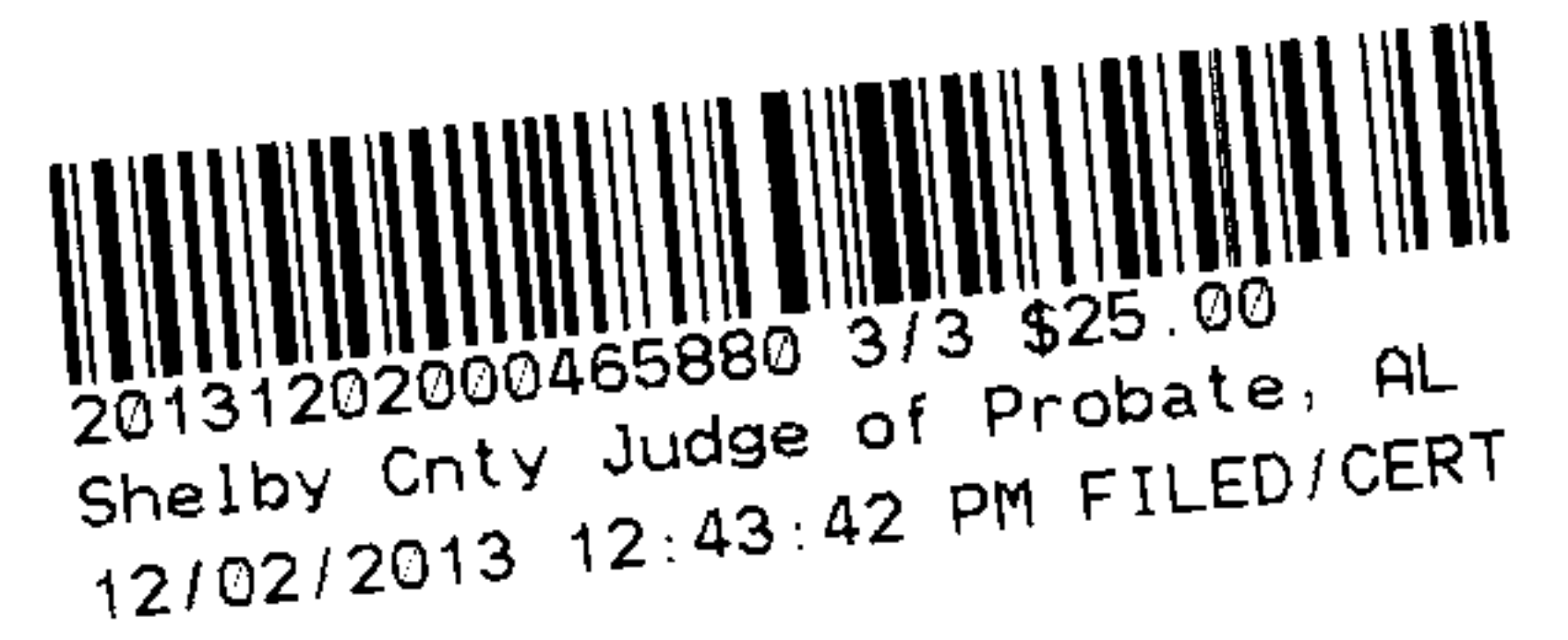
