

#### FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on December 23, 2002, towit: Melanie J. Bryant, an unmarried woman, executed a mortgage to Mortgage Electronic Registration Systems, Inc., solely as nominee for Countrywide Home Loans, Inc., its successors and assigns, herein called the Mortgagee, which said mortgage was recorded on January 2, 2003, in Document Number 20030102000001450, in the Office of the Judge of Probate, Shelby County, Alabama, which conveyed the property hereinafter described to secure the indebtedness evidenced by a note, payable in installments, therein described; which mortgage and the indebtedness secured thereby was subsequently assigned to Green Tree Servicing LLC, by assignment recorded June 5, 2013, and recorded in Document Number 20130605000230230, of said Probate Court records; and
