FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on March 6, 2003, to-wit: Teri L. Smith, joined by her spouse, Terry W. Smith, executed a mortgage to Mortgage Electronic Registration Systems, Inc., solely as nominee for Castle Mortgage Corporation, its successors and assigns, herein called the Mortgagee, which said mortgage was recorded on March 20, 2003, in Document Number 20030320000169380, in the Office of the Judge of Probate, Shelby County, Alabama, which conveyed the property hereinafter described to secure the indebtedness evidenced by a note, payable in installments, therein described; which mortgage and the indebtedness secured thereby was subsequently assigned to CitiMortgage, Inc., by assignment recorded April 26, 2013, and recorded in Document Number 20130426000170430, of said Probate Court records; and
