FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on October 30, 2006, to-wit: Ada Griffies and Jerry M. Griffies, wife and husband, executed a mortgage to Mortgage Electronic Registration Systems, Inc. solely as nominee for Synovus Mortgage Corp., its successors and assigns, herein called the Mortgagee, which said mortgage was recorded on November 6, 2006, in Instrument Number 20061106000544540, in the Office of the Judge of Probate, Shelby County, Alabama, which conveyed the property hereinafter described to secure the indebtedness evidenced by a note, payable in installments, therein described; which mortgage and the indebtedness secured thereby was subsequently assigned to Chase Home Finance LLC, by assignment recorded September 29, 2010, and recorded in Instrument Number 20100929000320740, of said Probate Court records; and

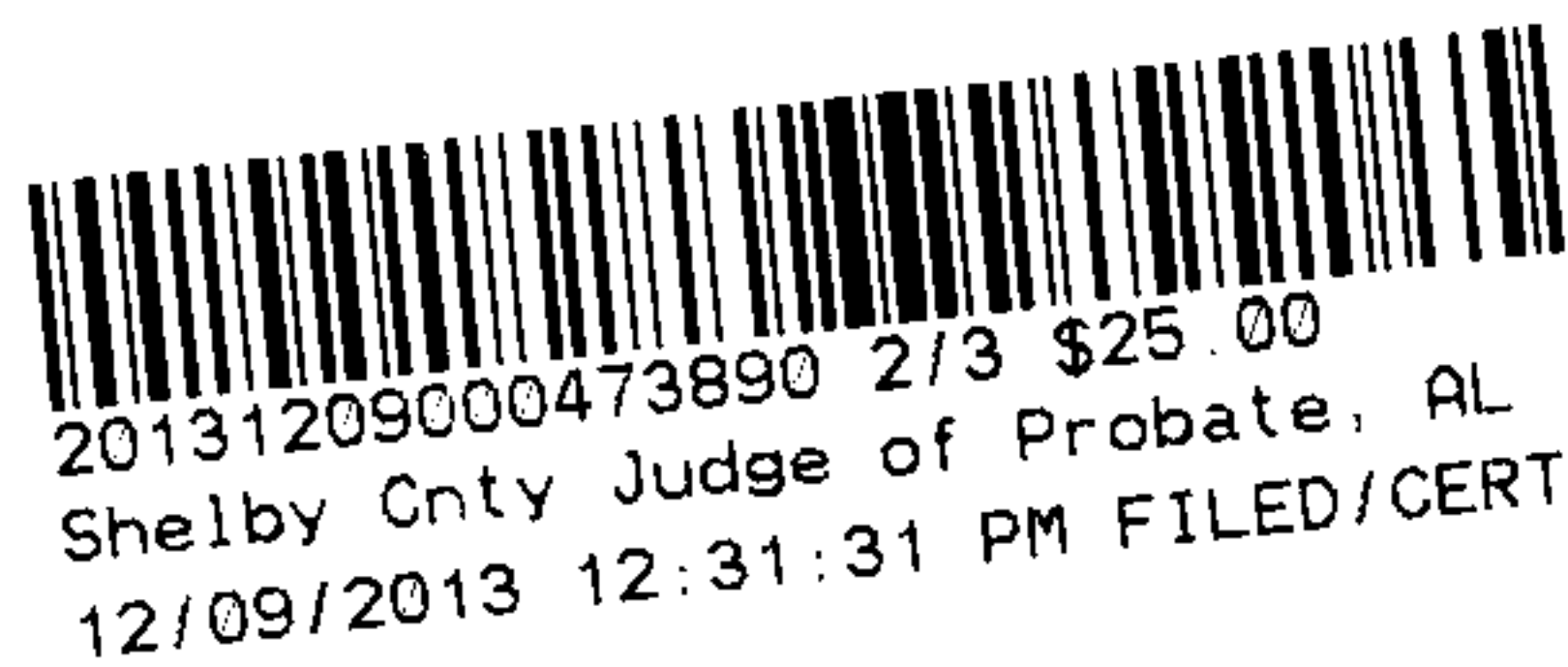
