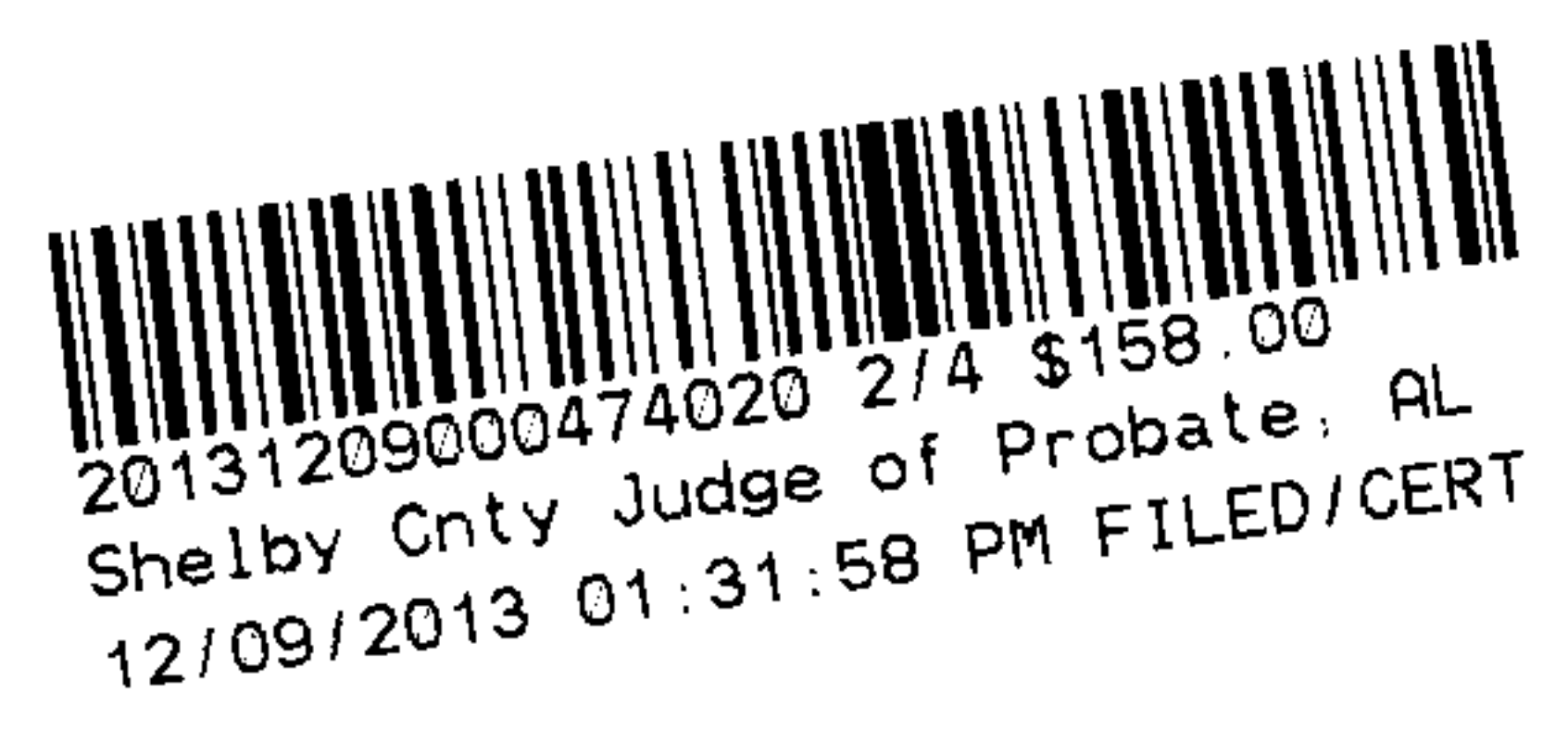
ARTICLE VII
DENIAL OF PREEMPTIVE RIGHTS

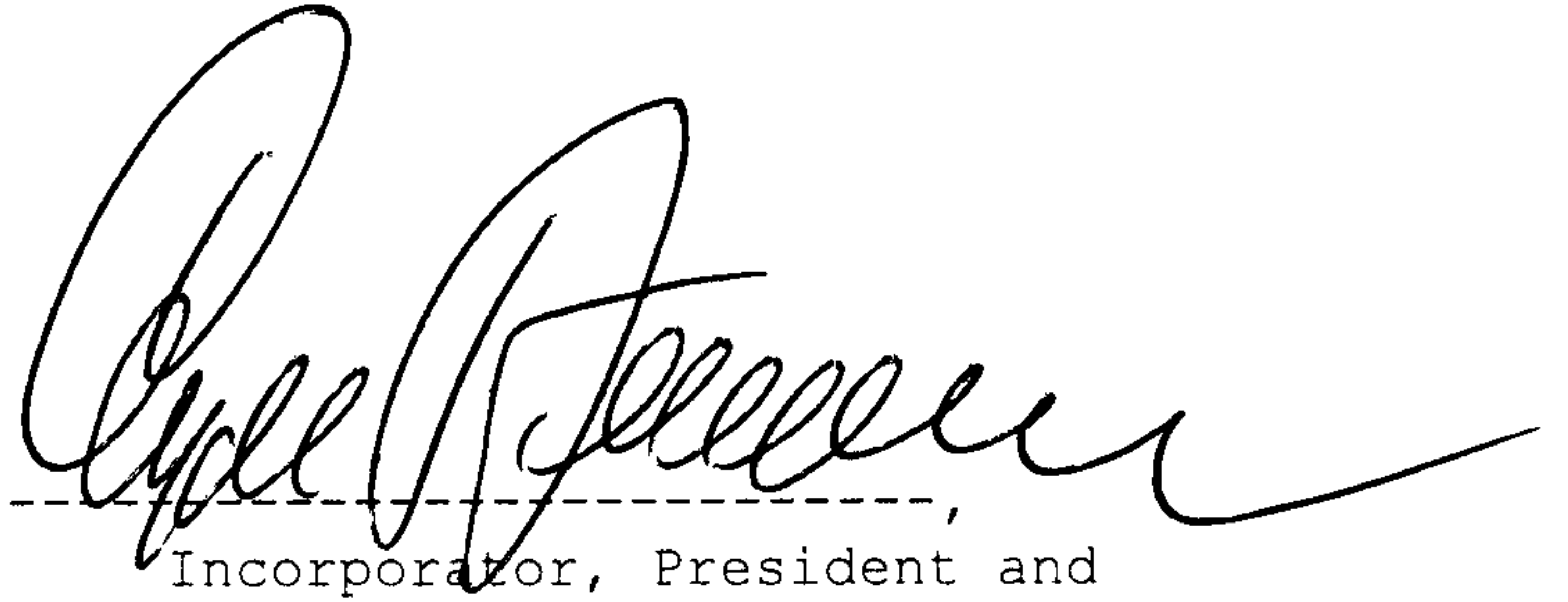
No holder of shares of this Corporation shall, as such holder, have any preemptive rights in, or preemptive rights to purchase or subscribe to, any shares of this Corporation, or an, bonds, debentures or any other securities or obligations convertible into or exchangeable with any shares of this Corporation, other than such rights of conversion or exchange and such rights under options or warrants or purchase or subscription arrangements, as shall be expressly granted by the Board of Directors or shareholders at such prices and upon such other terms and conditions as the Board of Directors, in its discretion, or the shareholders may fix or designate.

ARTICLE VII
LIMITATION OF LIABILITY

A director of the Corporation shall not be liable to the Corporation or its shareholders for money damages for any action taken, or any failure to take action, as a director, except for (i) the amount of a financial benefit received by such director to which such director is not entitled; (ii) an intentional infliction of harm by such director on the Corporation or its shareholder; (iii) a violation of Section 10-2B-8.33 of the Code of Alabama of 1975 or any successor provision of such section; (iv) an intentional violation by such director of criminal law; (v) breach of such director's duty of loyalty to the Corporation or its shareholders. The liability of the Director shall be limited to that under the Alabama Business Corporation or any successor statute.

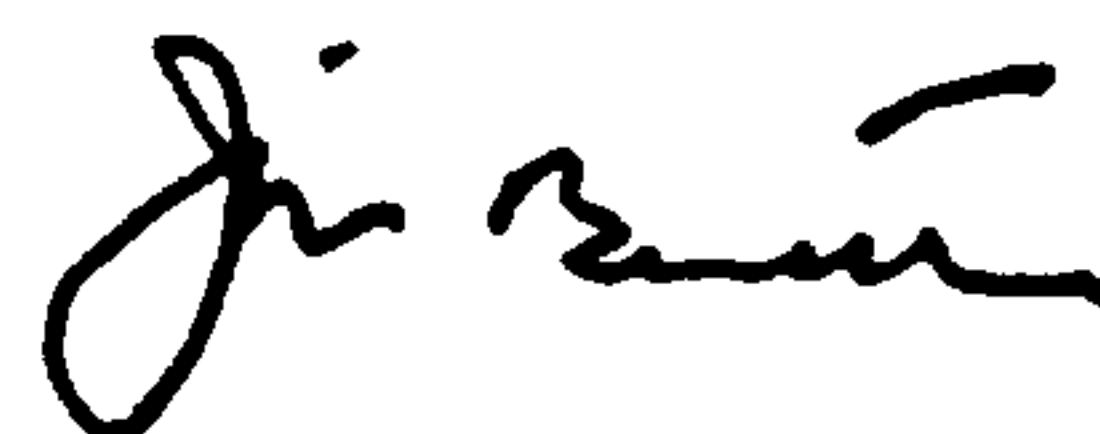
