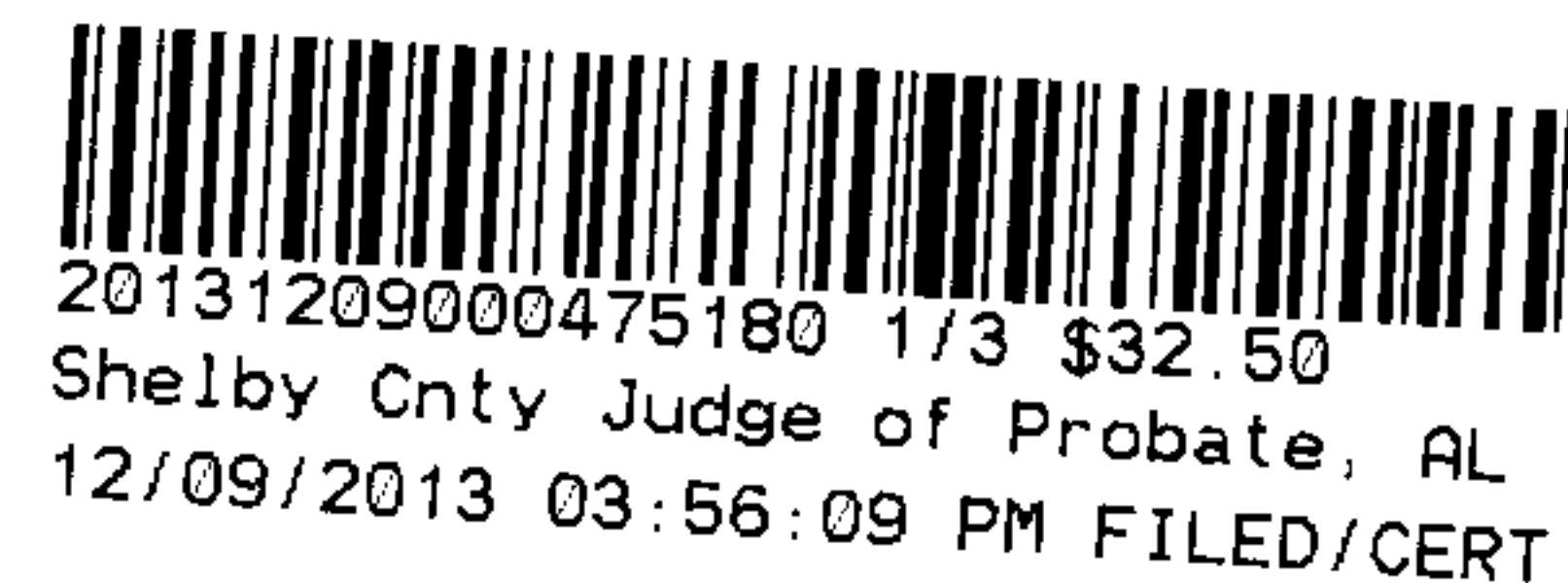

GENERAL WARRANTY DEED
Joint Tenant with Rights of Survivorship

} KNOW ALL MEN BY THESE PRESENTS:

That in consideration of **One Hundred Eighty Five Thousand and NO/100 Dollars (\$185,000.00)** to the undersigned grantor in hand paid by the grantees herein, the receipt whereof is acknowledged, I,

Jimmie Frances Brindley, an unmarried person

(herein referred to as Grantor), grants, bargains, sells and conveys unto

Amanda Davani and Nicholas Davani

(herein referred to as **Grantees**), for and during their joint lives as joint tenants with rights of survivorship and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder or right of reversion, the following described real estate, situated in Shelby County, Alabama to wit:

Lot 36, Block 1, according to the Survey of Selkirk, a Subdivision of Inverness, as recorded in Map Book 6, Page 163, in the Probate Office of Shelby County, Alabama.

Subject to easements, rights of way, set back lines, restrictions, covenants, mineral and mining rights not owned by the grantors and current taxes due.


\$172,800.00 of the above consideration was secured by and through the purchase money mortgages closed and recorded herewith.

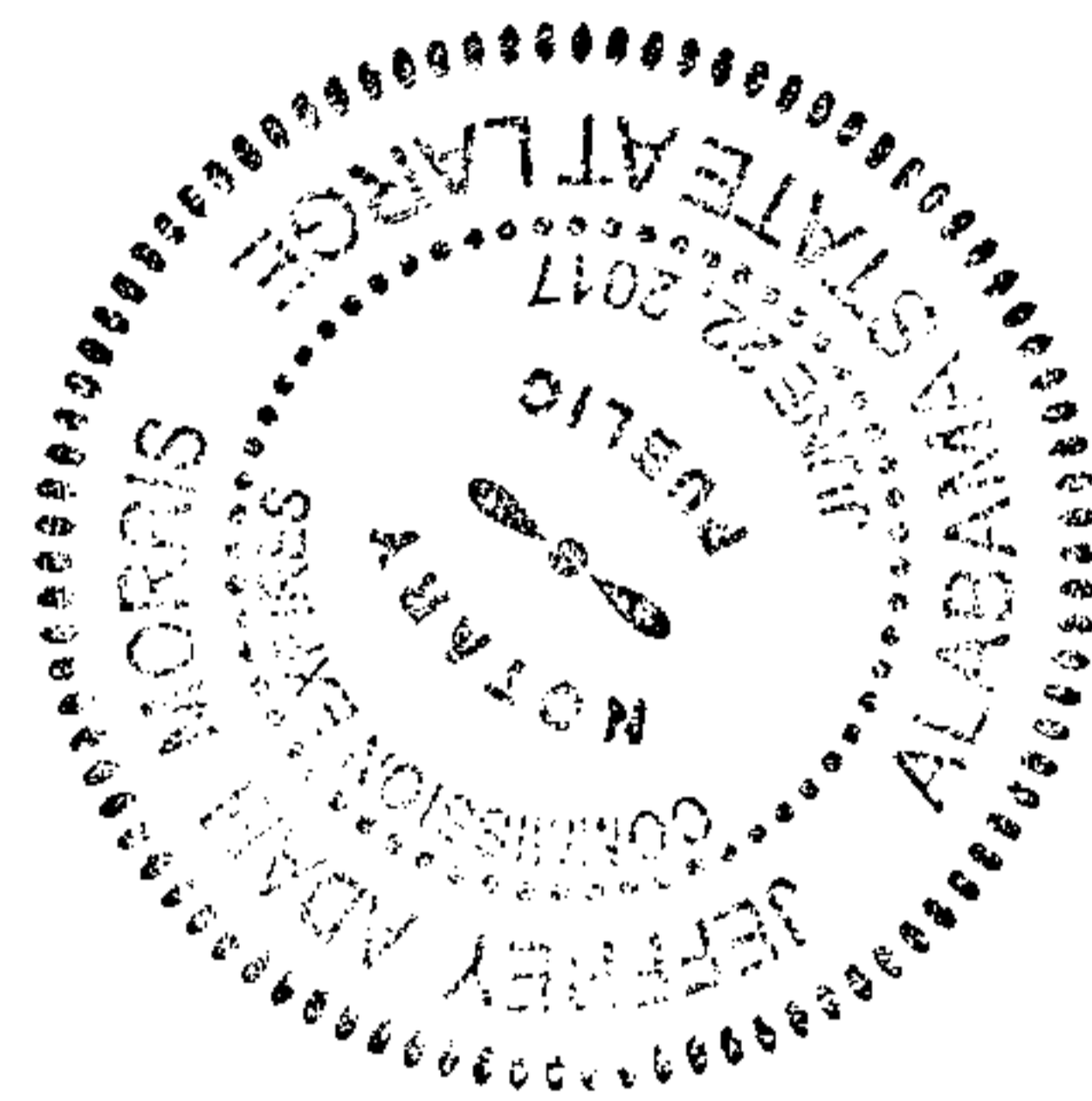
