KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 29th day of April, 1999, Christopher D. Labeau and Sherri J. Labeau, husband and wife and Mary Jo Labeau, a single person, executed that certain mortgage on real property hereinafter described to SouthTrust Mortgage Corporation, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 1999-20173, said mortgage having subsequently been transferred and assigned to Wells Fargo Bank, N.A., by instrument recorded in Instrument Number 20121031000418000, in the aforesaid Probate Office ("Transferee"); and

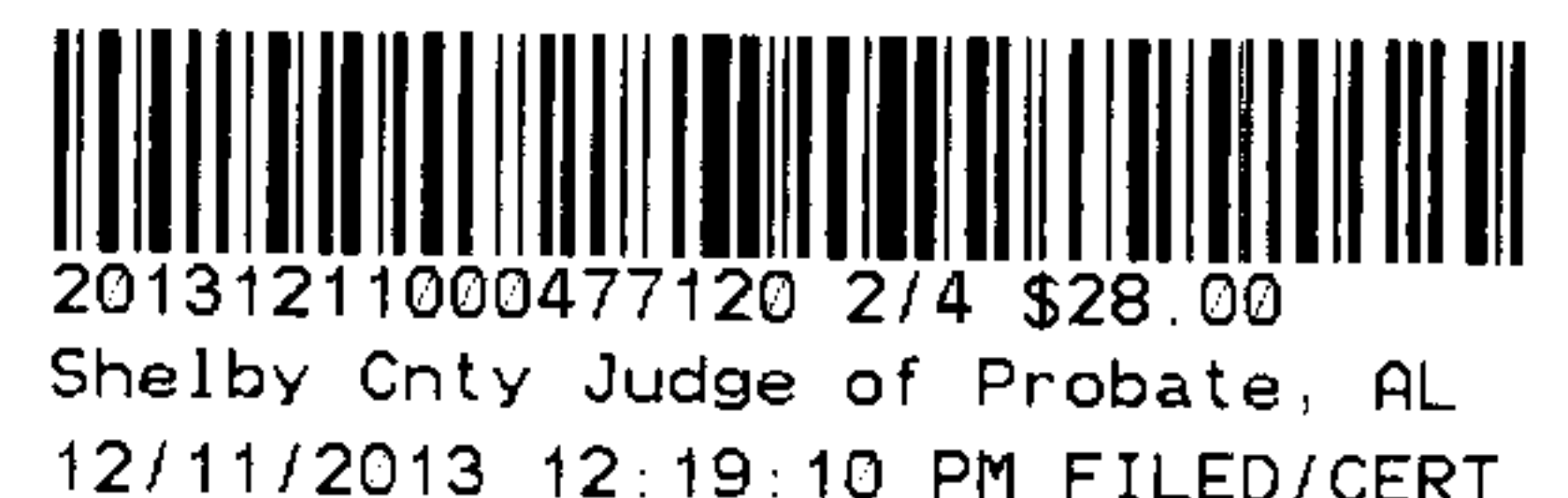

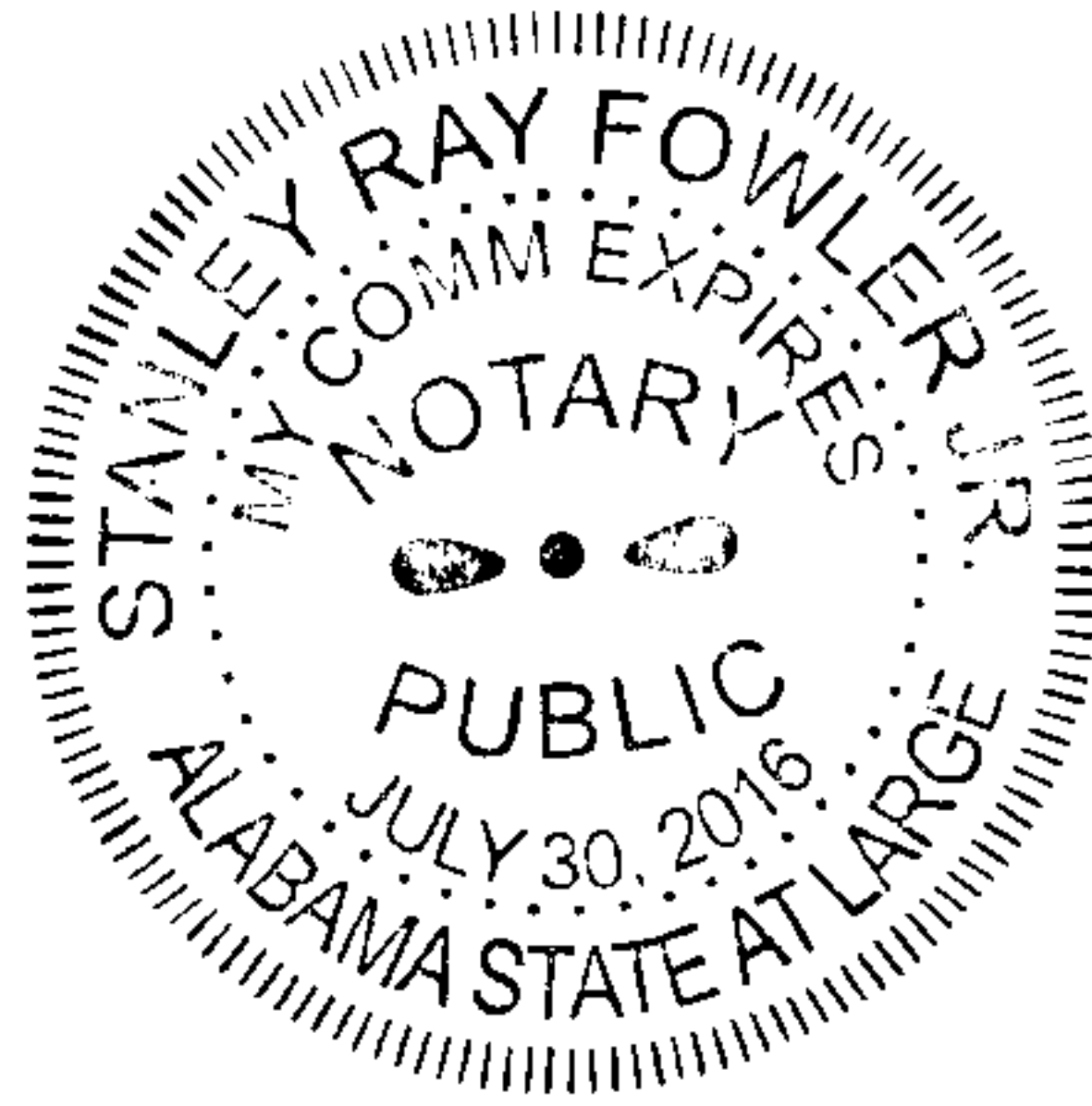

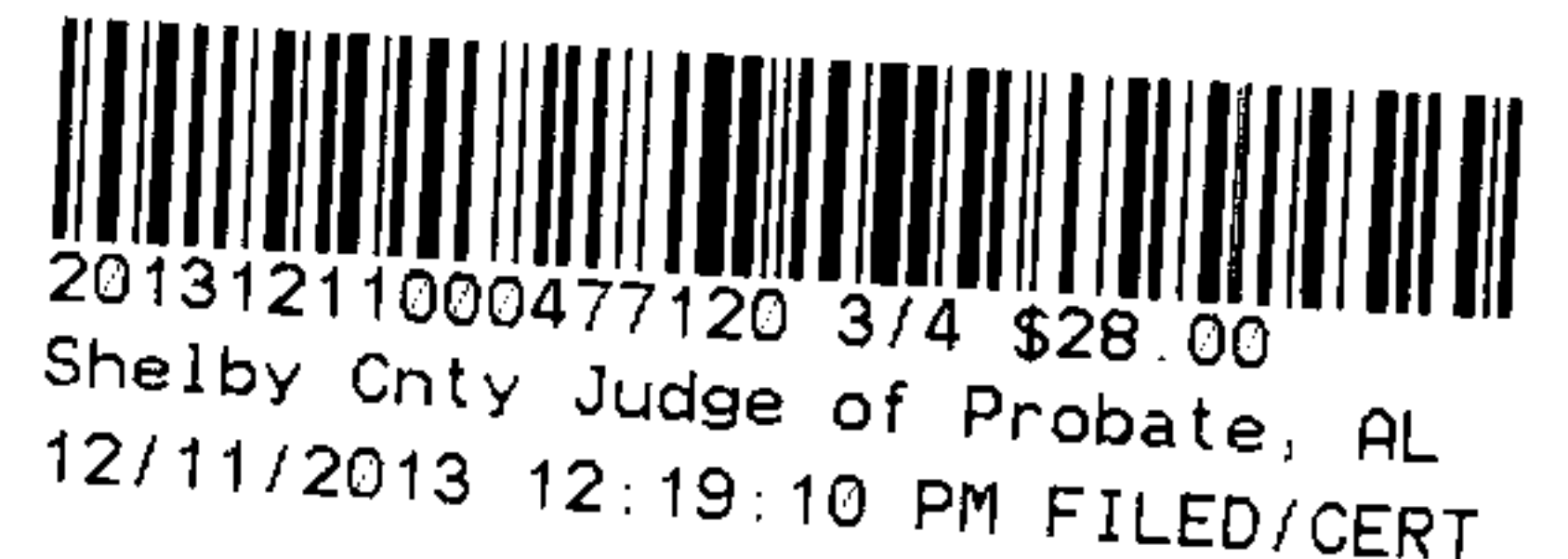
