

**CERTIFICATE OF FORMATION
OF
BHAM TIGERS, L.L.C.**

Pursuant to the Provisions of Section 10A-5-1.01, *et seq.* of the Code of Alabama, the undersigned hereby adopt the following Limited Liability Company Articles of Organization.

ARTICLE I

Name

The name of the limited liability company is BHAM TIGERS, L.L.C., (the "Company").

ARTICLE II

Duration

The Company shall have a perpetual duration, unless it is dissolved and its affairs wound up in accordance with the Alabama Limited Liability Company Act (the "Act").

ARTICLE III

Purposes

The purposes for which the Company is formed are:

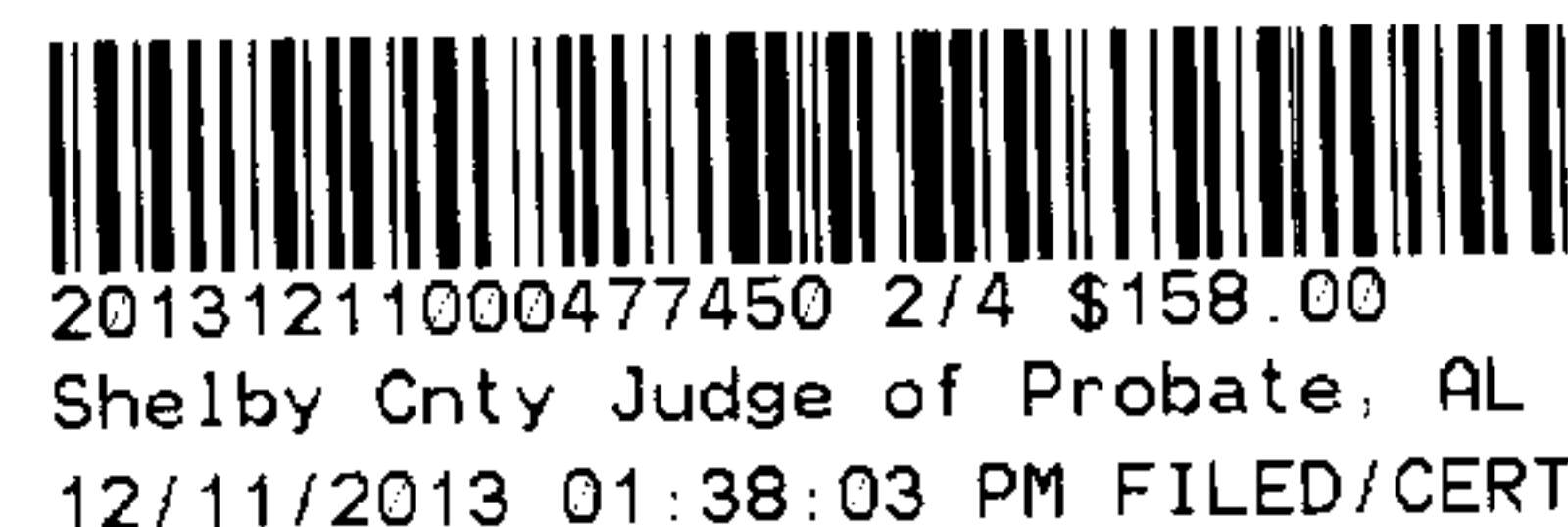
- A. To own, buy, sell, lease, improve and deal generally in real and personal property of every type and description.
- B. To borrow money and for the purpose of carrying on the business of this company, to lease, buy, sell, convey, rent and mortgage or pledge, both real and personal property as the same shall be necessary or incidental to the carrying on of said business, and generally to do all things that may be necessary or incidental to the carrying on of said business.
- C. Subject to the limitations and restrictions imposed by law, to make, accept, endorse, execute and issue promissory notes, bills of exchange, bonds, debentures, or other obligations from time to time for the purchase of property or for any purpose in or about the business of the company.
- D. To establish lines of credit with banking houses for the purposes hereinabove enumerated and set forth, and to incur indebtedness and to raise, borrow and secure the payment of money in any lawful manner, including the issue and sale or other disposition of warrants, bonds, debentures or obligations, negotiable and transferable instruments, and evidences of indebtedness of any kind, whether secured by mortgage, pledge, deeds of trust, or otherwise, for the purpose of adding additional capital or for any other purposes in or about its business or affairs without limits as to amount, except as provided by statute, this to be done on such terms and conditions and by

such officers as said banking house or houses may require.

- E. To acquire property, rights, franchises, certificates and good will, including the whole or any part of the assets, and in connection therewith, assume or guarantee such liabilities of any person, firm, associate or other company as this company may lawfully acquire or assume, to pay for the same in cash, or in stocks or bonds of this corporation, or otherwise.
- F. To subscribe for, buy, sell, and own stock, notes or bonds of any other corporation.
- G. To engage in any other lawful activity, except that of banking or insurance.
- H. To act as agent, representative, or receiver of any person, firm, corporation, or governmental entity or instrumentality in respect to any lawful undertaking or transaction.
- I. To purchase, take, receive, lease or otherwise acquire, own, hold, improve, use and otherwise deal in or with, real or personal property or any interest therein, wherever situated, and to sell, convey, mortgage, pledge, lease, exchange, transfer and otherwise dispose of real or personal property, or any interest therein.
- J. To purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge, or otherwise dispose of , and otherwise use and deal in and with, shares or interests in, or obligations of, corporations, associations, partnerships, limited liability companies, individuals, or direct or indirect obligations of governmental entities or of any instrumentality thereof.
- K. To lend money, invest and reinvest its funds, and take and hold real and personal property as security for the payment of funds so loaned or invested.
- L. To engage in any other lawful act or activity for which limited liabilities companies may be organized pursuant to the Act.
- M. To engage in the business of managing hotels and or motels.

ARTICLE IV
Registered Office; Registered Agent

The location and street address of the initial registered office of the Company shall be 1080 Hermitage Circle, Birmingham, Alabama 35242, its registered agent at such address shall be Hemal Patel.

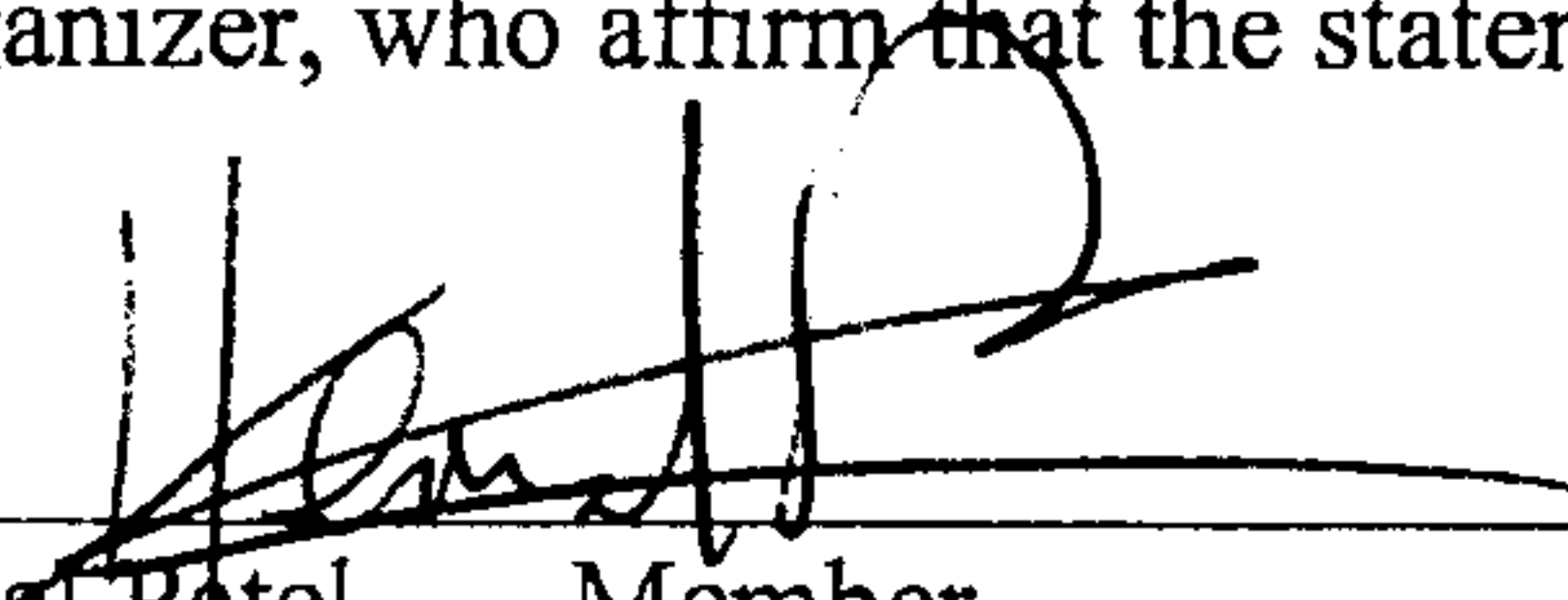
ARTICLE VI

The cessation of membership of one or more members will not result in the dissolution of the Company.

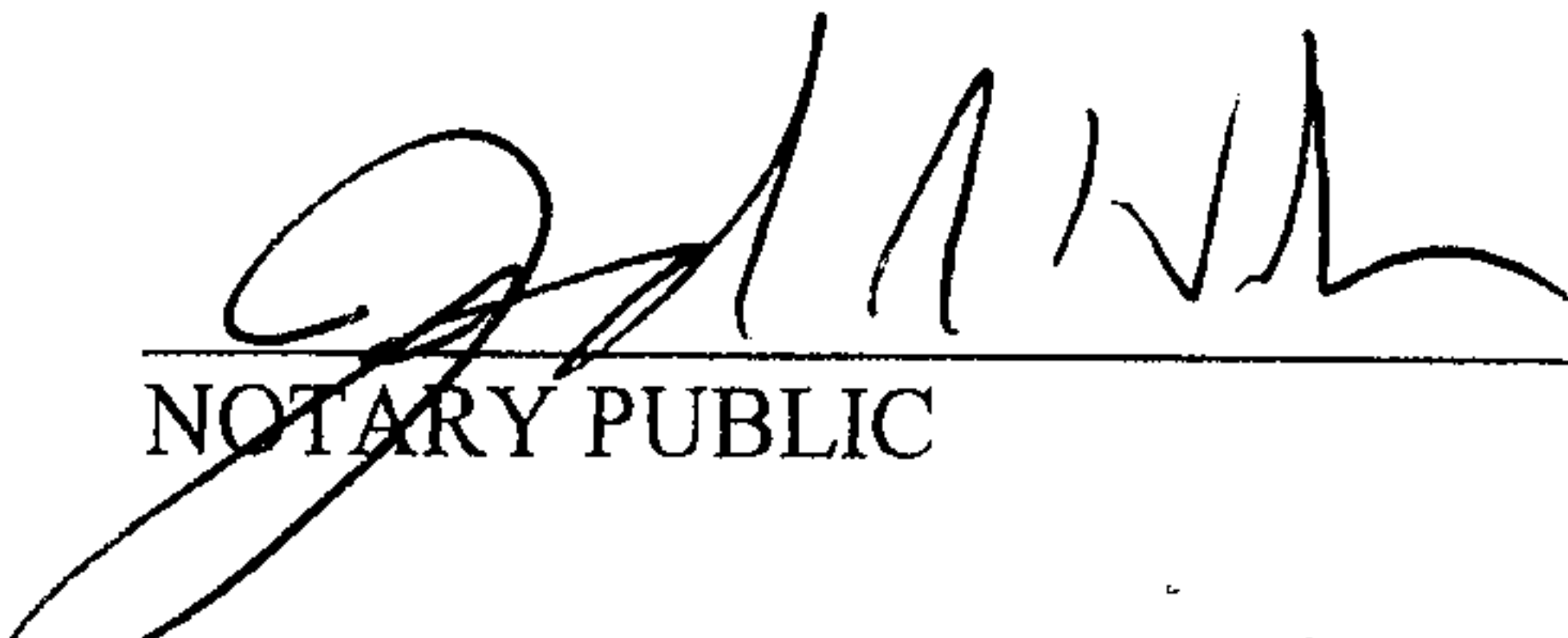

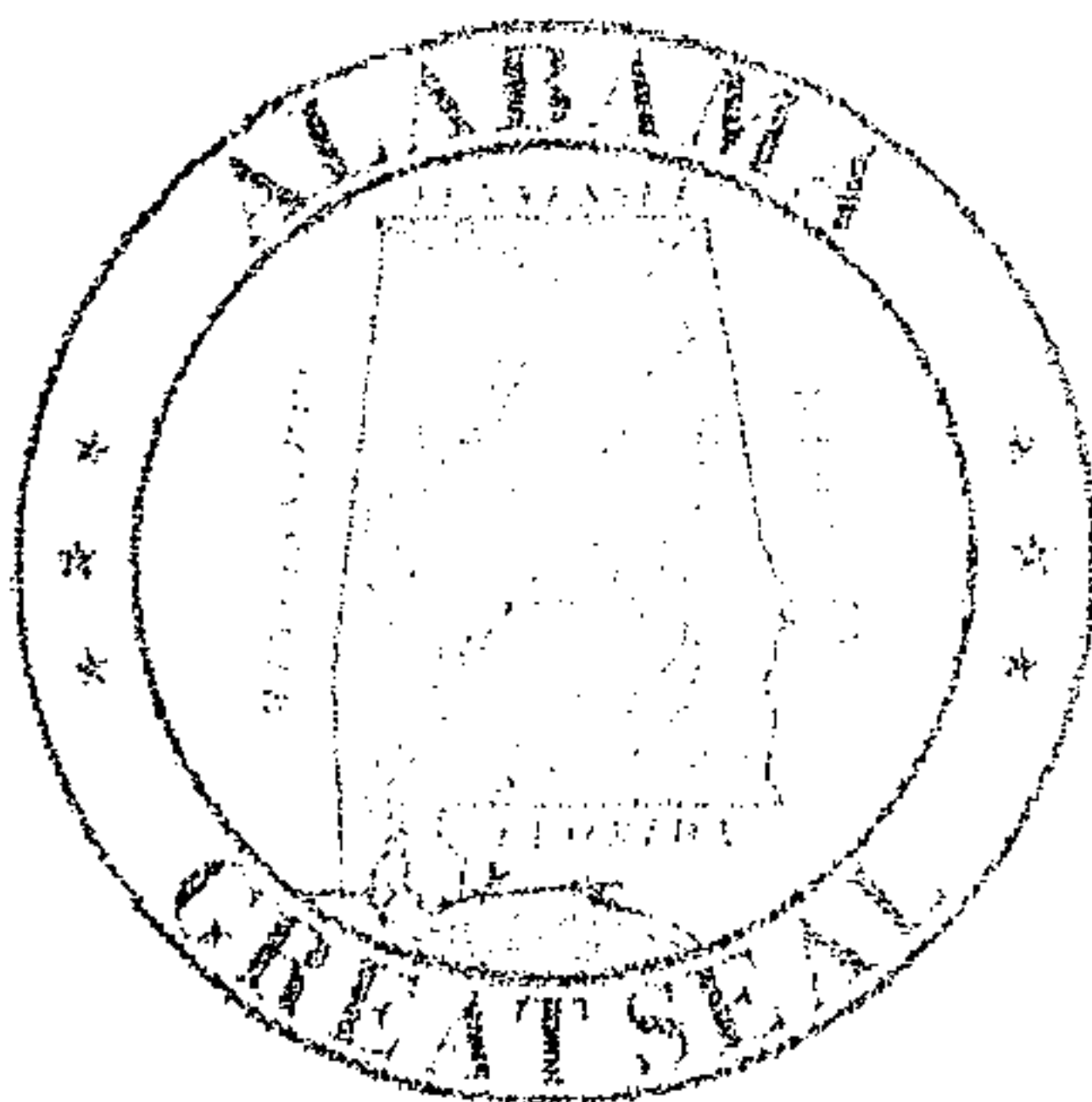
