**DISCLAIMER OF INTEREST**

I, the undersigned, CHRISTINE COOPER KILLION, being a surviving spouse of WAYNE WORDEN KILLION (hereinafter sometimes referred to as "Decedent"), do by this instrument definitely, finally and irrevocably renounce and disclaim certain interests in property and trust as described herein.

**I. DISCLAIMER OF BENEFICIAL INTERESTS UNDER WILL**

1. I finally and irrevocably disclaim all of my interest, whether present beneficial interest, contingent remainder, or otherwise, in "Trust Estate u/w/o WAYNE WORDEN KILLION " the terms of which are found in Item VII of the Last Will and Testament of WAYNE WORDEN KILLION dated February 1, 2012, which document constitutes the Last Will and Testament of my deceased husband, and was admitted to probate in the above entitled estate proceeding in the Probate Court of Shelby County, Alabama (hereinafter referred to as the "Will").
2. I recognize that as a result of this disclaimer, under the terms of the Will, said Trust Estate that I am disclaiming will be held in trust for my son, Wayne W. Killion, Jr. and administered under Item IX of the Will, which is entitled "GST Exempt Trust."

**II. DISCLAIMER OF POWERS AND OTHER RIGHTS**

1. I do hereby disclaim the limited power of appointment granted to me under Item VII, paragraph (a) of Decedent's Will as such power applies to the Trust Estate u/w/o WAYNE WORDEN KILLION.
2. I do hereby disclaim the right to redesignate successor trustees under Item XVIII of Decedent's Will as such right applies to the Trust Estate u/w/o WAYNE WORDEN KILLION.
3. In addition, I hereby disclaim any other right or power over all property and interests in property disclaimed herein, the retention of which would operate to cause this disclaimer to fail to constitute a qualified disclaimer under Sections

2046 and 2518 of the Internal Revenue Code of 1986, as amended, or Sections 43-8-290, et. seq., of the Code of Alabama (1975), as amended.


### III. MISCELLANEOUS

1. It is my intention with respect to the above disclaimed property to comply with the requirements of Sections 43-8-290, et. seq., of the Code of Alabama (1975), as amended, and the requirements for a qualified disclaimer under Sections 2046 and 2518 of the Internal Revenue Code of 1986, as amended. Any provision that is not stated herein, but which is required for this disclaimer to constitute a qualified disclaimer under the provisions of the Internal Revenue Code or the Code of Alabama shall be considered a part of this disclaimer and is hereby incorporated into its terms.
2. I do hereby affirm that I have not accepted any interest in or benefit from the property hereby disclaimed and renounced, and that I have not received and will not receive any consideration in money or money's worth for making this disclaimer. I affirm that I have not directed and will not direct the passing, disposition or transfer of the property hereinabove disclaimed.
3. I confirm that a copy of this disclaimer is being hand delivered to the personal representative of the estate of WAYNE WORDEN KILLION within nine months of the date of his death, which was March 31, 2013. This disclaimer is also being filed of record in the probate proceedings in Jefferson County, Alabama.
4. I specifically do not disclaim the marital devise directed to me, outright, in Item V of the Will of WAYNE WORDEN KILLION, entitled "Marital Devise".


