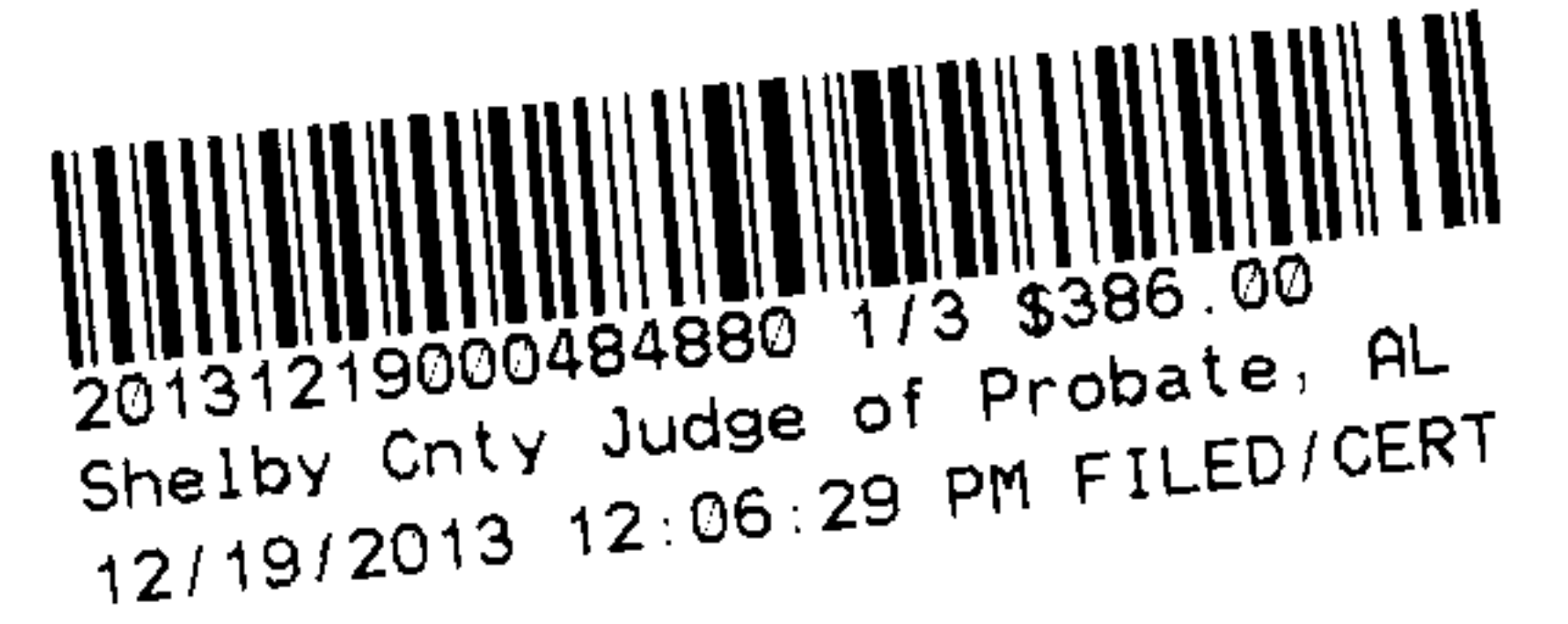

Know all men by these presents that in consideration of Ten Dollars and other good and valuable consideration to the undersigned grantor, in hand paid by the grantee herein, the receipt and sufficiency whereof is acknowledged, we, **Warren C. Dickerson and Mina L. Dickerson**, husband and wife (herein referred to as Grantor), who certify that the property conveyed hereby constitutes our homestead, grant, bargain, sell and convey unto **Warren C. Dickerson and Mina L. Dickerson, Trustees of the Warren C. Dickerson Revocable Trust dated April 9, 2001, and any amendments thereto** (herein referred to as Grantee), as tenants in common, the real estate described below situated in Shelby County, Alabama, to wit:

Lot 1135, according to the Map of Highland Lakes, 11th sector, an Eddleman Community, as recorded in Map Book 27, Page 84, A, B, C and D, in the Probate Office of Shelby County, Alabama, being situated in Shelby County, Alabama.

To have and to hold to the said grantee, as tenants in common, their heirs and assigns in fee simple, forever.

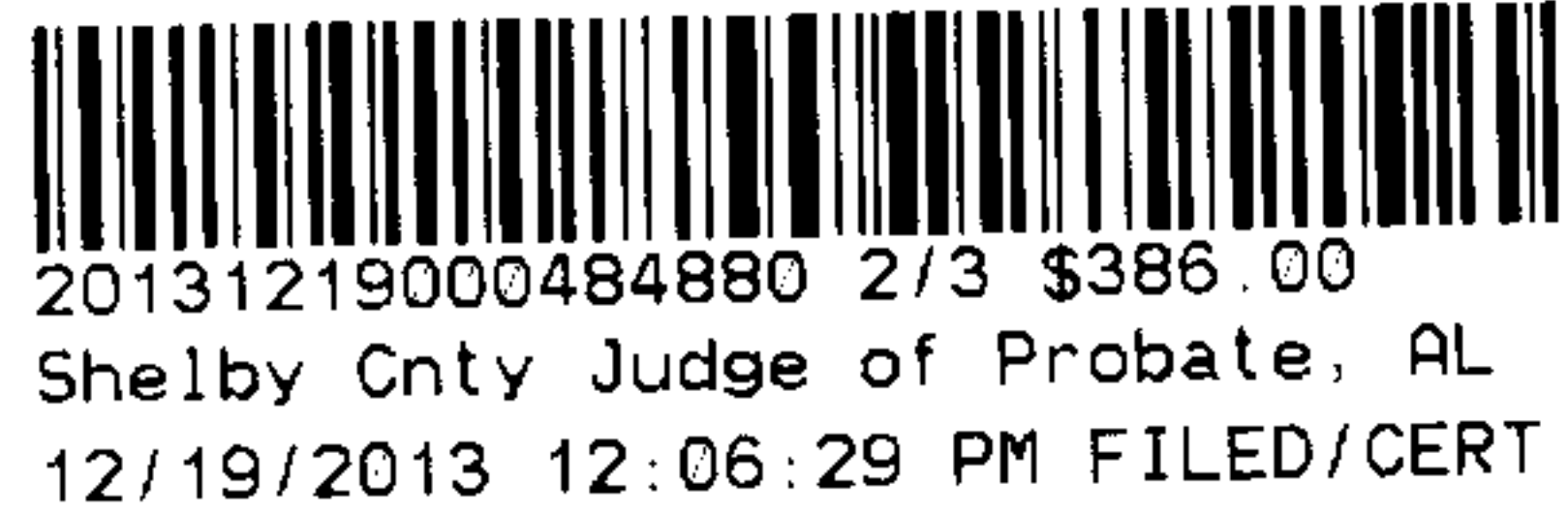
Subject to: Restrictions, Conditions, Covenants, Rights, Rights of Way, Mortgages, and easements now of record, if any.

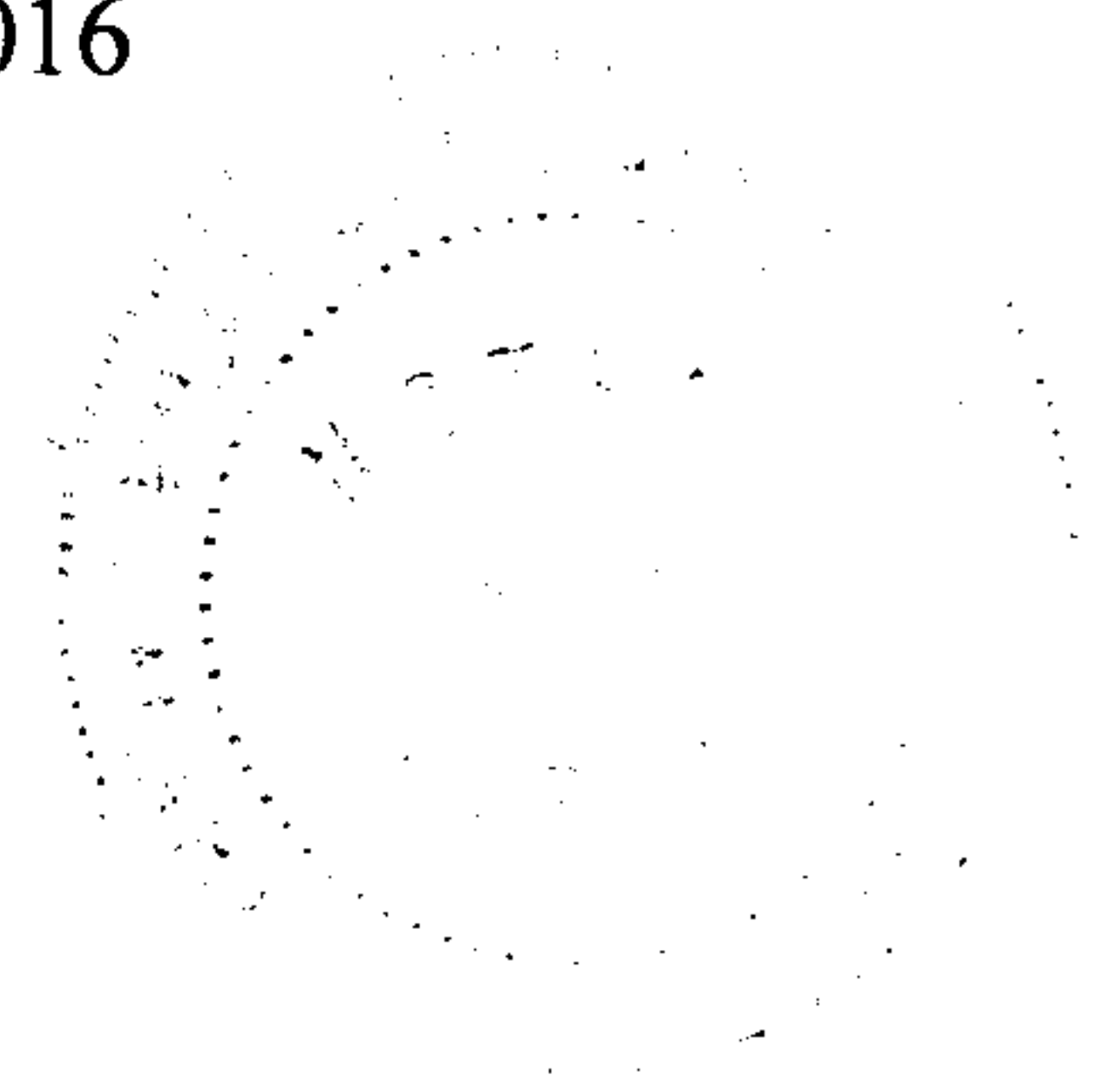
