(herein referred to as GRANTEE, whether one or more), the following described real estate situated in SHELBY County, Alabama, to-wit:

**Lot 4-22, according to the Survey of Chelsea Park 4th Sector, as recorded in Map Book 34, pages 147A and 147B, in the Probate Office of Shelby County, Alabama.**

\$234,693.00 of the consideration was paid from a mortgage loan closed simultaneously herewith.

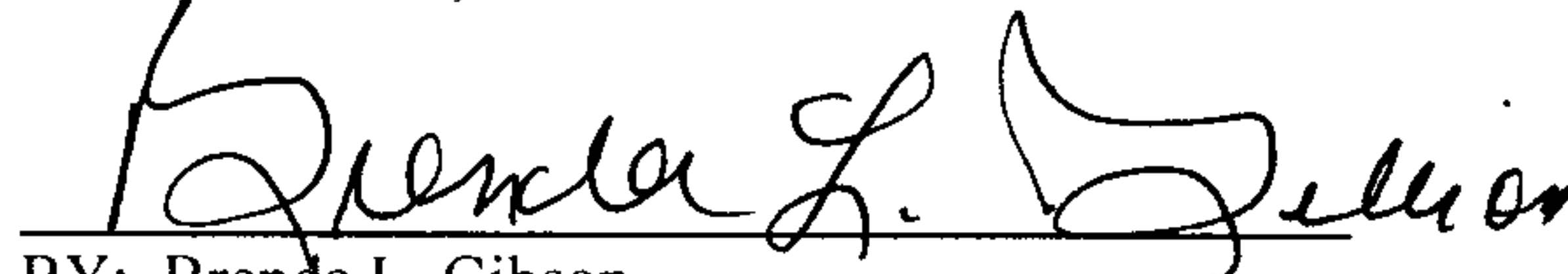
**TO HAVE AND TO HOLD**, unto the said GRANTEE, her/his heirs and assigns forever.

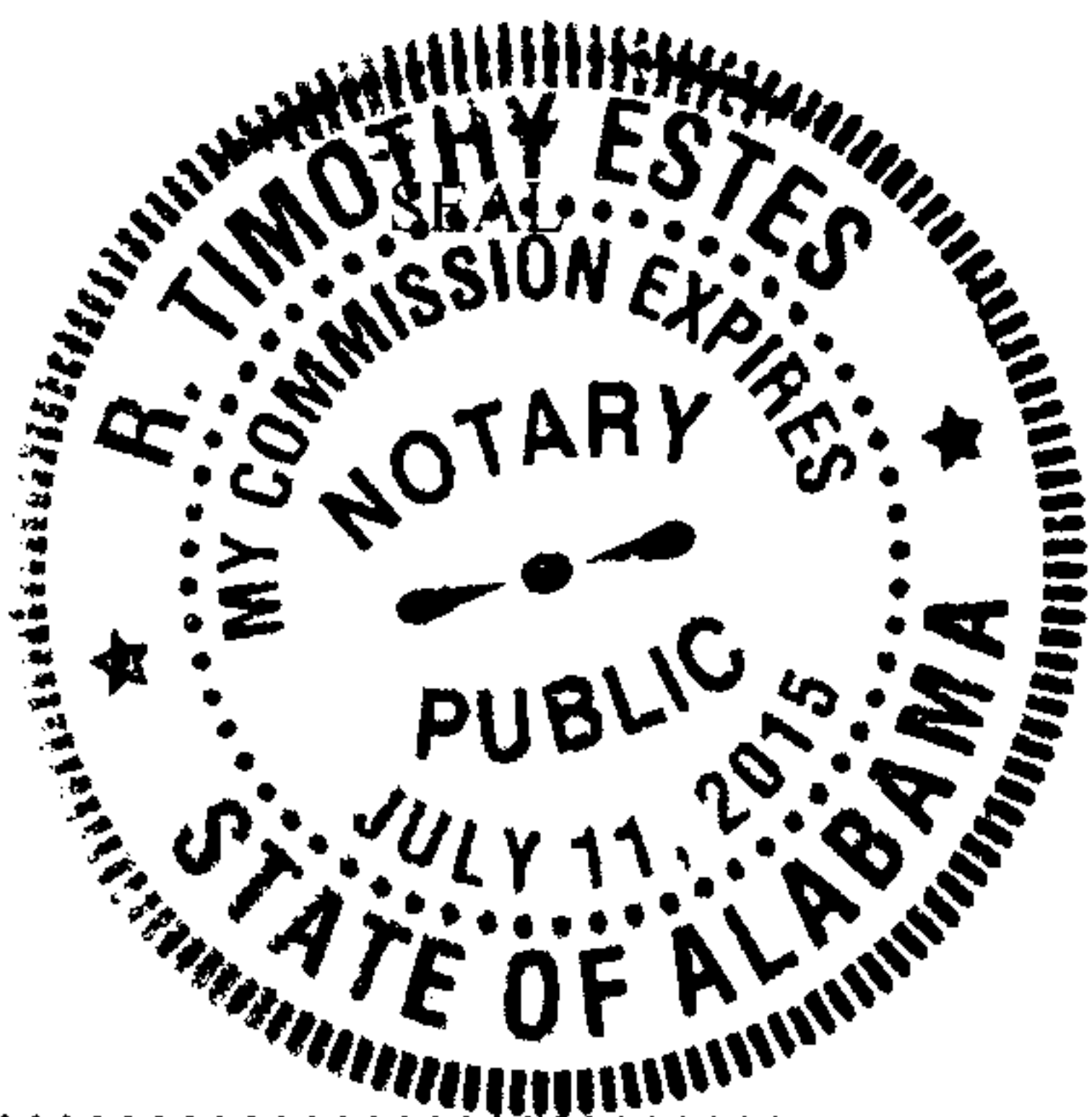
