

**WARRANTY DEED**  
**Joint Tenants With Right of Survivorship**

KNOW ALL MEN BY THESE PRESENTS:

That in consideration of **Two Hundred Ten Thousand and 00/100 Dollars (\$210,000.00)** and other good and valuable consideration paid in hand by the GRANTEES herein to the undersigned GRANTORS, the receipt whereof is acknowledged,

**David Marcus Curles and Toni Edmondson Curles, Husband and Wife**

(herein referred to as GRANTORS, whether one or more) does, grant, bargain, sell and convey unto

**Melissa M. Wilson and Marc B. Wilson**

(herein referred to as GRANTEE, whether one or more), the following described real estate situated in **Shelby** County, Alabama, to-wit:

**Lot 15, according to the Survey of Calumet Meadow, as recorded in Map Book 21, Page 112, in the Probate Office of Shelby County, Alabama.**

Mineral and mining rights excepted. Subject to current taxes, easements, covenants, conditions and restrictions of record.

\$168,000.00 of the consideration was paid from a mortgage loan closed simultaneously herewith.


