

FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on February 15, 2007, to-wit: Carolyn Holsomback and Tomie Lee Holsomback, wife and husband, executed a mortgage to Mortgage Electronic Registration Systems, Inc., solely as nominee for New South Federal Savings Bank, its successors and assigns, herein called the Mortgagee, which said mortgage was recorded on March 1, 2007, in Document Number 20070301000092870, in the Office of the Judge of Probate, Shelby County, Alabama, which conveyed the property hereinafter described to secure the indebtedness evidenced by a note, payable in installments, therein described; which mortgage and the indebtedness secured thereby was subsequently assigned to Green Tree Servicing LLC, by assignment recorded September 6, 2013, and recorded in Instrument Number 20130906000364470, of said Probate Court records; and
