**KNOW ALL MEN BY THESE PRESENTS**, That in consideration of **Three Hundred One Thousand One Hundred Seventy Four Dollars and No Cents (\$301,174.00)** and other good and valuable consideration the receipt and sufficiency whereof is hereby acknowledged, **Harris Doyle Homes, Inc.** (herein referred to as GRANTOR) does by these presents grant, bargain, sell and convey unto William S. Cannon and Jessica P. Cannon (herein referred to as GRANTEE, whether one or more) as joint tenants with right of survivorship, the following described real estate situated in **Shelby** County, Alabama, to-wit:
