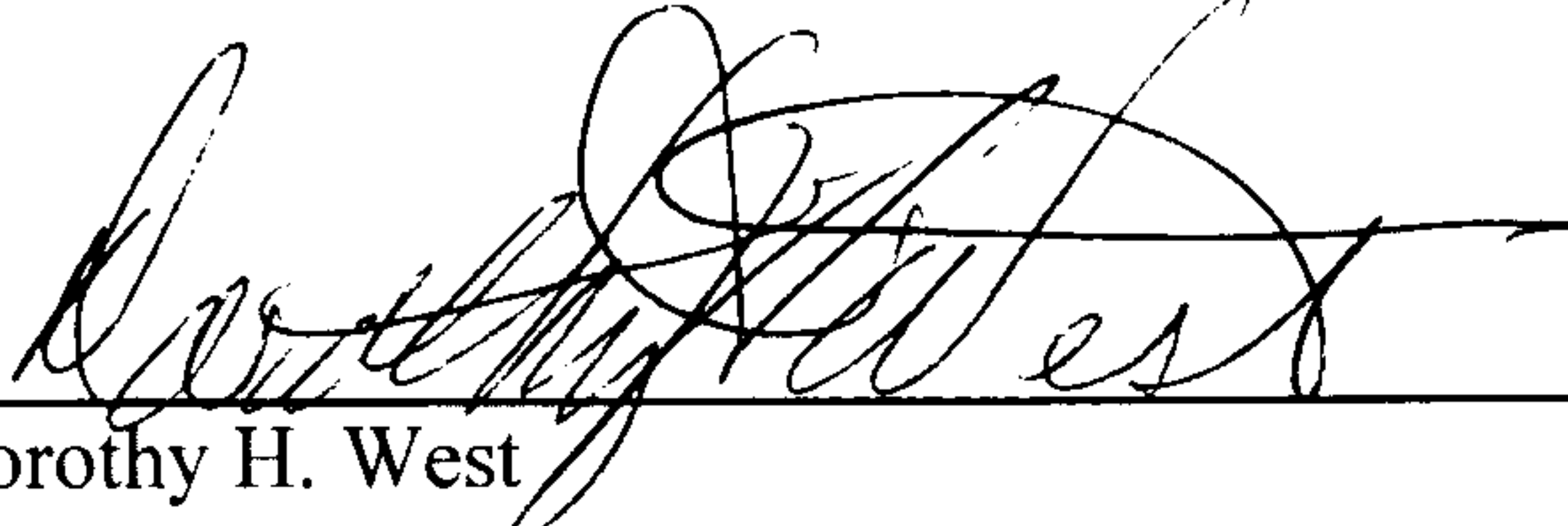
**ARTICLES OF ORGANIZATION
OF
4D WEST, LLC**

1. The name of the limited liability company is 4D WEST, LLC.
2. The limited liability company will have perpetual existence.
3. The purpose of the LCC is to own, purchase, sell and manage real property.
4. The address of its initial registered office in the State of Alabama is 164 Moss Bend Drive, Helena, Alabama 35080.

6. This Articles of Organization will be effective on filing.

8. The Company is to be managed by one or more members. Each initial member will serve as a managing member until the first annual meeting of the members or until their successor is elected and qualified. The initial member that shall manage the Company is identified as follows:

9. Members of the Company have the right to admit new members on majority written consent of the existing members. The existing members shall determine the amount and nature of contributions by new members at the time the new members are admitted.
