

#### CERTIFICATE OF FORMATION

- II. DURATION. The duration of the Company shall be perpetual.
- III. <u>PURPOSE</u>. The purpose of the Company is to acquire and own real estate, and any and all other lawful purposes.

Code</u> § 10A-5-3.02 or other applicable law, the members of the Company shall not be liable under a judgment, decree, or court order, or in any other manner, for a debt, obligation, or liability of the Company, whether arising in contract, tort, or otherwise, or for the acts or omissions of any other member, manager, agent, or employee of Company.
- VIII. <u>CONTINUATION OF BUSINESS UPON DISSOCIATION OF A MEMBER</u>. If a member of the Company becomes dissociated from the Company, pursuant to this Certificate, the Operating Agreement, or by operation of law, the Company's affairs shall be wound up, and the Company dissolved, unless the remaining members submit their

unanimous written consent within ninety (90) days of dissociation, and there exists at least one remaining member.


