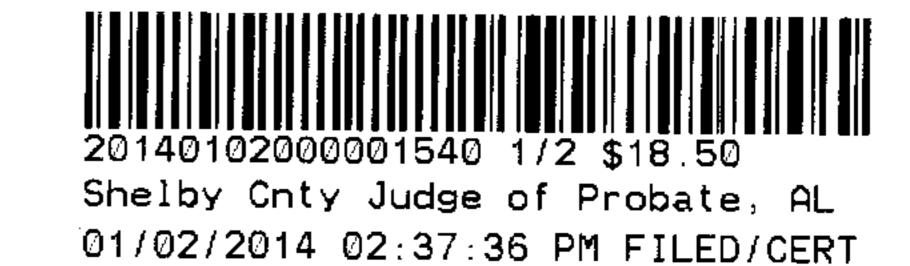

## JOINT SURVIVORSHIP DEED

Baumgartner, a unmarried person, (hereinafter referred to as GRANTORS), the receipt whereof is hereby acknowledged, the GRANTORS do hereby give, grant, bargain, sell and convey unto the GRANTEES, William Kyle Mullins and Whitney Burch Mullins, (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of Shelby, State of Alabama, to-wit:

Lot 3, in Block 3, according to the Survey of Arden Subdivision to the Town of Montevallo, as recorded in Map Book 3, Page 64 in the Probate Office of Shelby County, Alabama.
