SHELBY COUNTY

That in consideration of One Hundred Fourteen Thousand Nine Hundred dollars and Zero cents (\$114,900.00) to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we, Victoria L. Calender, a Single woman (herein referred to as grantors) do grant, bargain, sell and convey unto Kevin D. Mauffray and Bridget Mauffray (herein referred to as GRANTEES) as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama to-wit:

Lot 15, according to the Amended Map of Savannah Pointe, Sector IX, as recorded in Map Book 37, Page 51 A & B, in the Probate Office of Shelby County, Alabama.

Subject to taxes for 2014 and subsequent years, easements, restrictions, rights of way, and permits of record.

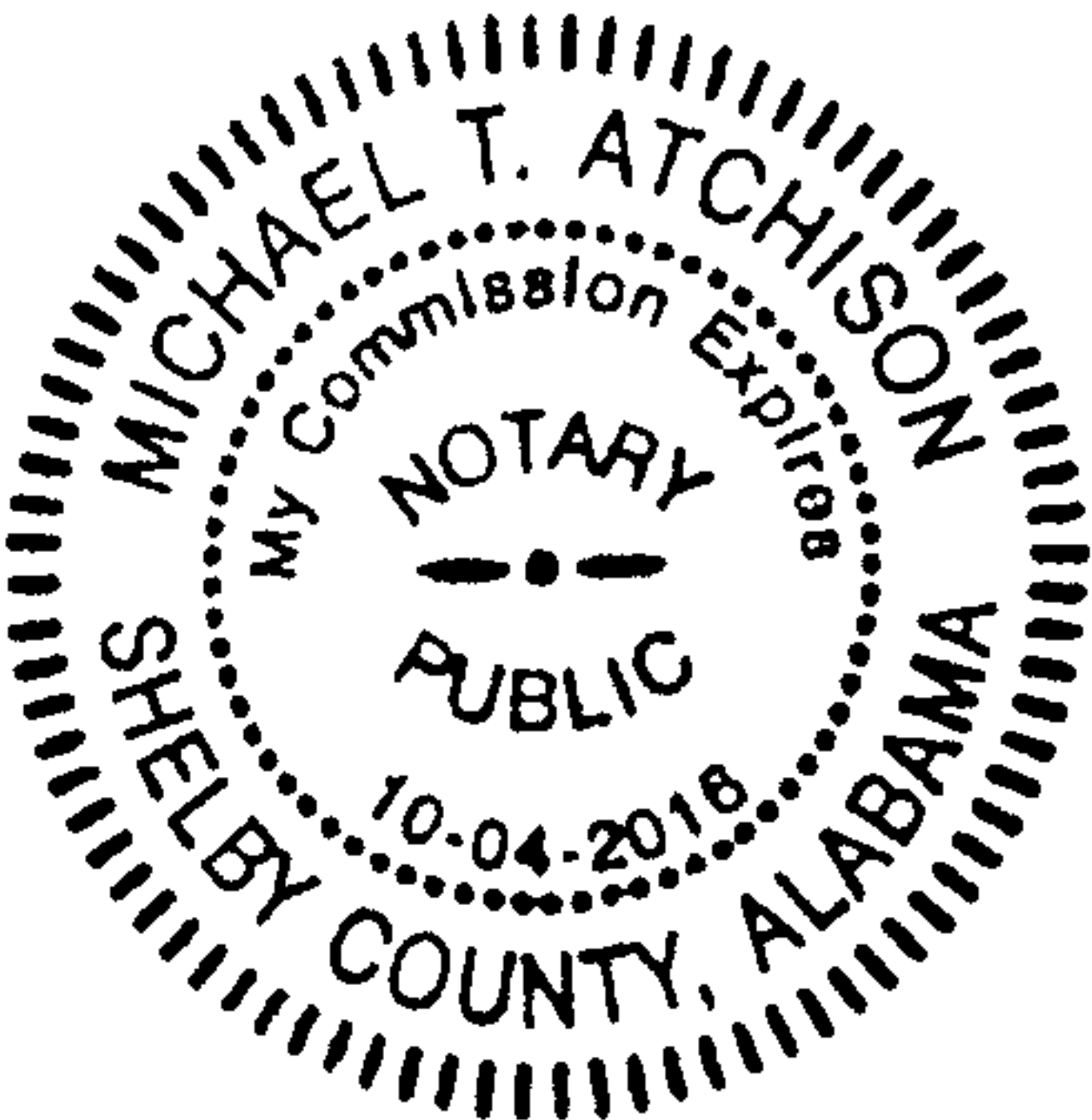
