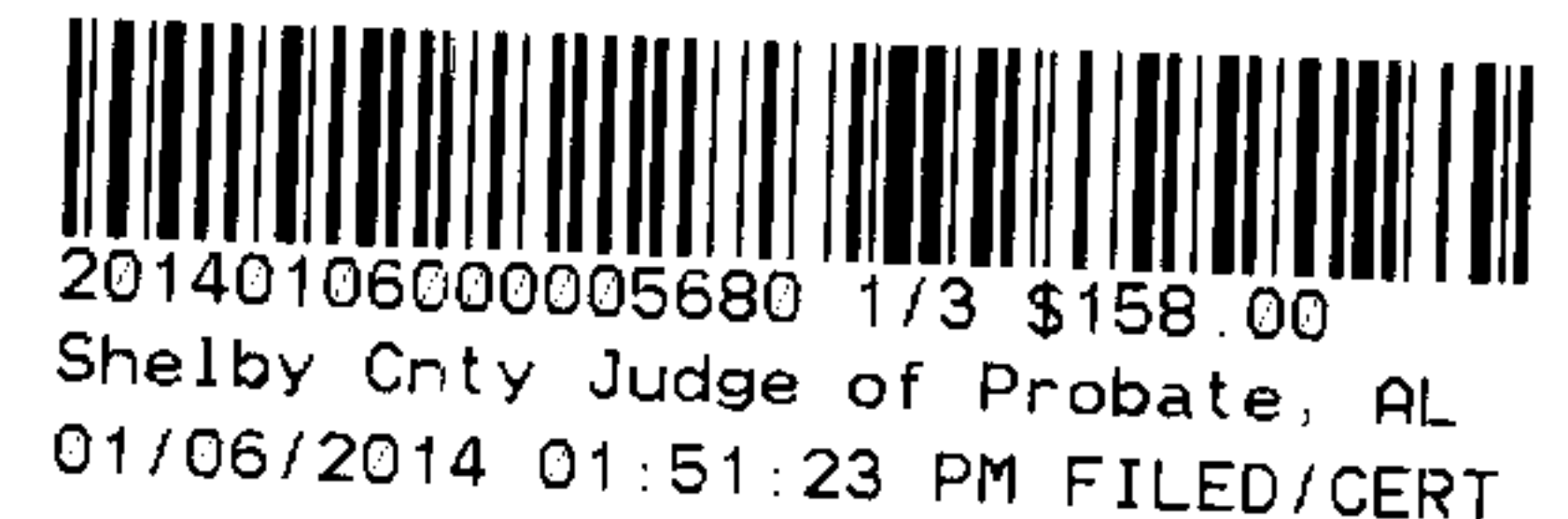

**ARTICLES OF ORGANIZATION
OF
DREAM SEAMS, LLC**

The undersigned, desiring to form a limited liability company pursuant to the laws of the State of Alabama, certify as follows:

1. **Name.** The name of the entity is Dream Seams, LLC.
2. **Type of Entity.** The type of entity being formed is a limited liability company.
3. **Purpose.** The purpose for which this limited liability company is organized is to engage in the retail and wholesale fabric and clothing business, and in the transaction of any and all lawful business for which limited liability companies may be organized under the laws of the State of Alabama.
4. **Duration.** The existence of the limited liability company shall commence on the date of the filing of these Articles of Organization in the office of the Judge of Probate of Shelby County, Alabama, and its duration shall be perpetual; provided, however, that the limited liability company shall be dissolved (a) upon the written consent of all of the members, (b) as provided in the Operating Agreement, or (c) as may be required by the Alabama Limited Liability Company Law.




8. **Admission of Additional Members.** The members of the limited liability company shall have the right to admit additional members to the limited liability company, as provided in the Operating Agreement.
