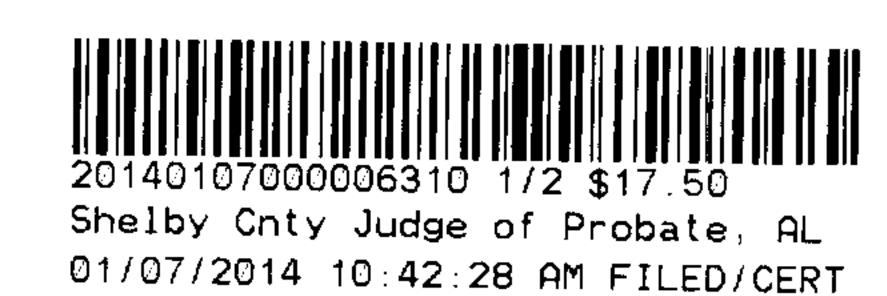

EASEMENT FOR INGRESS AND EGRESS

Tew (hereinafter referred to as Grantors) and Larry W. Tew and wife, Cynthia Tew (hereinafter referred to as Grantees).

NOW, THEREFORE, in the consideration of the sum of TEN AND NO/100 (\$10.00) DOLLARS and the mutual covenants and obligations set forth herein, Larry A. Tew and wife, Nancy L. Tew and Michael Allen Tew and wife, Amelia L. Tew the Grantors, hereby grant and convey unto the Grantee, Larry W. Tew and wife, Cynthia Tew, their heirs and assigns, an easement across the following described property of Grantor located in Shelby County, Alabama:

Commence at the NW corner of the NE $\frac{1}{4}$ of the SE $\frac{1}{4}$; thence run S 89° 10' 48" W along the North line of said $\frac{1}{4}$ - $\frac{1}{4}$ for 7.50' to the point of beginning of a 15' easement for ingress and egress lying 7.50' on either side of the following described centerline; thence run S 0° 35' 52" E along the East line of said NE $\frac{1}{4}$ of the SE $\frac{1}{4}$ of said Section for 105' more or less to the Northwesterly right of way line of Shelby County Highway No. 4 and the end of said easement.

The said easement is given for, and shall be used for the purpose of providing ingress and egress across grantors property. The parties hereto agree not to erect or permit the erection of any building or structure on said right of way that would interfere with said parties' right to use the easement.

This agreement shall be binding on, and shall inure to the benefit of, the heirs executors, administrators, successors and assigns of the parties hereto.
