Pursuant to the Provisions of Section 10-12-1 and Section 10-12-45, *et seq.* of the Code of Alabama (1975), the undersigned hereby adopt the following Limited Liability Company Articles of Organization.

ARTICLE I

Name

The name of the limited liability company is **EL.EN COLLECTION, LLC.**, (the “Company”).

ARTICLE II

Duration

The existence of the Company shall commence on the date of filing of these Articles of Organization in the Office of the Judge of Probate of Shelby County, Alabama, and its duration shall be perpetual; provided, however, that the Company shall be dissolved (a) upon the written consent of all the members; (b) as provided in the Operating Agreement; or (c) as may be required by the Alabama Limited Liability Company Act.

ARTICLE III

Purpose

The purpose for which the Company is organized is to engage in the transaction of any and all lawful business for which Limited Liability Companies may be organized under the laws of the State of Alabama, more specifically, to operate a wholesale and retail jewelry business.

ARTICLE IV

Registered Office; Registered Agent

Admission of New Members

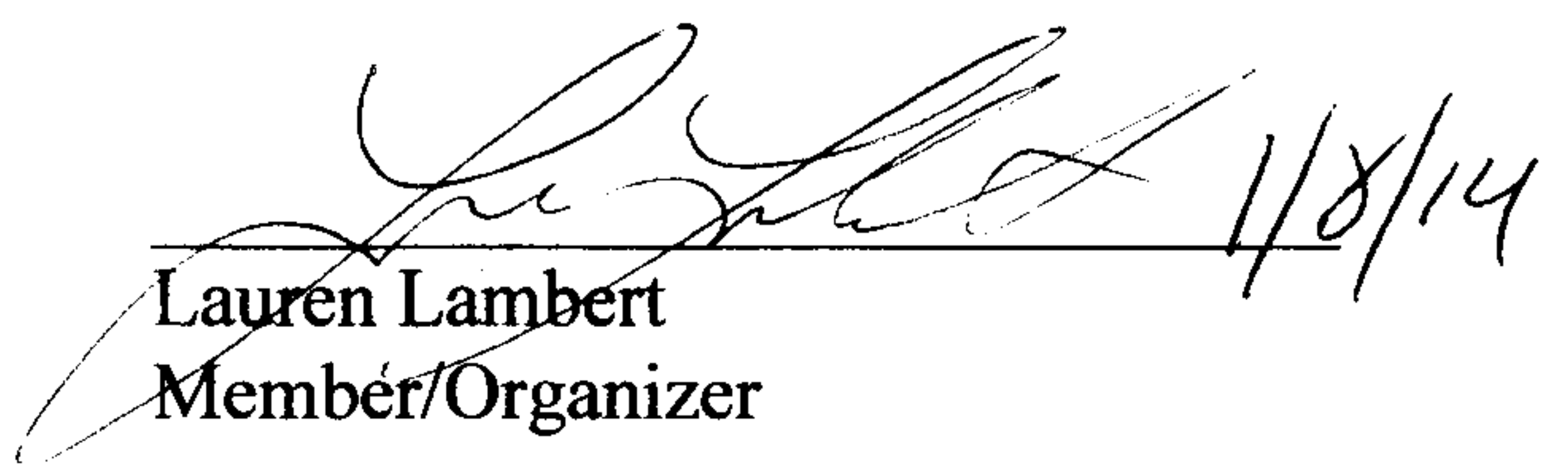
The members of the Limited Liability Company shall have the right to admit additional members to the Limited Liability Company, as provided in the Operating Agreement.
