Know All Men by These Presents: That in consideration of **One hundred sixty seven thousand and no/100 (\$167,000.00)**, to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Ronnie Sartain, as Conservator for The Estate of Elizabeth Lee Campbell, an incapacitated person, Tuscaloosa County, Alabama Case No. PC-2013-615** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Rodney Glenn Floyd and Sarah Jane Floyd** (herein referred to as grantee, as joint tenants of survivorship, whether one or more), the following described real estate, situated in **Shelby County, Alabama**, to-wit:

Lot 3, in Block 5, according to the Survey of Wooddale, Third Sector, as recorded in Map Book 5, Page 133, in the Office of the Judge of Probate of Shelby County, Alabama.

Subject to existing easements, restrictions, set-back lines, rights of way, limitations, if any of record.


\$172,511.00 of the purchase price recited above was paid from a purchase money mortgage loan closed simultaneously herewith.

To Have and to Hold to the said grantee, as joint tenants, with right of survivorship, their heirs and assigns forever; it being the intention of the parties to this conveyance, that (unless the joint tenancy created is severed or terminated during the joint lives of the grantees herein) in the event one grantee herein survives the other, the entire interest in fee simple shall pass to the surviving grantee, and, if one does not survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common.
