**FIRST AMENDMENT TO THE
CERTIFICATE OF FORMATION

3. **Name Change.** The Certificate, including, but not limited to Article One thereof, is hereby amended by deleting, in all instance, the name "DMJ Rentals, LLC" and by inserting, in its place, the name "Danny Jordan Properties, LLC".
4. **Continuation of Certificate.** Except as specifically amended herein, all of the terms and provisions contained in the Certificate of the Company are hereby confirmed, adopted, and ratified and shall remain in full force and effect.
5. **Recordation.** The Member of the Company hereby authorizes, approves, and directs that this Amendment be recorded in the Office of the Judge of Probate of Shelby County, Alabama, in the Office of the Secretary of State of the State of Alabama and in such other locations as are necessary or appropriate to give effect to the intention of this Amendment.

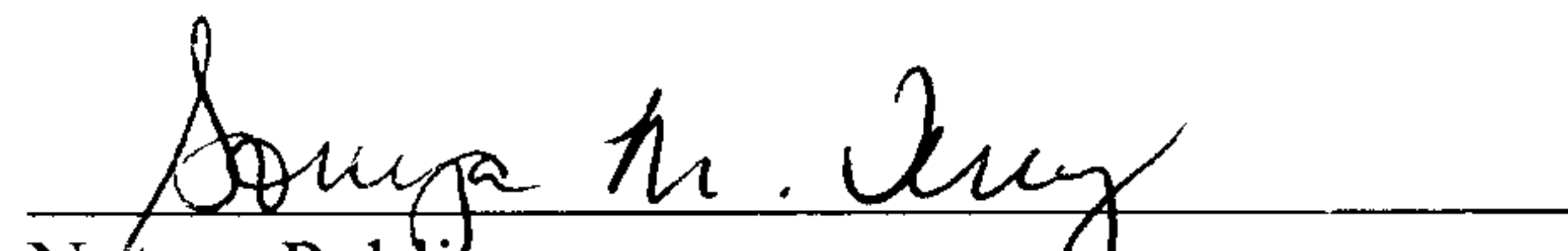
