### ASSIGNMENT OF LEASE

This Assignment of Lease (this "Agreement") is made effective as of OCTOBER 23, 2013, by and between CHARLES S. Assignor specifically reserves the right to collect any rental delinquent as of the date hereof.

2. **Assumption**. The Assignee hereby assumes all of the obligations of the Assignor as landlord under the Lease accruing subsequent to the date hereof, including, specifically, the obligation to account to all tenants for Security Deposits, if any, paid by such tenant to the Assignor, and the Assignee does hereby indemnify and hold the Assignor harmless from and against any and all such liabilities, claims or causes of action arising after the date hereof in connection with the Lease.

#### 3. Miscellaneous.

- (a) <u>Amendments</u>. No amendment, modification or cancellation of this Agreement shall be valid unless in writing and signed by all the parties hereto.
- (b) <u>Headings</u>. The Paragraph and Subparagraph headings hereof are inserted for convenience and reference only and shall not alter, define, or be used in construing the text of such Paragraphs or Subparagraphs.
- (c) <u>Meaning of Particular Terms</u>. Whenever used, the singular number shall include the plural and the plural the singular, and pronouns of one gender shall include all genders; and the words "Assignor" and "Assignee" shall include their respective heirs, personal representatives, successors and assigns.
- (d) Governing Law. This Agreement shall be governed by and construed and enforced in accordance with the substantive laws of the State of Alabama.
- (e) <u>Invalidity of Particular Provisions</u>.
