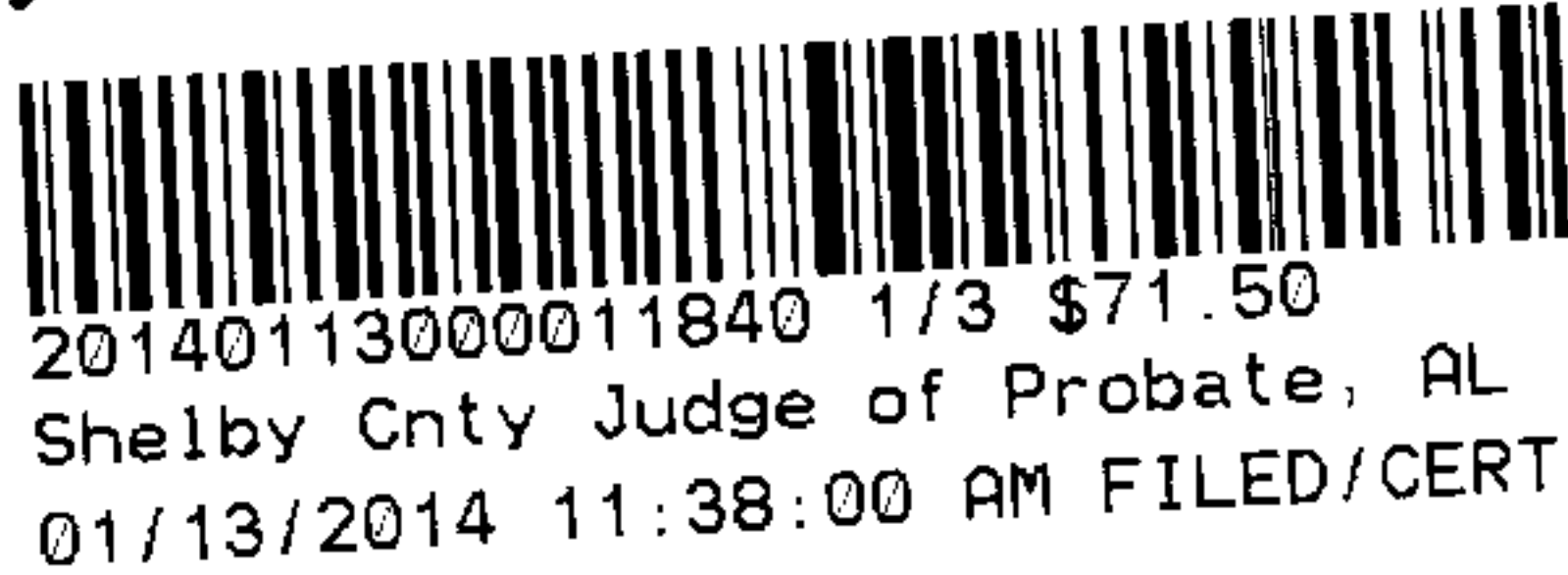

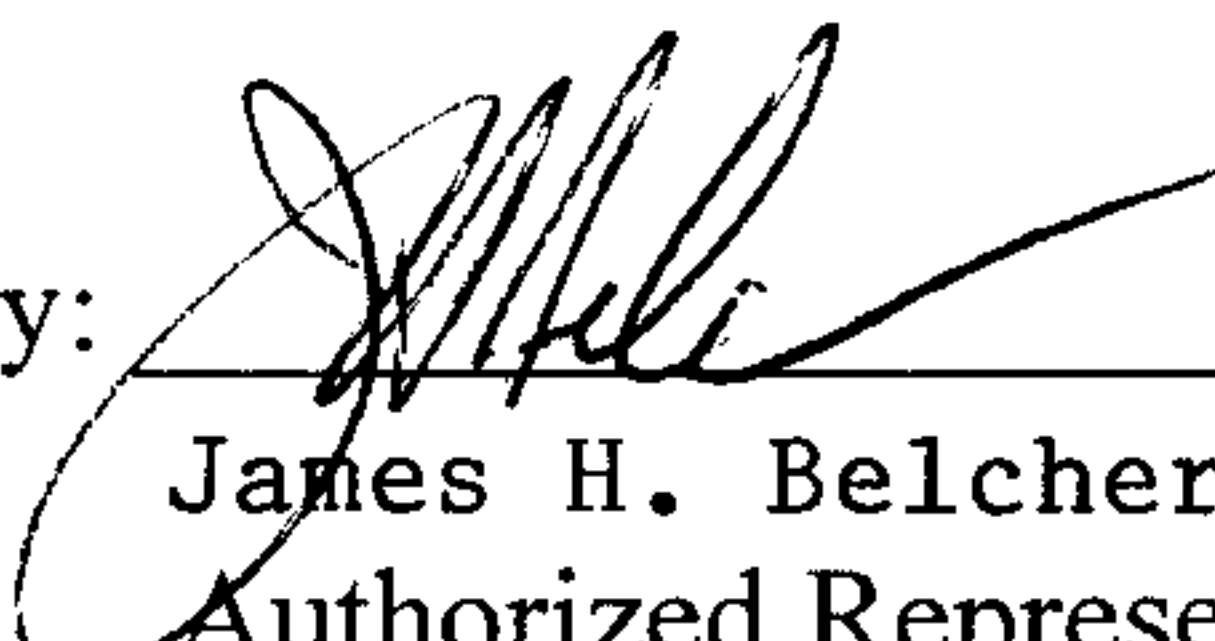
\$288,150 of the purchase price recited above has been paid from the proceeds of a mortgage

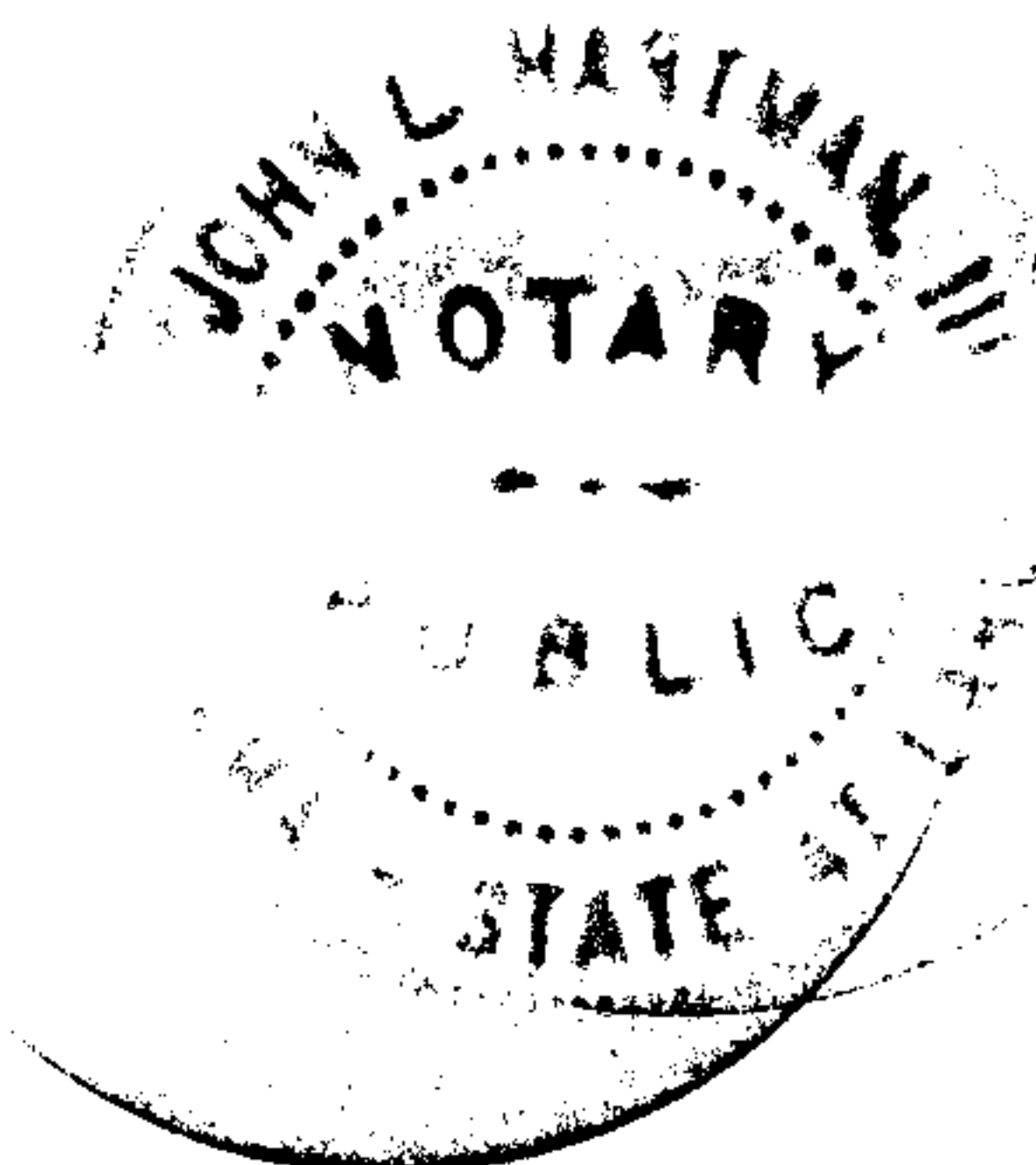

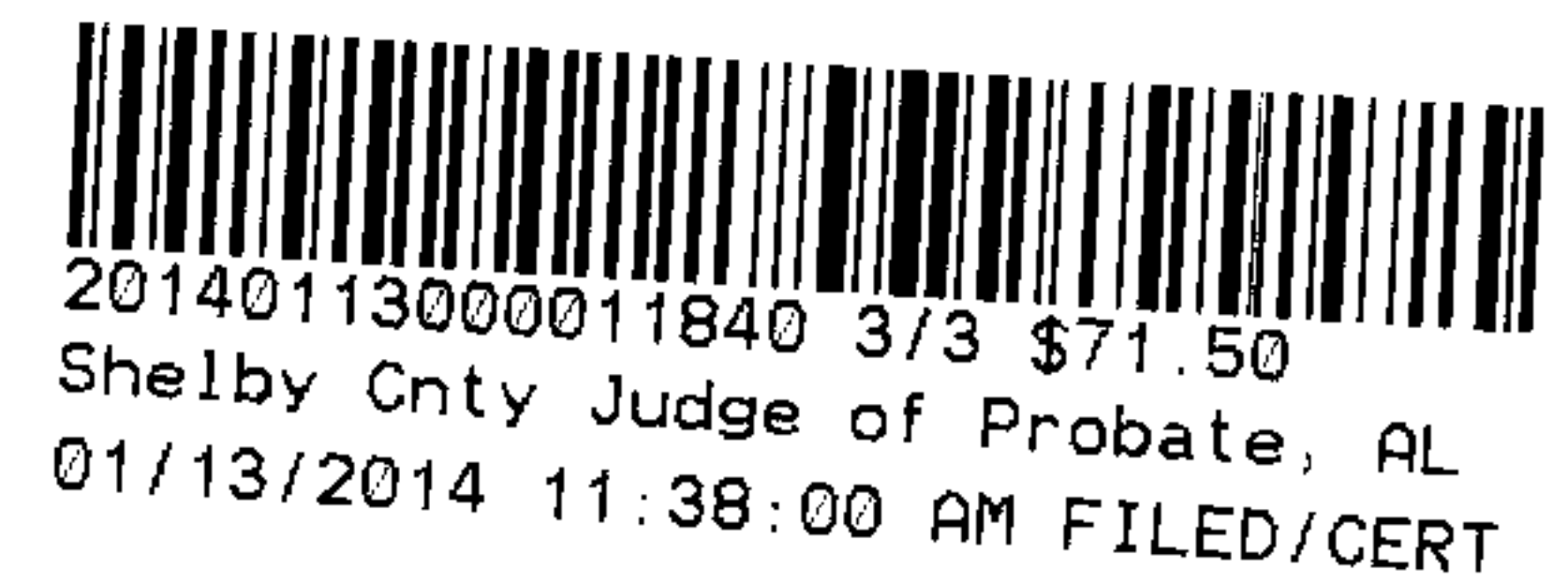
