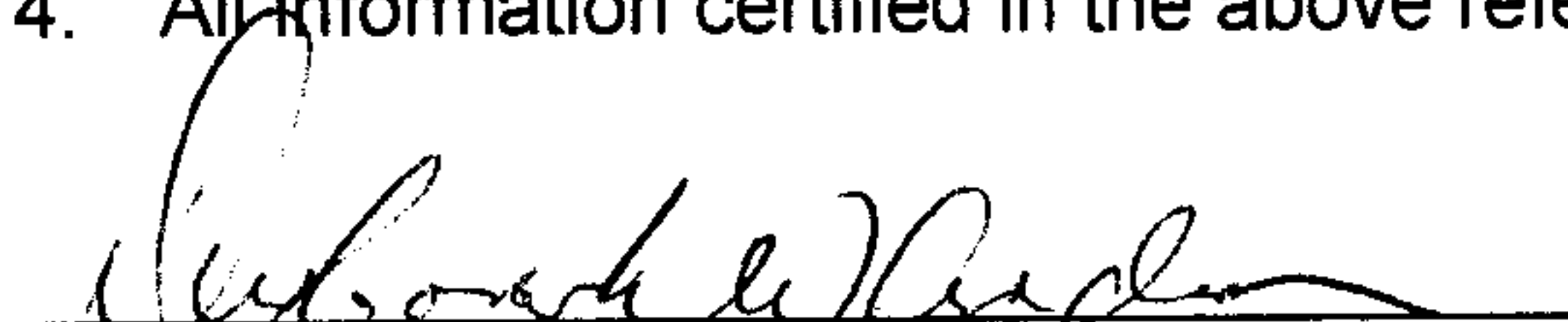


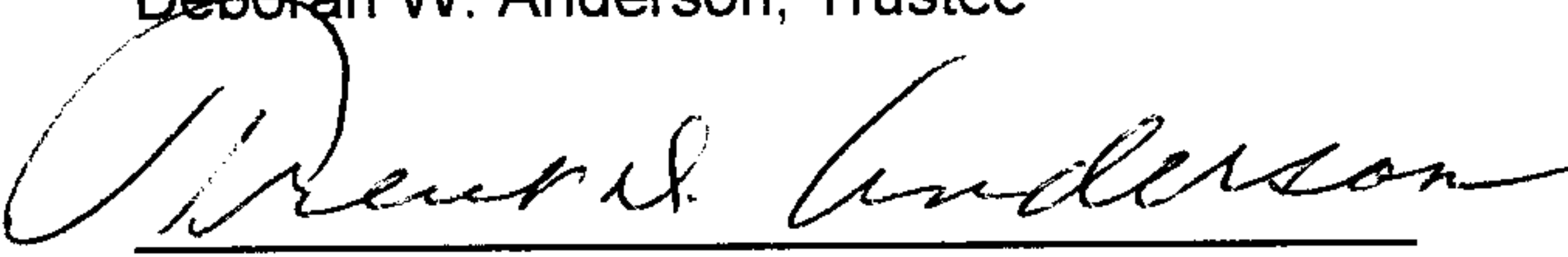

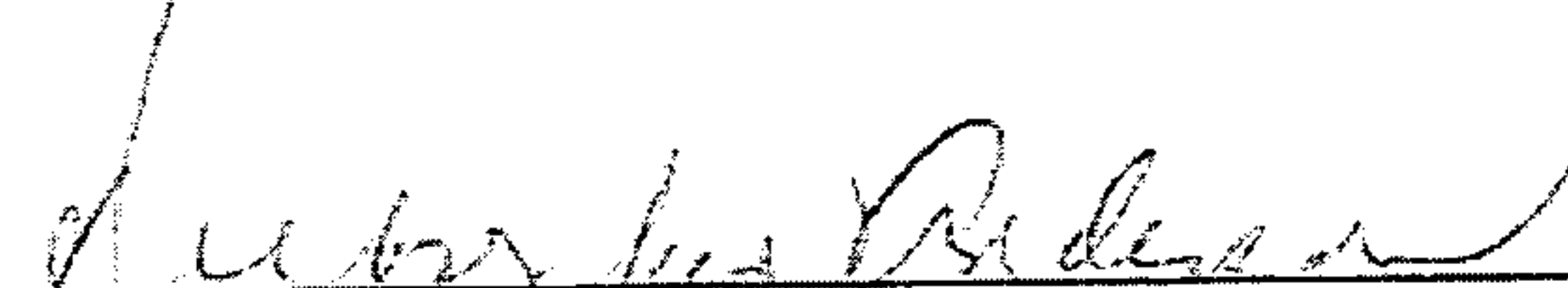

They do not modify the powers of the Trustees.

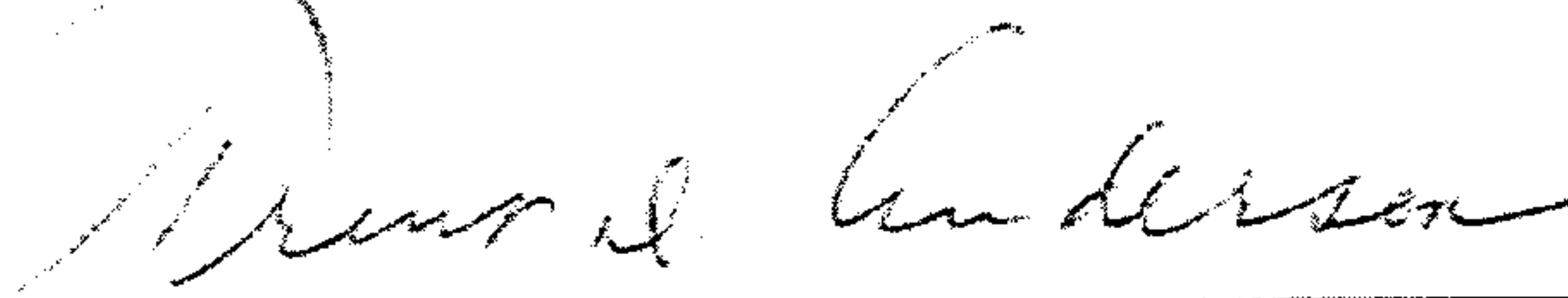

and correct, under penalty of perjury.

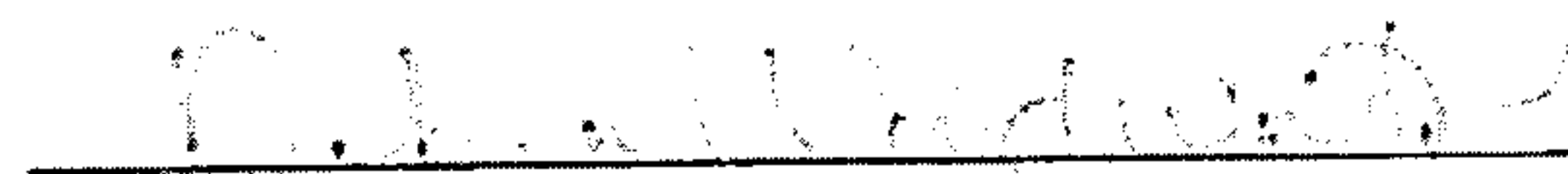

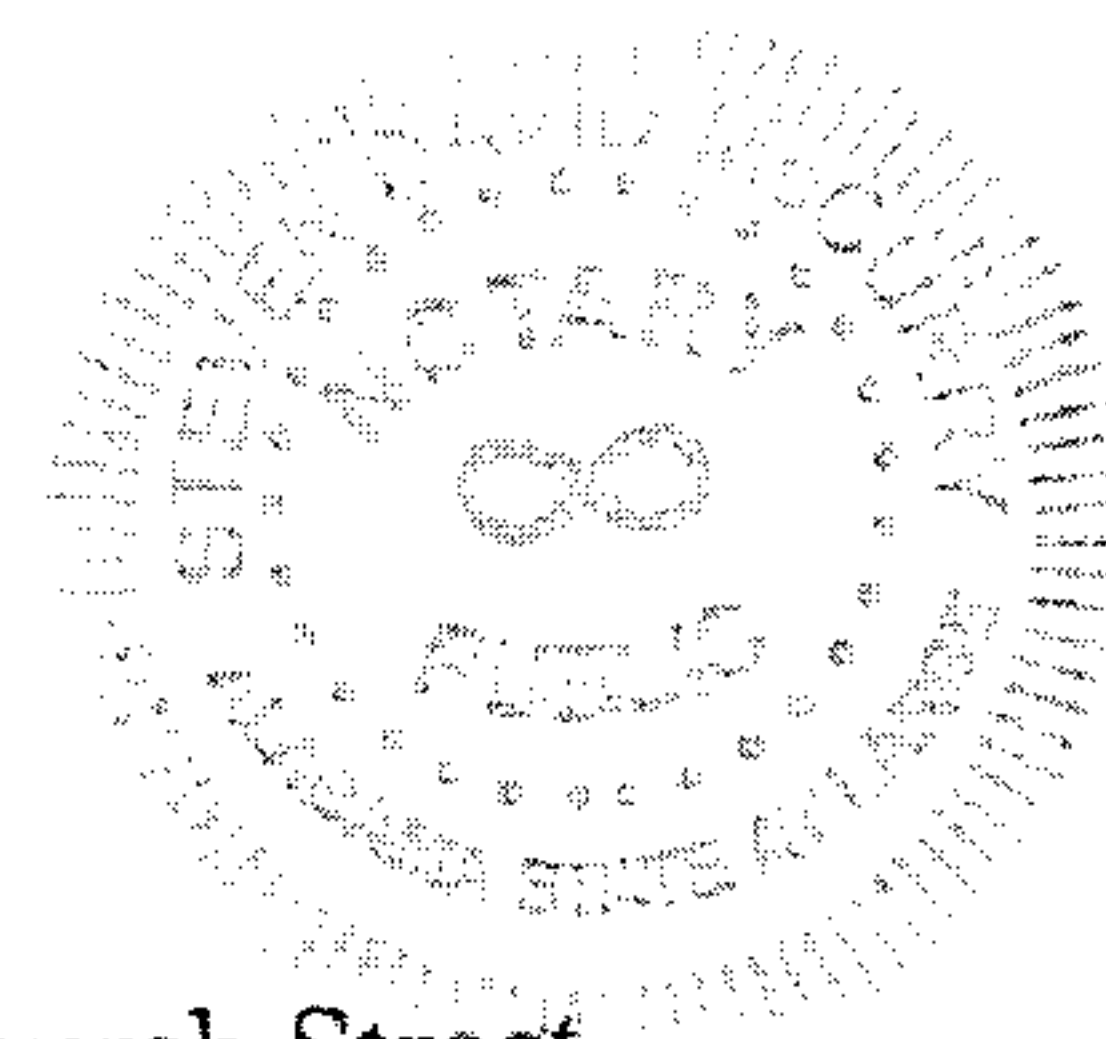
