

**ARTICLES OF ORGANIZATION**  
**OF**

The undersigned, for the purpose of forming a limited liability company under Alabama Code section 10A-5-2.01 (1975), as amended (the "Alabama Limited Liability Company Law"), hereby file the following Articles of Organization with the probate judge of the county in which the initial registered office of the limited liability company will be located and affirm that the facts stated in these Articles of Organization are true:

**ARTICLE I**

**NAME OF COMPANY:** The name of the limited liability company is **SMF CONSULTING, LLC** (the "Company").

**ARTICLE II**

**DURATION:** The period of duration of the Company shall be perpetual unless said Company is dissolved pursuant to the provisions of the laws of the State of Alabama or the Operating Agreement of the Company.

**ARTICLE III**

**PURPOSES:** The purposes for which the Company is organized is to engage in any and all businesses and activities permitted by the laws of the State of Alabama. The Company shall have all of the powers vested in a limited liability company organized and existing by virtue of such laws.

**ARTICLE IV**

**REGISTERED OFFICE AND AGENT FOR SERVICE OF PROCESS:** The location, street address and mailing address of the initial registered office of the Company shall be 422 Stonegate Drive, Birmingham, Alabama 35242. The name of the initial registered agent for service of process at the foregoing address shall be Susan Fitzpatrick Adams.

**INITIAL MEMBERS:** The names and mailing addresses of the initial members of the Company are as follows:




**ARTICLE XI**
