ARTICLE IV - Officers: Section 12. Power of Attorney.

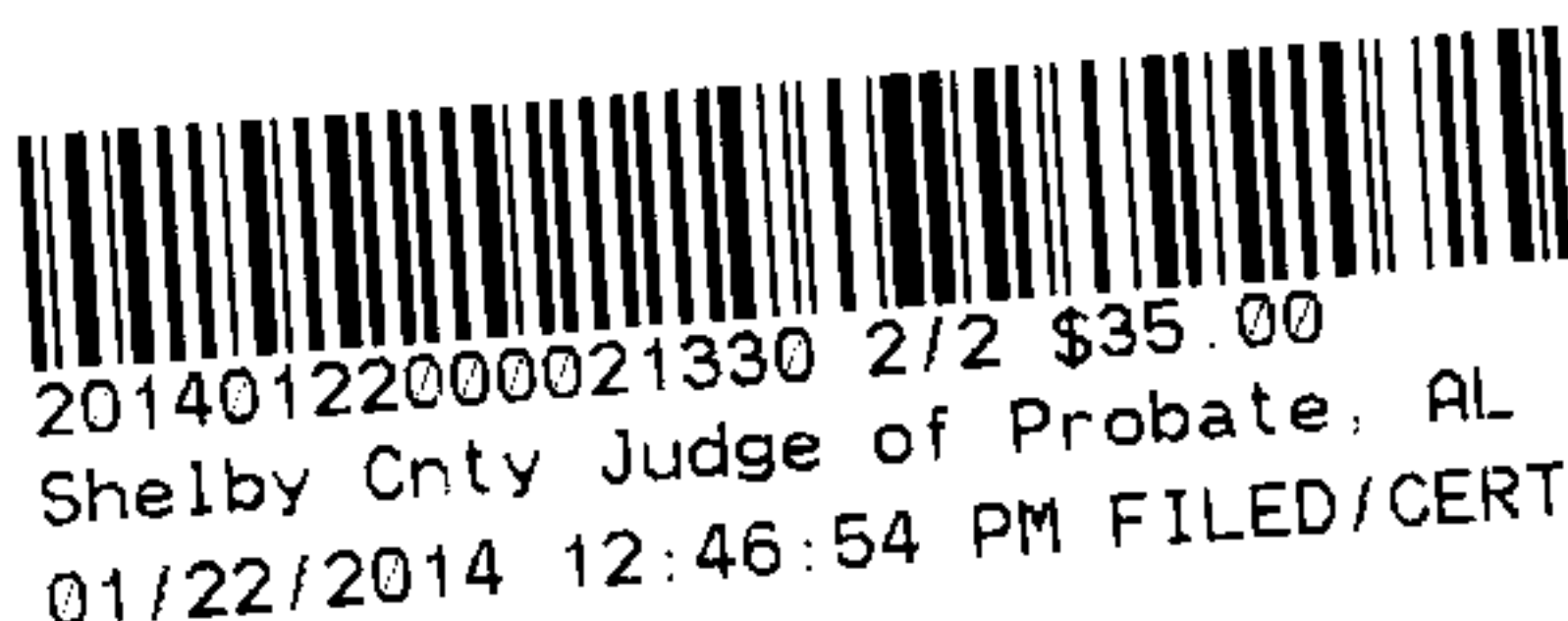
