Before me, the undersigned authority, on this day personally appeared Joseph R. McCullough, hereinafter referred to as "Affiant," who is personally known to me (or, if not being personally known to me, did confirm his/her identity presenting [REDACTED] as identification [i.e. drivers license]), and appearing to be fully competent and of sufficient age, upon being duly sworn, stated upon Affiant's oath the following:

1. My name is Joseph McCullough (Affiant), and I live at 218 Meadowlark Dr, Alabaster, AL 35007.

I am personally familiar with the family and marital history of Dean Edward Glenn (Decedent), and I have personal knowledge of the facts stated in this affidavit.

2. I knew Decedent from June 1991 until June 2011. I was personally well acquainted with the Decedent during his lifetime.

3. The Decedent died on June 4th, 2011 at the following place of death: Alabaster, Shelby, Alabama. At the time of Decedent's death, Decedent's residence was 219 Meadowlark Drive, Alabaster, AL 35007.

4. I was well acquainted with the family and near relatives of the Decedent, and with all those who would, under the laws of the State of Alabama, be his heirs. The following statements and the information contained herein are based upon my personal knowledge and are true and correct.

- 1) The Decedent did not leave a will.
- 2) To my knowledge there has not been an administrator or personal representative appointed for the estate of the deceased.
- 3) The Decedent left a debt of a home mortgage. I am not aware of the name of neither said mortgage company nor the amount of this debt.
- 4) In my opinion the estate of the Decedent will not be sufficient to pay debts left behind.
- 5) To my knowledge there are no Federal or State inheritance taxes to be paid.
- 6) The Decedent was not married at the time of death leaving no widow.

- 9) The Decedent had one grandchild born. Taylor Glenn born September 26 2002 to Thomas Glenn and Erica Brasher.
- 10) The Decedent has no other children or step children.
- 11) The Decedent owned real estate property at 219 Meadowlark Dr, Alabaster, AL 35007 in Shelby County.
- 12) My relationship with the Decedent was a family friend.
