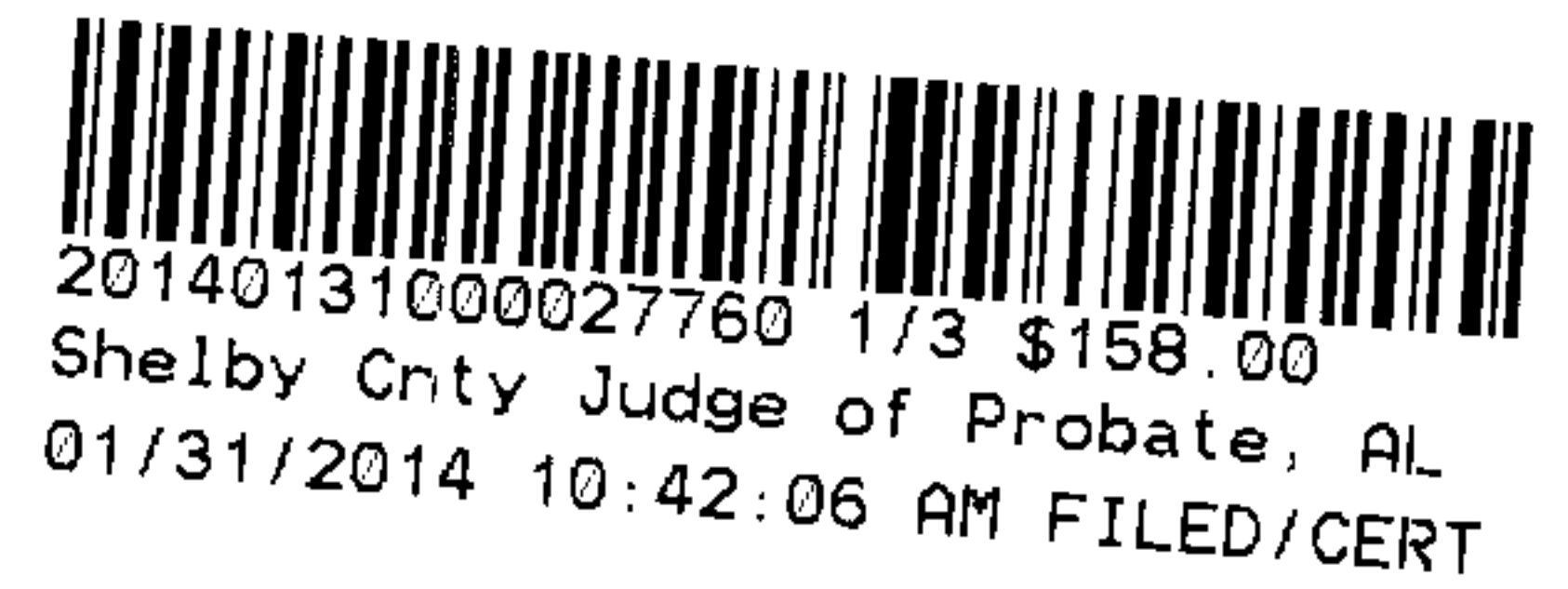


# ARTICLES OF ORGANIZATION

OF

## ENTRY POINT LLC



The undersigned, for the purpose of forming a limited liability company (the "Company") pursuant to the provisions of the Alabama Limited Liability Company Act (the "Act") (Alabama Code §10-12-1, et seq.) hereby certify as follows:

1. NAME OF COMPANY. The name of the Company is:

**"ENTRY POINT LLC"**

2. PERIOD OF DURATION. The period of duration of the Company shall be perpetual.

3. COMPANY PURPOSES. The Company has been organized for the purpose of providing research, development, manufacture and sale of Military and Law Enforcement products. The Company may also transact any other lawful business for which a limited liability company may be formed under the Act, but nothing contained herein shall be construed as authorizing the Company to carry on the business of banking or insurance or to act as a trust company. Furthermore, nothing contained herein shall be construed as authorizing the Company to act as a securities broker, a securities dealer or as an investment advisor.

4. INITIAL REGISTERED OFFICE AND INITIAL REGISTERED AGENT. The location and mailing address of the initial registered office of the Company is: 237 Stillmeadow Circle, Columbiana, Alabama 35051. The name of the Company's initial registered agent at such address is James Allen Morrison.

6. ADDITIONAL MEMBERS. Any new members shall be admitted to the Company only upon the written consent of the Members.




