less the Deferred Principal Balance shall be referred to as the "Interest Bearing Principal Balance," and this amount is \$374,299.70.

The Interest Bearing Principal Balance will re-amortize over 480 months.

Interest will begin to accrue as of **NOVEMBER 01, 2013**. The first new monthly payment on the New Principal Balance will be due on **DECEMBER 01, 2013**, and monthly on the same date thereafter.



- D. To comply, except to the extent that they are modified by this Agreement, or by the U.S. Bankruptcy Code, with all covenants, agreements, and requirements of the Loan Documents including my agreement to make all payments of taxes, insurance premiums, assessments, impounds, and all other payments, the amount of which may change periodically over the term of my Loan. This Agreement does not waive future escrow requirements. If the Loan includes collection for tax and insurance premiums, this collection will continue for the life of the Loan.






