

ARTICLES OF ORGANIZATION
of

Pursuant to the provisions of Section 10-12-1, *et seq.* of the Code of Alabama (1975), the undersigned hereby adopts the following Limited Liability Company Articles of Organization.

ARTICLE I

Name

The name of the Limited Liability Company is **RS9 Security Consultants LLC**.

ARTICLE II

Duration

The Company shall have duration from the date of organization, which is perpetual, unless it is dissolved and its affairs wound up prior to that date in accordance with the Alabama Limited Liability Company Act (the "Act") or the Company's Operating Agreement.

Cessation of Membership

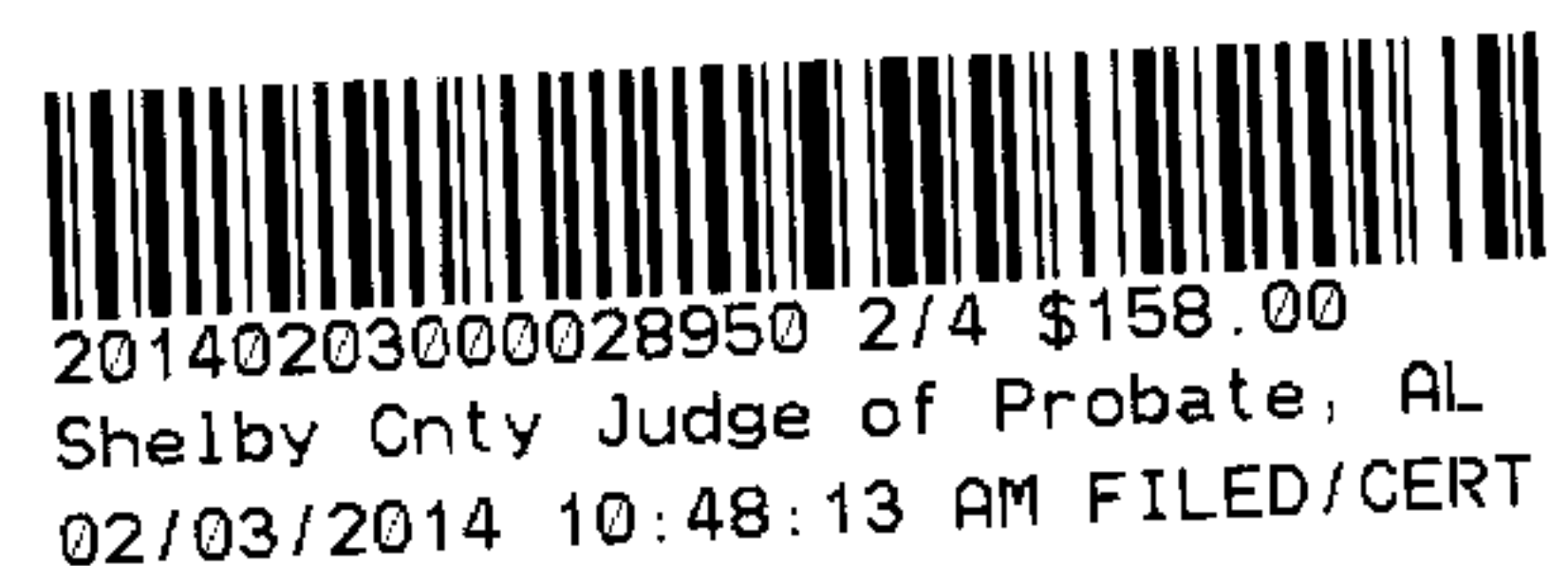

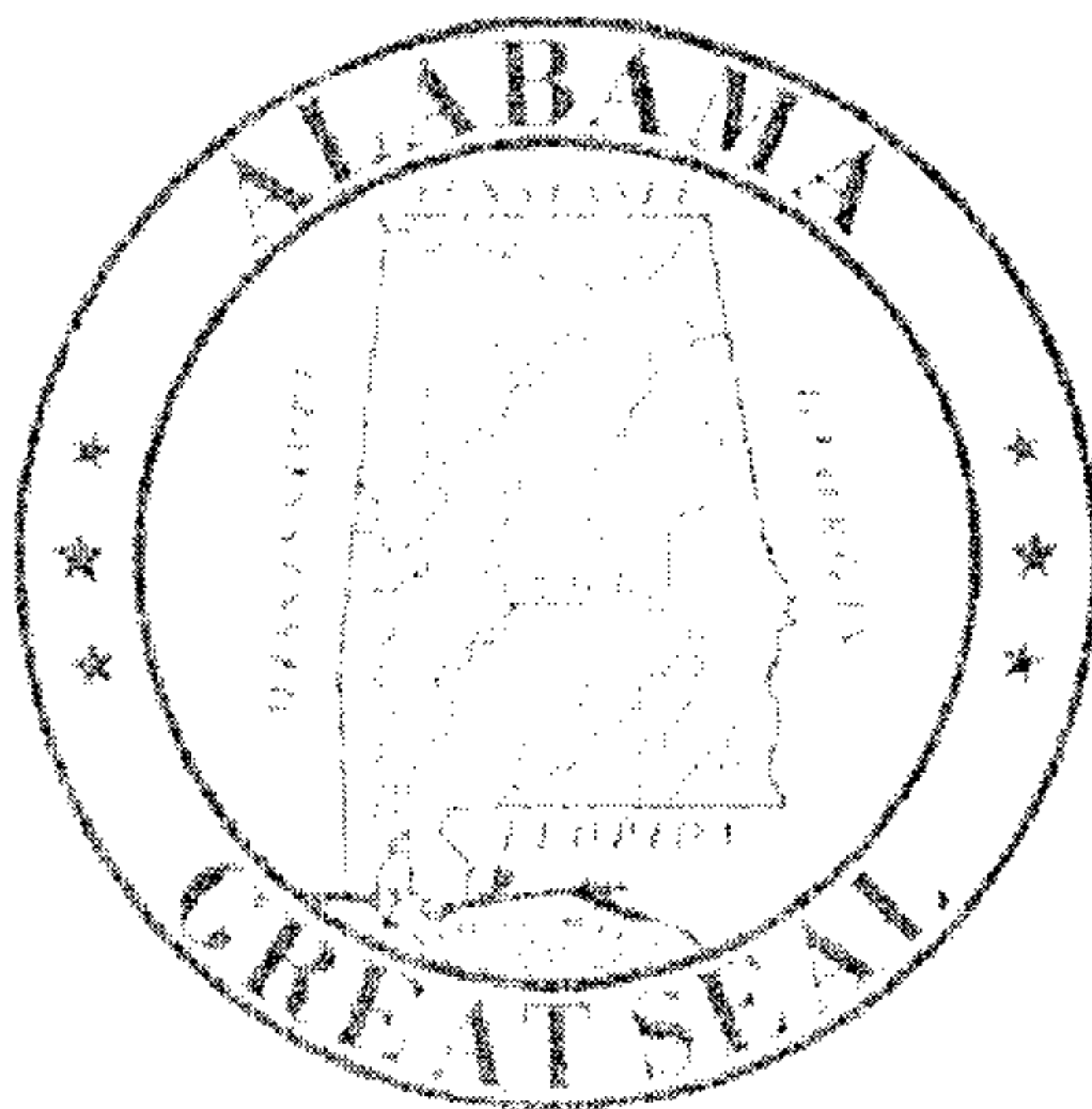
