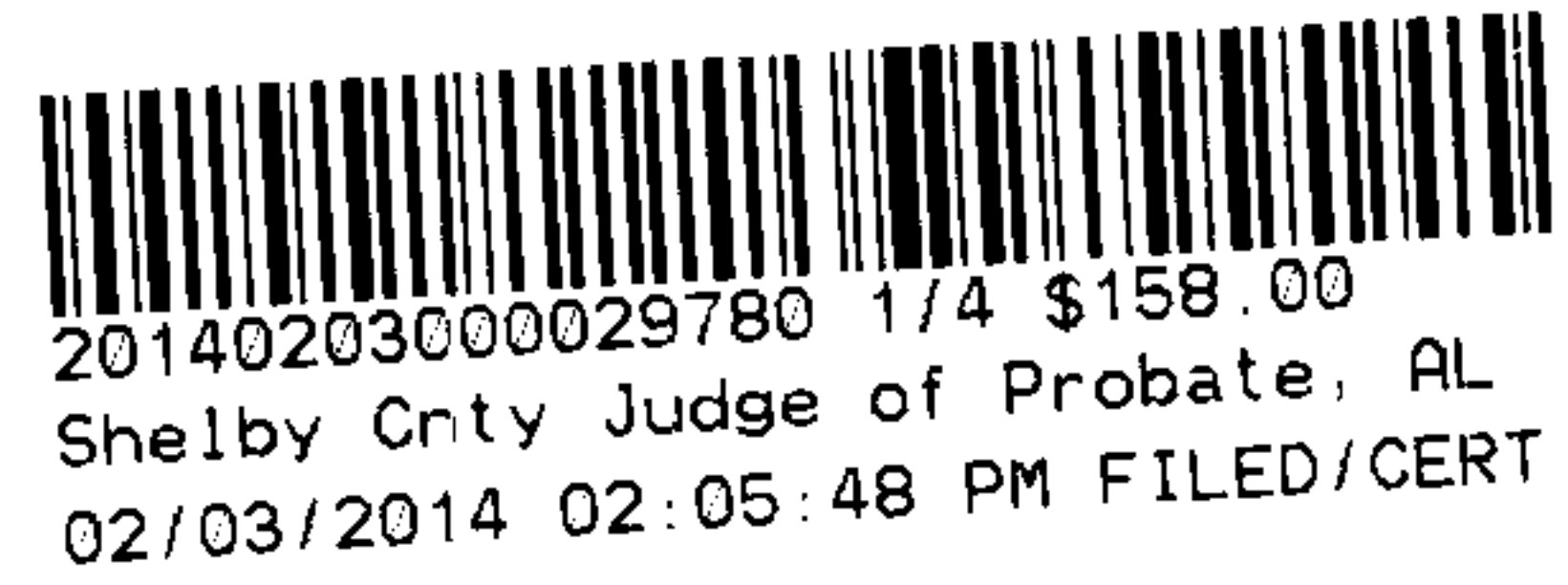

CERTIFICATE OF FORMATION


ARTICLE VIII

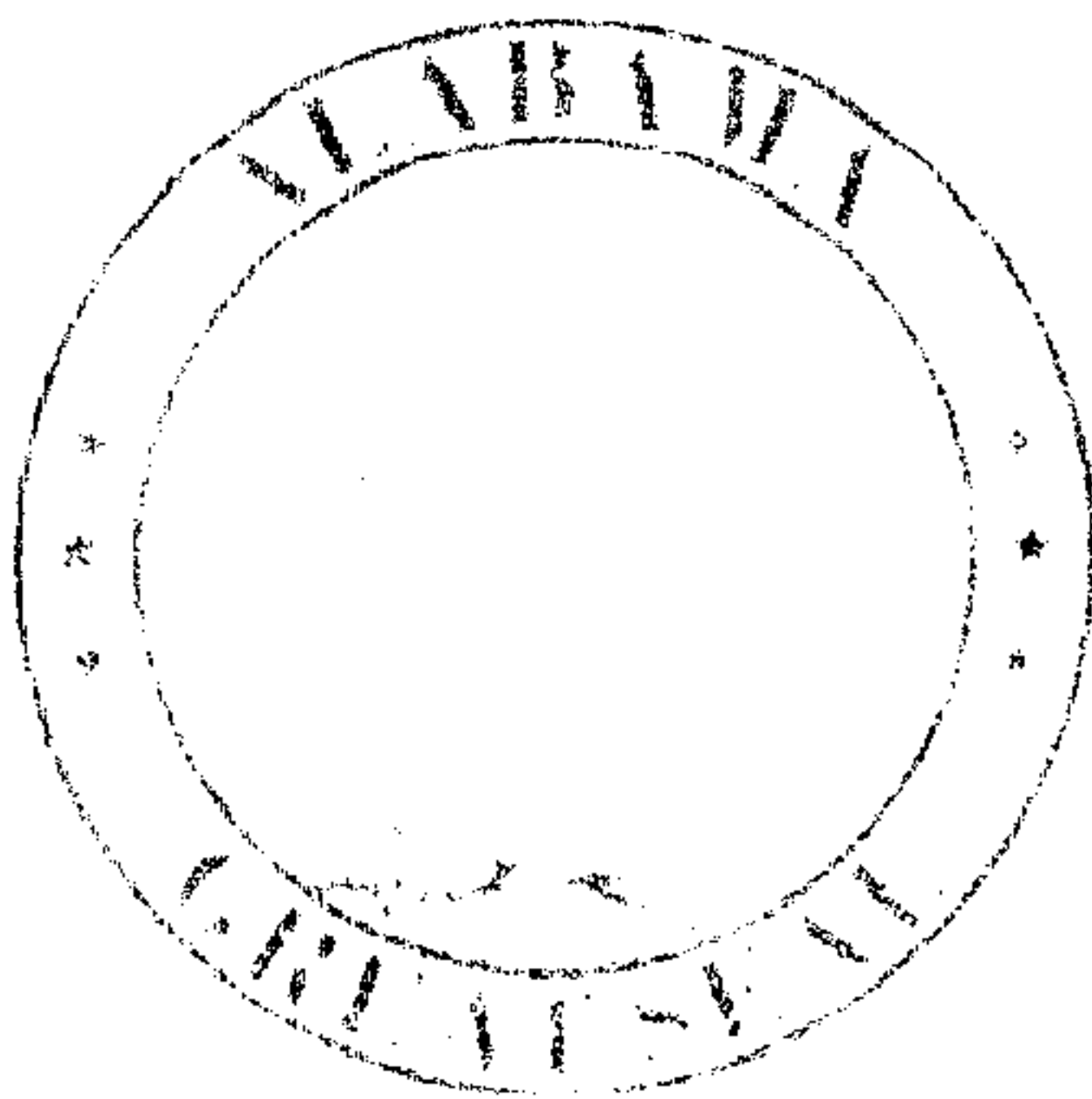


