KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 26th day of March, 2008, Timothy D. Love, unmarried, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., solely as nominee for GMAC Mortgage, LLC dba ditech, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20080422000163750, said mortgage having subsequently been transferred and assigned to Green Tree Servicing, LLC, by instrument recorded in Instrument Number 20130503000180740, in the aforesaid Probate Office ("Transferee"); and

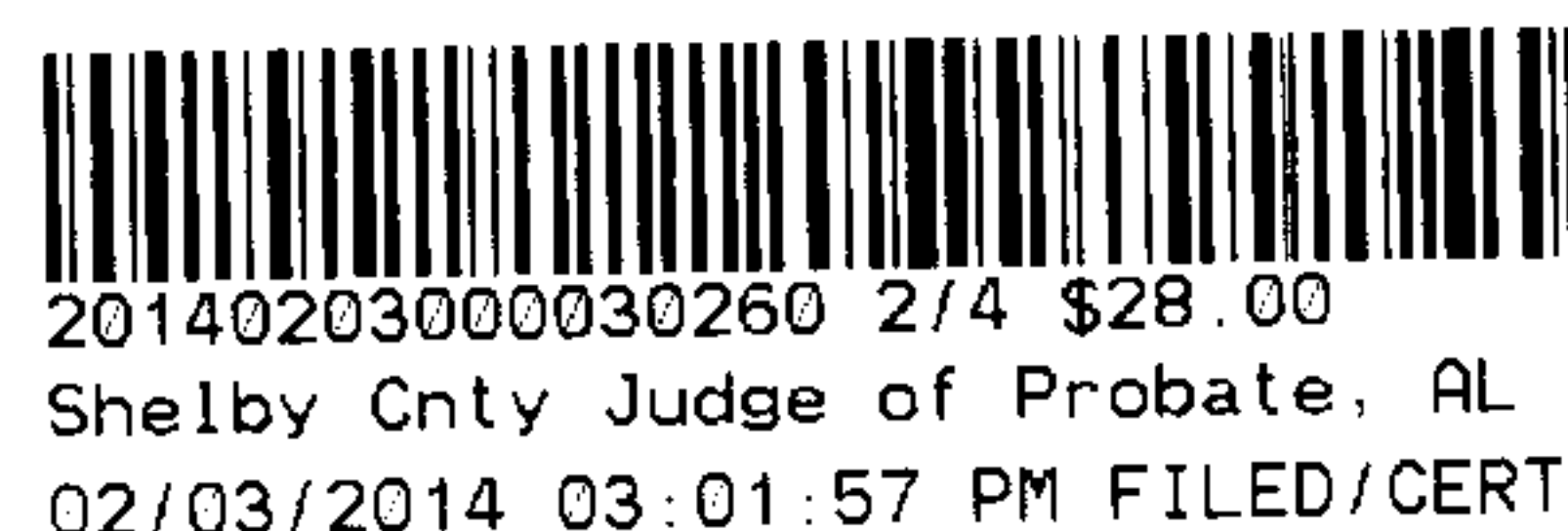

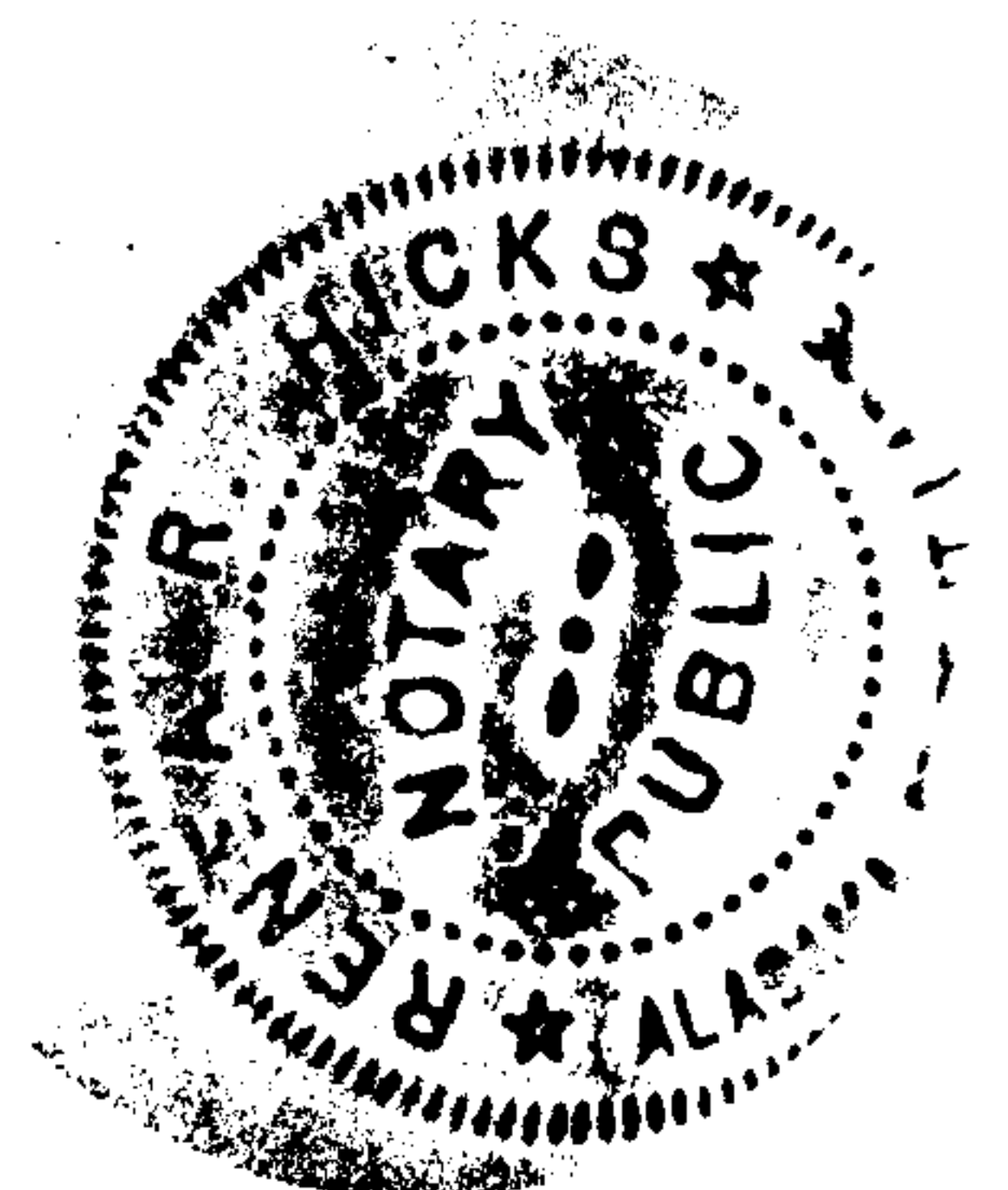

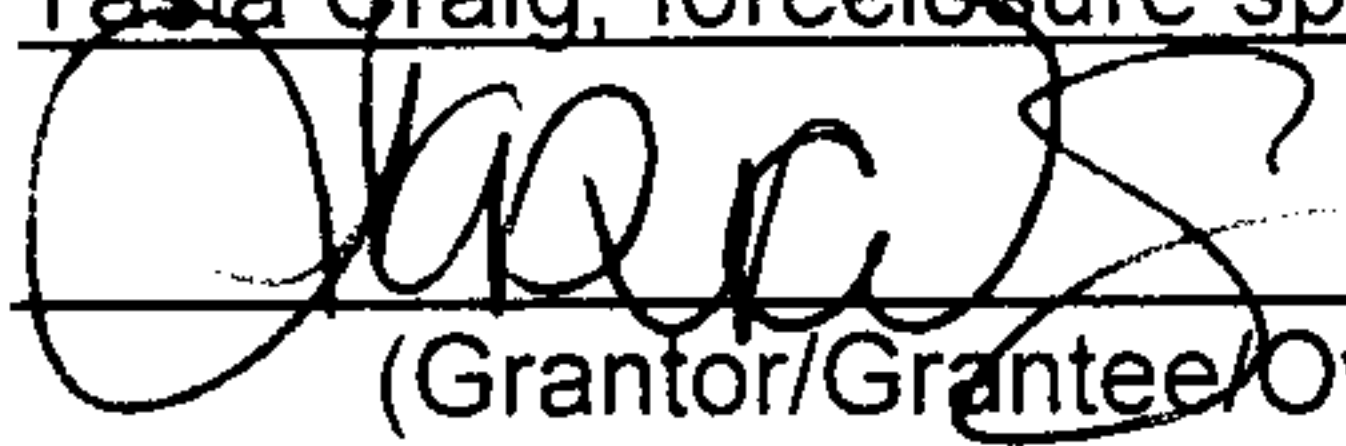
