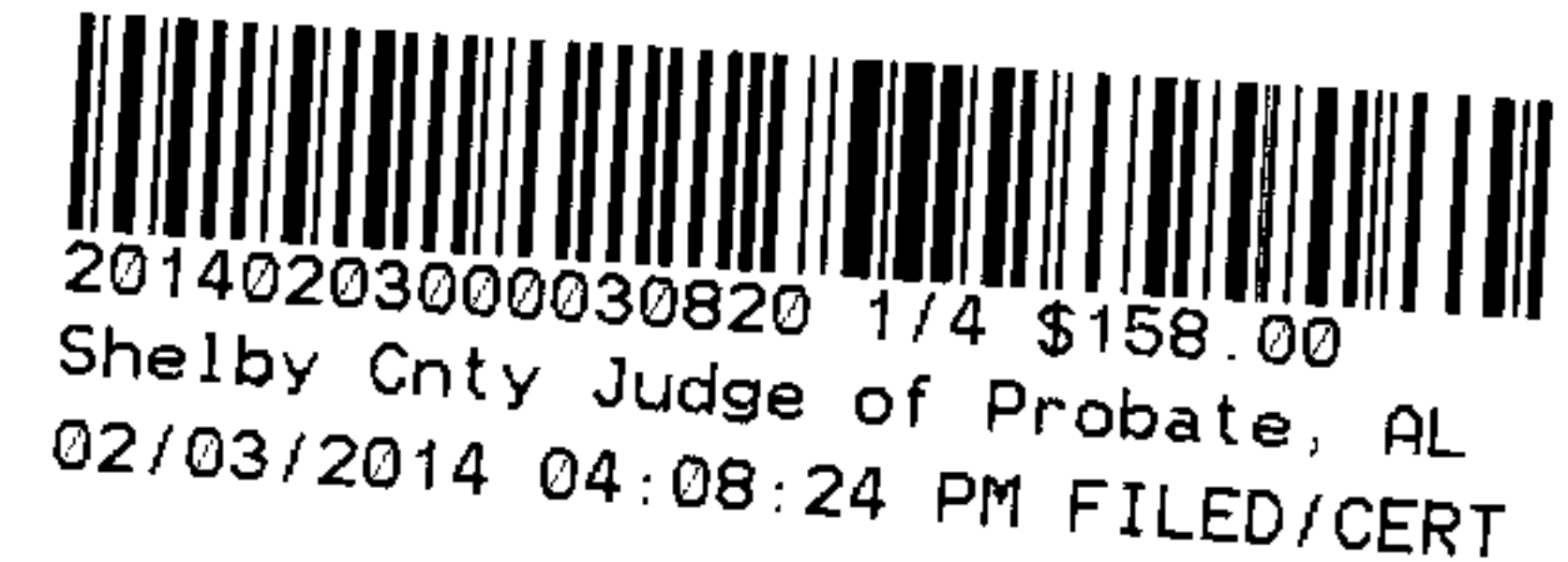


ARTICLES OF ORGANIZATION
OF

ARTICLE I

Name

Continuation of Business

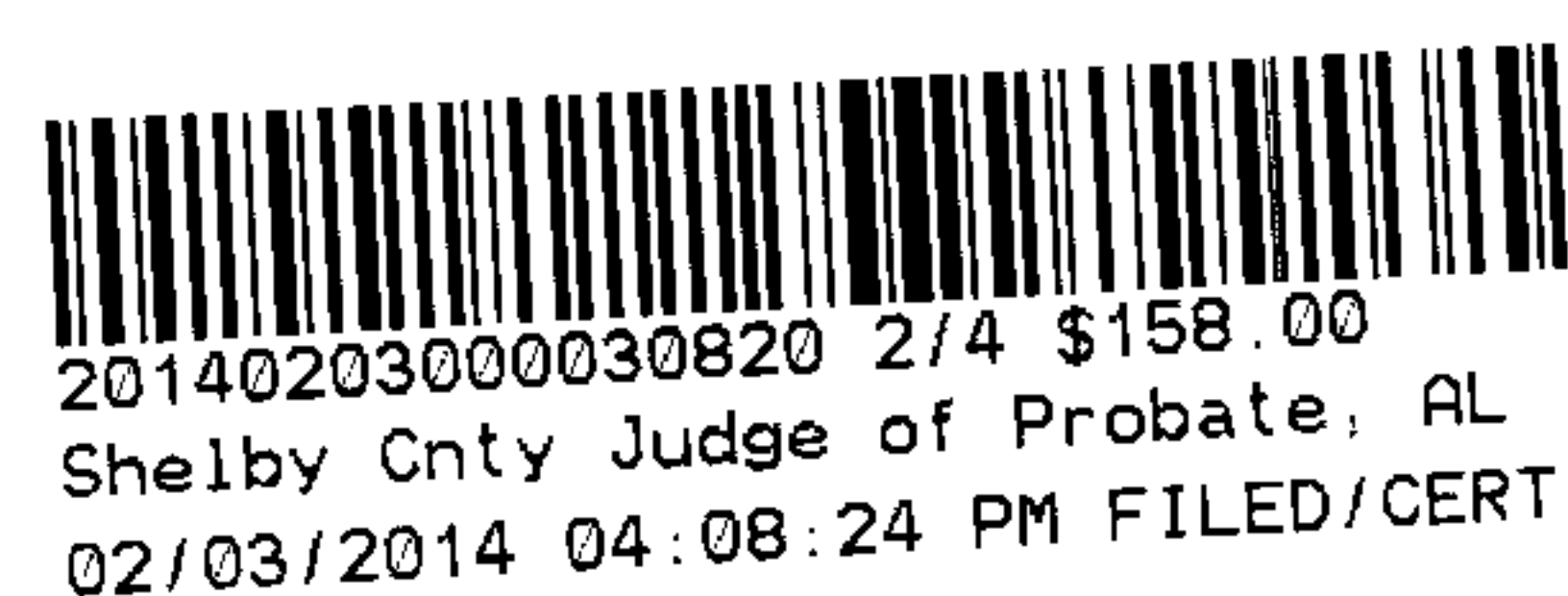
The cessation of membership of one (1) or more of the Members will not result in the dissolution of the Company.

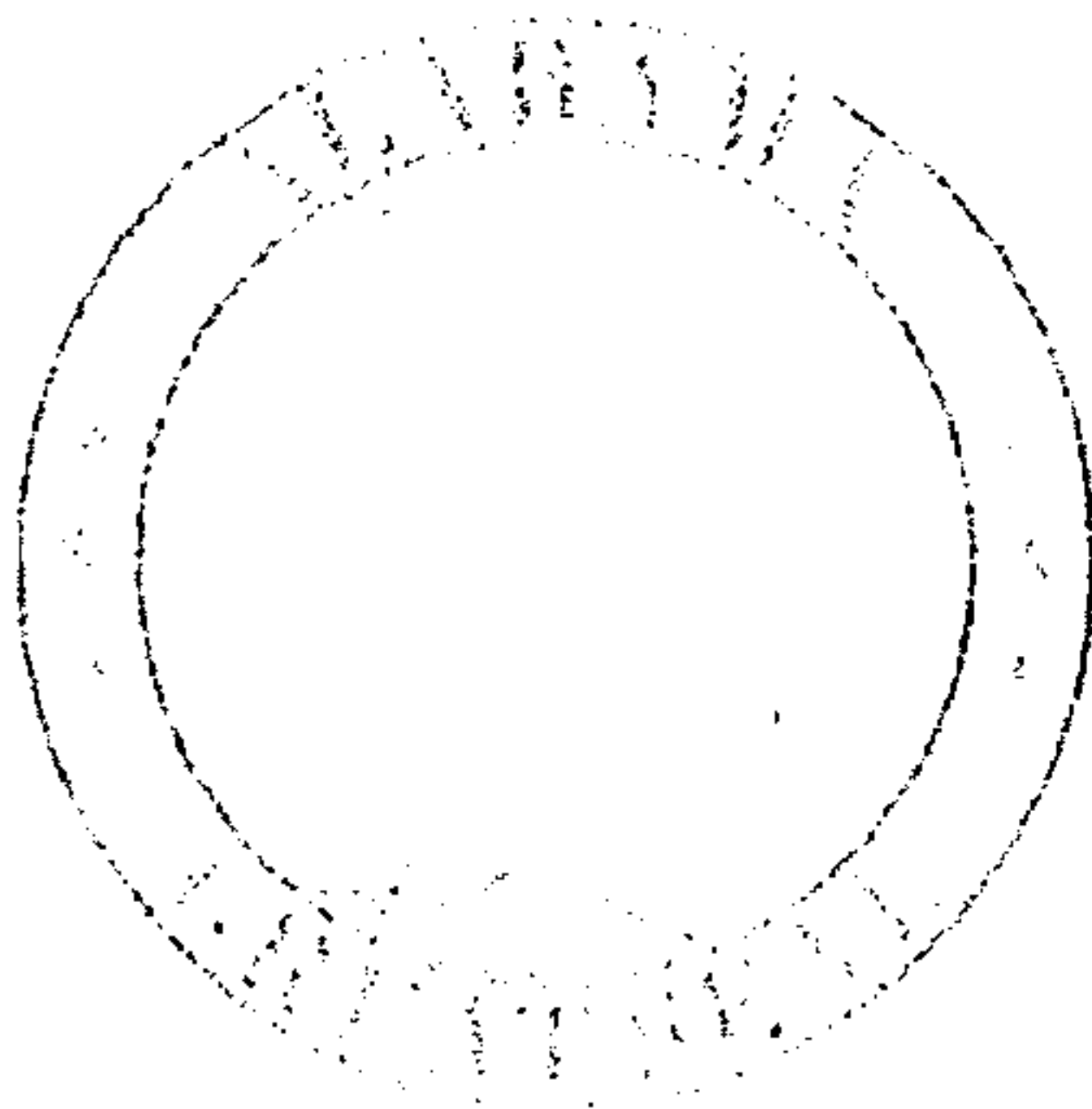
